



Preface

Welcome to use our product, double mic Bluetooth karaoke sets, it uses the original design, to move the full set of KTV karaoke system to ordinary families by low cost, simple way. It has double mic so that 2 singer could sing song in the meanwhile. It's adjustable for mic vol and echo effects in RX box. Background music is essential when you sing in .KTV, and original sound could be turned on or off. All of these functions are available in this product by Bluetooth technology and free APP software installed in smart phone or tablet.

A. Product description



1.ON/OFF: Power switch

2.Mic ECHO: Echo adjustment knob

3.MIC-A: A Mic led

4.MIC-B: B Mic led

5.MIC VOL: Mic vol adjustment knob

6.ANT-A: A Mic antenna

7.VOL-OUT: audio output vol adjustment knob

8.MIX-OUT: audio output 9.DC 5V: Power input

10. ANT-B: B Mic antenna

Wireless mic uses UHF band technology to realize high anti-jamming, remote wireless transmission. Application area: family entertainment, stage performances, meetings and etc. Special reminder: It's necessary to customize if you would use 2 or above products in the same effective working area, otherwise, it will occur the same frequency interference problem.



B. How to use

- 1. Turn on the handhold microphone and K380 RX box, and connect the "receiving box" to the speakers or audio amplifiers by D3.5mm audio cable;
- 2.Connect smart phone or tablet to WiFi, download and install the K song app software, we recommend "iSing", then download your favorite video song files,
- 3.Turn on Bluetooth function on your phone or tablet, searching for "K380" device and connect it: 4.Run karaoke APP that just installed in your smart phone or tablet, and choose
- your favorite songs, background music can be transmitted to the speakers by Bluetooth,, APP software can also turn on or off the original sound when you
- 5. Turn on handhold microphone and you can enjoy singing.

D. Notes

1. Please put the product in a dry ventilated place if it is rained and moisture, 2. Please put the slip ring on the microphone as to avoid falling damage.

E. Trouble shooting

- 1. The microphone has no sound: check whether the power switch is turned on on microphone and receiver box, and whether microphone is in mute state; APP software can also turn on or off the original singing voice when you sing song. Microphone howled: check the microphone and audio is leaning too close, microphone is pointed to speakers, volume is adjusted too loud;
 - B.Background music could not transmit to speakers: check Bluetooth has been connected between receiving box and smart phone or tablet, individual smart devices is not compatible with APP software, so far, we found "Teana K song" and apple I-phone or i-pad are not compatible, it's compatible problem between them, our products is in good conditions.
