To answer a phone call:  
Click to answer a phone call.  
To reject a phone call:  
Press for 3 Seconds to reject the call.  
To play the music:  
Click for play and pause the music.

Volume Up: Long press “+”  
Volume Down: Long press “-”  
Previous Track: Click “←”  
Next Track: Click “→”

#### Charge the batteries:

- 1.Plugs the Micro-USB charging cable into the headset.
- 2.Plug the USB port on a computer or power adapter.
- 3.Charge for 1 to 3 hours or until the Battery status red light turns off.
