


RADIATED EMISSION TEST SETUP BELOW 1GHz



RADIATED EMISSION TEST SETUP ABOVE 1GHz






VIEW OF BATTERY






INTERNAL VIEW OF EUT-2







VIEW OF EUT(PORT)







VIEW OF BATTERY


