



<WLAN Tx Mode>




<WLAN RJ-45 Cable Mode>

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.



 Compare this with the RBW setting of the analyzer. Readjust RBW and repeat measurement as needed until the RBW/EBW ratio is approximately 1%.
- 7. For 99% Bandwidth Measurement, the spectrum analyzer's resolution bandwidth (RBW) is set 1MHz and set the Video bandwidth (VBW) ≥ 3 * RBW.
- 8. Measure and record the results in the test report.





3.2 Maximum Conducted Output Power Measurement

3.2.1 Limit of Maximum Conducted Output Power

For the 5.25–5.725 GHz bands, the maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250 mW or 11 dBm 10 log B, where B is the 26 dB emission

bandwidth in megahertz.


The total final Power Spectral Density is from a device with 2 transmitter outputs. The spectrum measurements of the individual outputs are all performed with the same span and number of points, the spectrum value in the first spectral bin of output 1 is summed with that in the first spectral bin of output 2 to obtain the value for the first frequency bin of the summed spectrum.

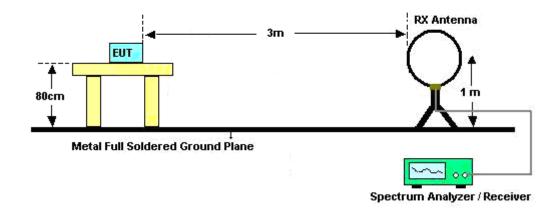



For radiated emissions from 30MHz to 1GHz


