#### 2.2 Test Mode

- a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (Z plane) were recorded in this report.
- b. AC power line Conducted Emission was tested under maximum output power.

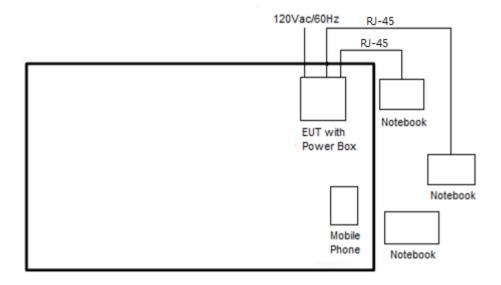

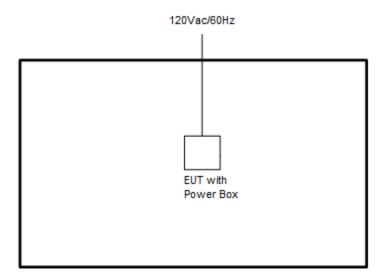

The RF test items, utility "CMD" was installed in Notebook which was programmed in order to make the EUT get into the engineering modes to provide channel selection, power level, data rate and the application type and for continuous transmitting signals.

### 2.6 Measurement Results Explanation Example

#### For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

#### Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10dB attenuator.

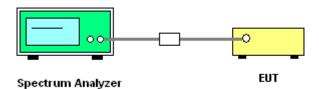

- 5. For 99% Bandwidth Measurement, the spectrum analyzer's resolution bandwidth (RBW) is set 30kHz and set the Video bandwidth (VBW) = 100kHz.

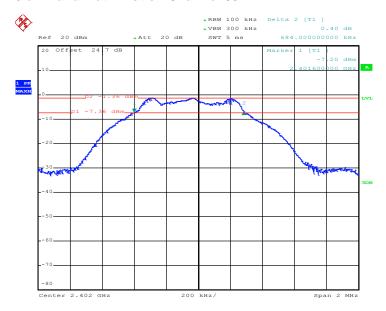

#### 6 dB Bandwidth Plot on Channel 00



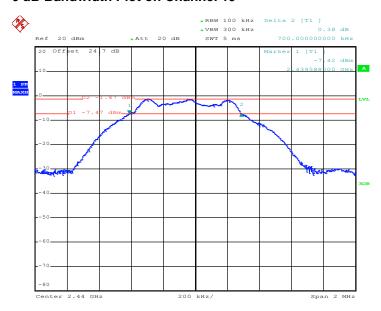

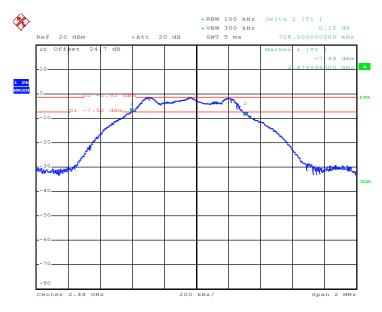

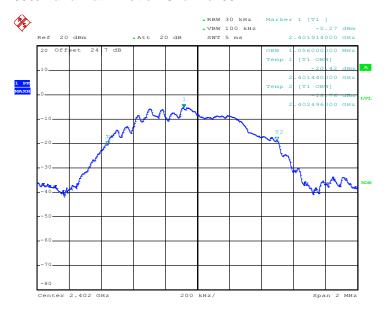

#### 99% Bandwidth Plot on Channel 00



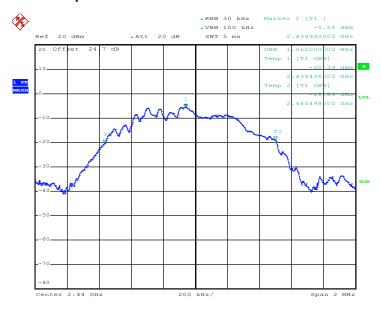

### 3.2 Output Power Measurement

#### 3.2.1 Limit of Output Power

For systems using digital modulation in the 2400-2483.5MHz, the limit for peak output power is 30dBm. If transmitting antenna of directional gain greater than 6dBi is used, the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.

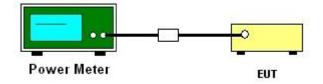

- 2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
- 3. Set to the maximum power setting and enable the EUT transmit continuously.
- 4. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 3 kHz. Video bandwidth VBW = 10 kHz In order to make an accurate measurement, set the span to 1.5 times DTS Channel Bandwidth. (6dB BW)
- 5. Detector = peak, Sweep time = auto couple, Trace mode = max hold, Allow trace to fully stabilize. Use the peak marker function to determine the maximum power level.
- 6. Measure and record the results in the test report.
- 7. The Measured power density (dBm)/ 100kHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.

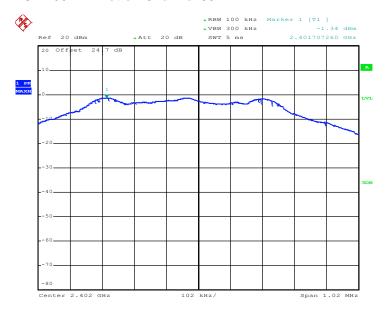

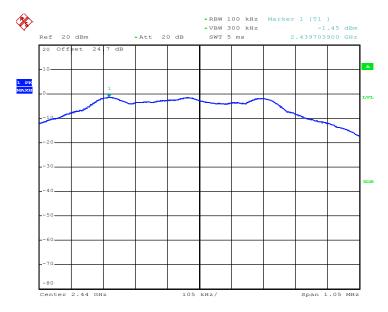

#### PSD 100kHz Plot on Channel 19



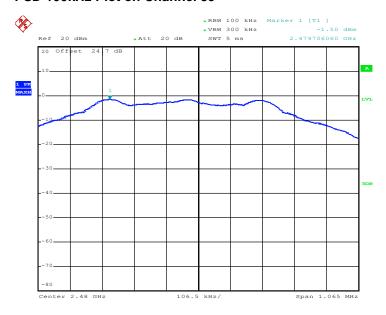

#### PSD 100kHz Plot on Channel 39



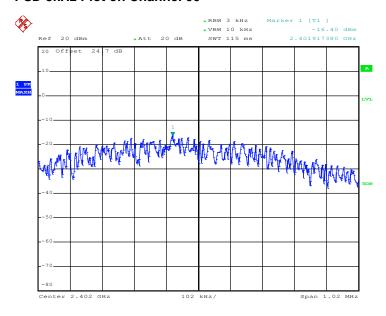

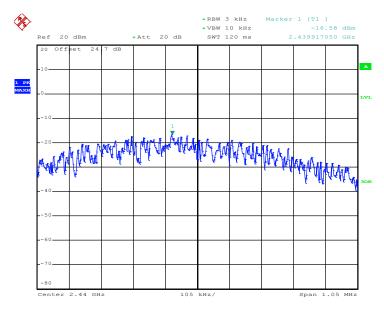

Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.
- 5. Measure and record the results in the test report.
- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.

## 3.5 Radiated Band Edges and Spurious Emission Measurement

In any 100 kHz bandwidth outside the intentional radiator frequency band, all harmonics/spurious must be at least 20 dB below the highest emission level within the authorized band. #### 3.5.3 Test Procedures

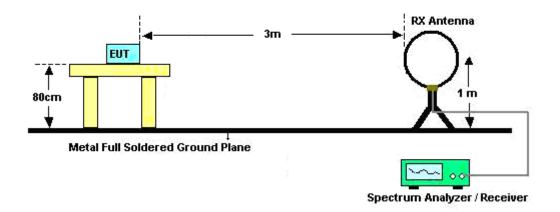
- 1. The testing follows FCC KDB Publication No. 558074 D01 DTS Meas. Guidance v04.
- 2. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level.
- The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
- 4. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
- 5. Corrected Reading: Antenna Factor + Cable Loss + Read Level Preamp Factor = Level

  - (3) Set RBW = 1 MHz, VBW= 3MHz for  $f \ge 1$  GHz for peak measurement. For average measurement:
    - VBW = 10 Hz, when duty cycle is no less than 98 percent.
    - VBW ≥ 1/T, when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation.

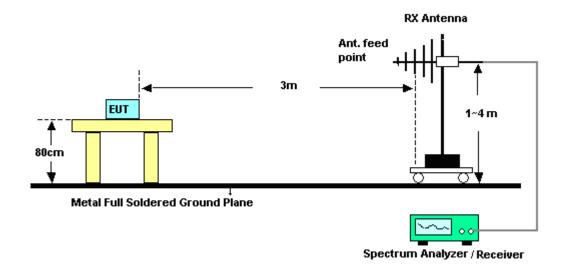

#### For radiated emissions from 30MHz to 1GHz

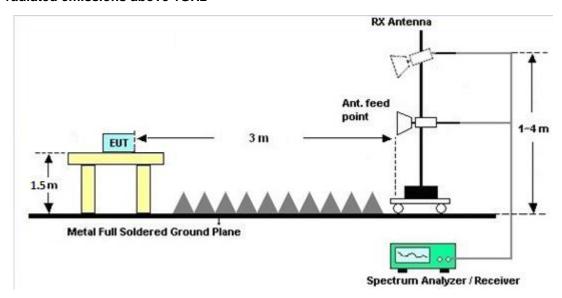

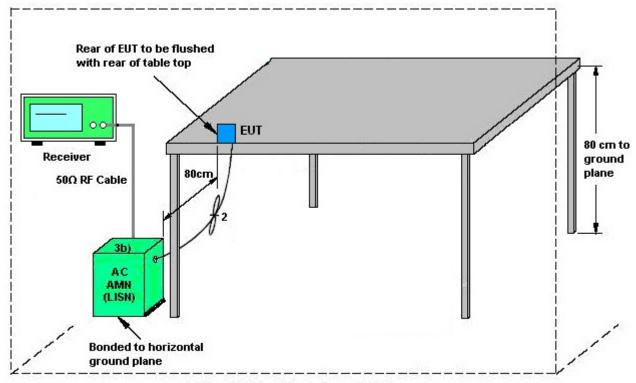

## 3.7 Antenna Requirements
