


Detailed Instructions and Diagrams



- Micro USB Input

Technical Specifications:

Preparing to Charge:

- The LED Lamp wireless charging pad can charge Qi enabled smartphones.
- You can charge your smartphone with a protective case on it.(Works with most cases up to 4mm thick.)
- If your protective case has metallic studs, magnetic clasps, or a magnetic plate, you should remove the case before placing your phone on the mount.
- Also ensure the protective case does not create distance between the charging pad and the back of the phone that is greater that 4mm.
- Connect the LED Lamp to power using the included USB power adapter.
- Place your Qi enabled mobile phone in the center of the charging pad.

USB Charging:

• Connect your device's existing USB cable to the USB out port to charge USB devices.

LED Light:

•The LED Lamp has 3 brightness levels. Press the power button to turn on/off and switch between brightness levels.

Troubleshooting:

- No power: Make sure the LED Lamp is connected to power. Plug the included USB power adapter into a AC power outlet and the micro USB input on the back of the LED Lamp.
- Device isn't charging (wireless): Make sure your smartphone is Qi enabled and is placed in the center of the charging area.
- Device isn't charging (USB): Make sure the USB cable is connected from the USB out port on the LED Lamp and connected to your device.

Precautions:

- Medical Implants: Please maintain a minimum of 20 cm safe distance between the LED Lamp (when powered ON) and any medical implants that can be affected by a magnetic field, such as pacemakers.
- Do not immerse in liquid.
- Do not place a magnet or any magnetically sensitive devices such as credit cards on the charging pad.
- Avoid placing metal or magnetic objects near the LED Lamp to prevent damage.
