QUICK START GUIDE

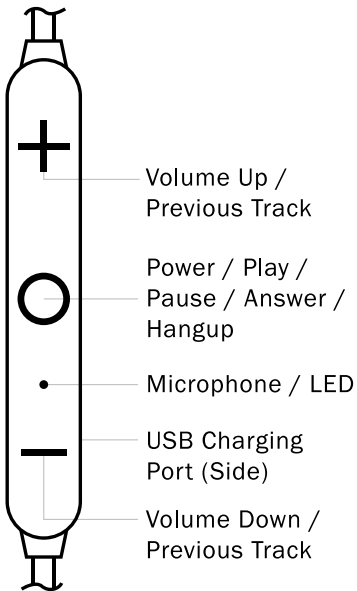
Thanks for purchasing LSTN's wireless Bolt earbuds! We know you're anxious to get started, so we'll keep this short. Want this information in video form? Go to [**lstnsound.co/gettingstarted**](https://lstnsound.co/gettingstarted)

- 1)** Hold the power (○) button down for ~5 seconds. The LED will flash red and blue, and you'll hear "Power On" when the power turns on.
- 2)** Open your device's Bluetooth preferences and select "LSTN-Bolt". A voice prompt will confirm the connection.
- 3)** That's it! You're now connected. To pair to a different device, simply turn off the headphones by holding the power button for 3 seconds, then restart this process at step 1 with your new device.

After completing the initial pairing process, your earbuds will reconnect to the last used device once turned on - you do not need to re-pair them each time. If no device is connected within 5 minutes of pairing, the earbuds will automatically turn off.

When using the Bolt, the controller should be on your right-hand side. A good way to remember this is to note that the point of the support wings should be facing forward in your ear.

OPERATION



Play / Pause: Quickly press the power (o) button

Adjust Volume: Tap the corresponding + or – button

Skip Forward: Press and hold the + button

Skip Backward: Press and hold the – button

Answer / End Call: Quickly press the power (o) button

Reject Call: Press the power (o) button for 2 seconds

Second Call: Quickly press the power (o) button to hang up your current call and answer the second. Press and hold the power (o) button for 2 seconds to reject the incoming call.

MY EARBUDS WON'T TURN ON

Check to ensure that your earbuds are charged. Plug the provided USB cable into a USB power supply. The LED indicator will turn red, and the headphones will begin charging. The LED will change to blue once your earbuds are fully charged (apx. 1 hour).

MY EARBUDS WON'T CONNECT / PAIR

Sometimes, connection errors happen. Try turning your device's Bluetooth connection off for a few seconds, and then try pairing again. If that doesn't work, turn off both your device's Bluetooth and the headphones for ~10 seconds, then start again.

MY CONNECTION IS SPOTTY / INTERMITTENT

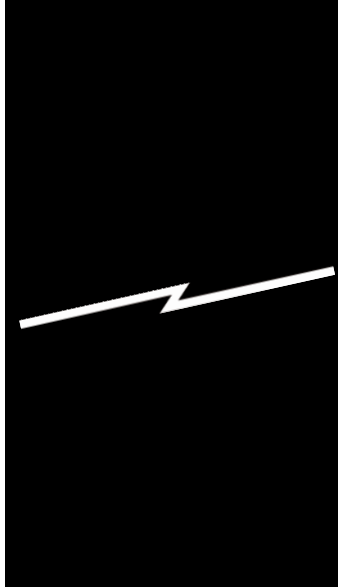
The Bolt's connection range is approximately 120 feet (40 m). Check the make sure you're in this range. They also work best with a direct line-of-sight connection, so make sure nothing is obstructing the path between your Bolt and your device.

WARRANTY

If our product has a defect in materials or workmanship, you can return it for a full refund within one year of purchase. LSTN, at its option and to the extent permitted by law will (1) exchange the product with a functionally equivalent product that is new or equivalent to new in performance and reliability, or (2) refund the original purchase price.
