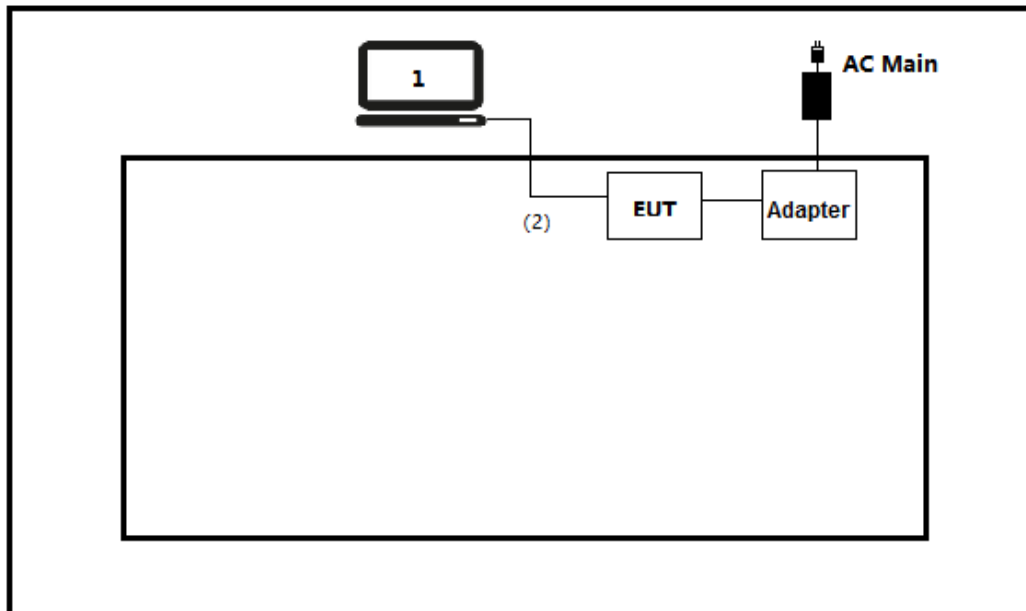

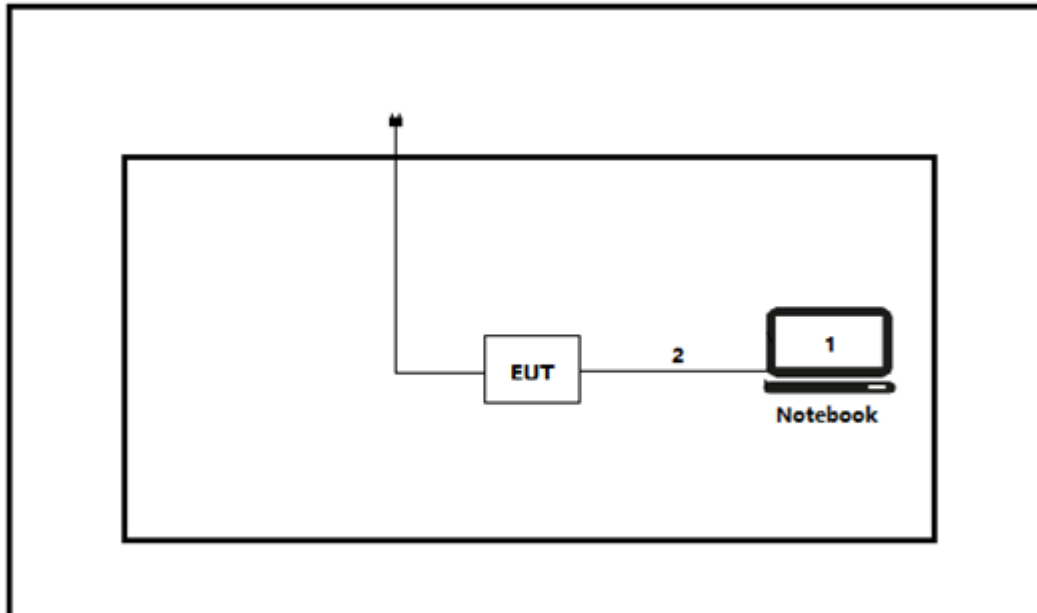

Test setup Diagram- AC Line Conducted Emission Test

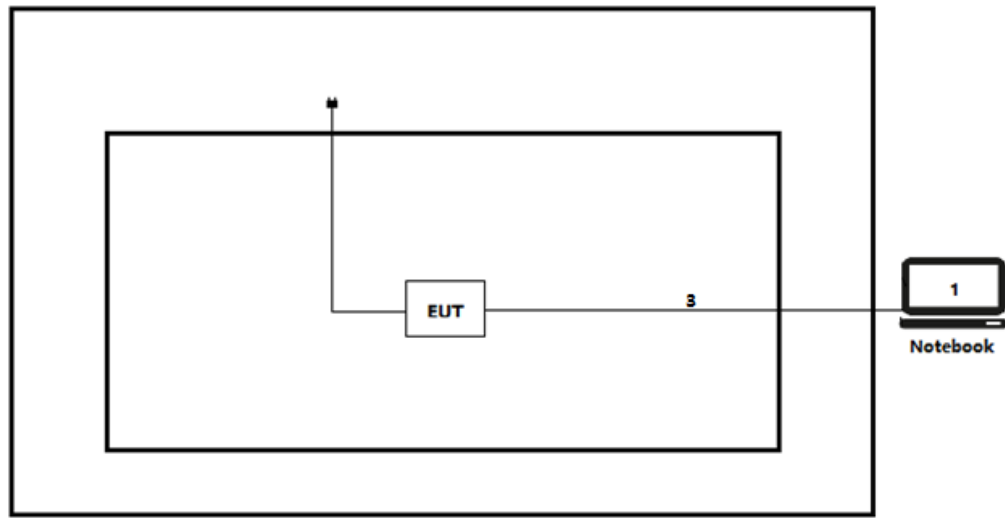


Test setup Diagram- Conducted test

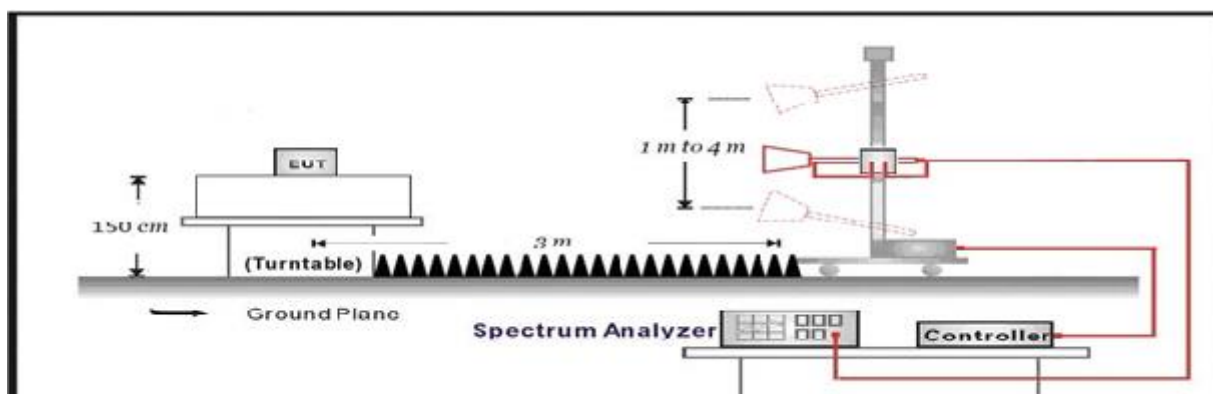
