- Preparation: Take out square magnet and oval magnetic bracket, download ‘Fitkid’ APP.
- First starting up: Press the square magnet for once, green light is on, that is, complete manual starting up for the first time.
- Auto start-stop: After the completion of manual starting up for the first time, the machine enters into auto on and auto sleep mode without manual starting up and shutdown again.
- Step 1: Wear on the 1cm below the collarbone (if adults, about 2 cm), square magnet is adhered outside clothes, and oval magnetic bracket is next to the skin inward and absorbed to surface of clothes.
- Step 2: Open the APP, match hardware according to system prompt until successful connection.
- Wearing clothes matched is suggested to be little flexible underclothes, then monitoring effectiveness will be the best.
- Adsorbed to loose clothing, not being absorbed to human body, not

being adsorbed to the correct position and not getting correct posture are likely to affect monitoring accuracy.

- In the APP-settings, complete personal settings and equipment settings.
- In the APP-settings, set class schedule, that is, children's work and rest time. According to your setting, it is automatically monitoring posture mode by default during class time, and will automatically switch to step calculation mode at other time.
- In the APP-settings, set remind cycle, namely, it will remind the wearer to adjust posture at regular intervals by means of vibration.
- Ensure that the above steps have been completed.
- Maintain ideal posture.
- Continuously press the square magnet for 2 times, then completing sitting posture calibration.
- If needing to adjust posture accordingly because of scene changes, then sitting posture calibration should be carried out again.
- In the APP-settings, can query battery remaining capacity.
- If needing to charge, please charge by putting the oval magnetic bracket on charging bracket, contact direction is as shown in the picture.
- When charging, red light is on, charging is completed, and then green

light is on.
