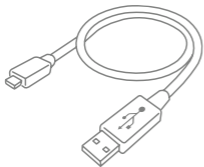

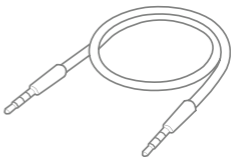

Safety Information

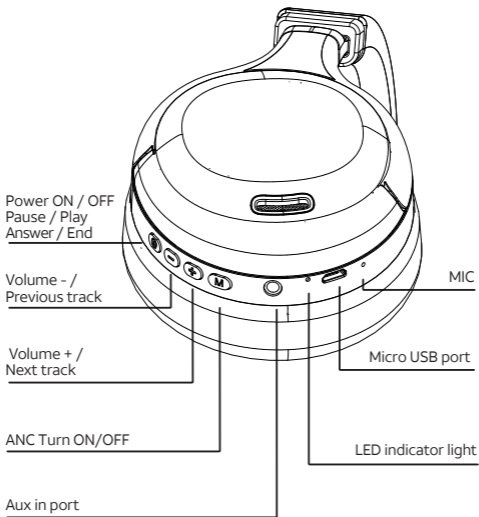
Important Safety Instructions

Please read all safety and operating instructions carefully before installation and use, and keep these instructions handy for future reference. Take special note of all warnings listed in this user's manual and on the ANC200.

1. **Attachments** - Do not use attachments not recommended by the manufacturer.
2. **Water and Moisture** - The unit should not be used near water. For example: near a bathtub, washbowl, kitchen sink, laundry tub, swimming pool or in a wet basement.
3. **Objects and Liquid Entry** - Care should be taken so that external objects do not fall into and liquids are not spilled onto any openings or vents located on the product.
4. **Power Source** - The unit should be connected only to a power supply of the type described in the operating instructions or as marked on the unit. If you are not sure, please consult the dealer or local power company.
5. **Heat** - The unit should be situated away from heat sources such as radiators, heat registers, stoves or other appliances (including amplifiers) that produce heat.

Operational Instructions

Charging

Charge your ANC200 through any USB jack or wall charger. The LED indicator will glow red when charging. Before using for the first time, charge at least 4 hours. After the first charge, the headset will charge in 2 to 3 hours and the LED indicator will turn off when the charge is complete.

Power ON/OFF

Press and hold the ON/OFF button for 2-3 seconds to switch the headset on. The LED will flash blue when powered on. Press and hold the ON/OFF button for 3 seconds to switch the headset off. When powering off, the LED will flash blue and then turn off indicating the headset is off.

Pairing

While the headset is off, press and hold the ON/OFF – for 2-3 seconds to start pairing mode. Once the headset is in the pairing mode (the LED will flash red and blue), select ‘ANC200’ among discovered Bluetooth devices on the phone to Pair.

Note: If the headset is not paired with a Bluetooth device in 5 minutes, it will turn itself off.

Making Phone Calls


Making a call

Once paired, use your mobile device to dial a number as usual. Once connected, the call will be heard on your ANC200 headset.

Answer a call

When receiving a call, press the “” button to answer the call.

Ending a call

While talking on the phone, press the “” button to end the call.

LED Indicator Chart

Status	Indicator
Powering ON	Blue and red lights flashing rapidly
Powering OFF	LED turns off
ANC function turn ON	Solid green light
ANC function turn OFF	The green light turn off
Low battery	Blinking red & headset emits a beep
Charging	Solid red light
Pairing mode	Blue and red lights flashing rapidly
Connection complete	Blue light blinks every 3 seconds
Playing music	Blinking blue light

Operational Instructions

Listening to Music

Play/Pause

Press the “⏮” button to launch the phone’s music player and to start listening to music. While listening to music, press the “⏮” button to pause or to resume play.

Song selection

While music is playing, press the |+| or |-| buttons to skip or go to previous songs.

Answer a call while listening to music

When receiving a call, press the “M” button to answer the call. Press the “M” button while on the phone to end the call. When receiving a call, press and hold the “M” button to reject the call. (Music will resume playing when the call is rejected.)

Volume control

Press and hold Volume adjust the volume level |+| and Volume |-| buttons to

Use the ANC function

Press the “M” button once , ANC function turn on .The LED Indicator will solid green light Press “M” button again to turn off the ANC function and green light is turn off.

Troubleshooting

Symptom	Solution
Music is not streaming over Bluetooth®	Check to make sure both devices are paired and connected over Bluetooth. Restart the headphone to auto-connect with your Bluetooth device.
No power	Make sure the ANC200 is fully charged.
Headphone does not answer phone calls	Check to make sure both devices are paired and connected over Bluetooth. Restart the ANC200 to auto-connect with your Bluetooth device.
Music does not resume after ending a call	Press play to resume music.
