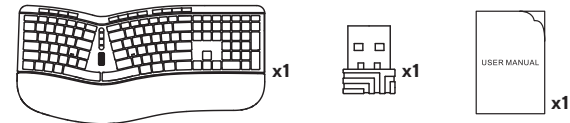

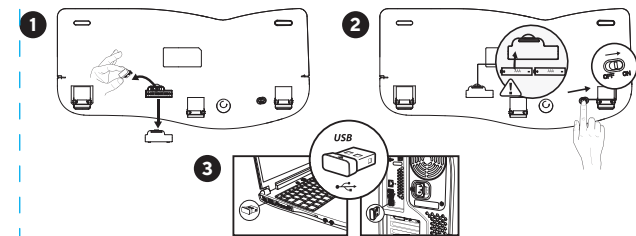

Instructions



- Step 1:** Take out the USB receiver from the keyboard's battery compartment.
- Step 2:** Place 2xAAA dry batteries into keyboard with correct polarity direction. Then turn on the keyboard.
- Step 3:** Plug USB receiver into computer's USB port.
- Step 4:** Wait for computer to install the drive automatically, and you can use the keyboard after that.

1. Designed with scroll wheel, left/right buttons and trackball, it can be used as a mouse to navigate the web pages and control the cursor.
2. With ergonomic wrist rest and separate button layout, it can make your hands put in a more comfortable position and help to relieve hand fatigue of long-time using.

2. The keyboard is only workable with AAA alkaline dry batteries. If you're not going to use the product for a long time, please take out the batteries to prevent it from corroding the product.

Solutions for Connecting Problems

1. Turn off the keyboard and turn it on again.
2. Short press CONNECT key and plug the USB receiver into computer.
3. Keep the distance between keyboard and USB receiver within 30cm, and the indicator light of code pairing will flash for 3 seconds and go out. The keyboard will work normally after that.

Note: If the product is still unworkable after above solutions, please repeat these steps for code pairing again. If your problems can't get solved yet after that, please contact our customer service for help. (Email: csforcustomer@gmail.com).
