Subject: Explanation for internal FCC ID Labeling for Wireless Vehicle Sensor FCC ID:  
2AGMZGC433WW1

External labeling is not desirable for the following reasons:

1. The cover is removable and can be lost or misplaced, therefore placing the label on the cover is not desirable.
2. The other external location would be on the bottom side of the plastic housing. Since the unit will be permanently mounted about 10-12" above the ground, this location is not easily viewable by the user.
3. The unit will be permanently mounted outdoor subject to environmental damaged. It is desirable to minimize the label exposure environmental damages.

Internal labeling as indicated in the attached photo would allow easily accessible and viewable by the user since he/she would have to access the control board during setting. It's also prevents the label from being lost/discard from the transmitter and/or damaged.

The FCC has provided in KDB 784784 D01, Section 3, that instead of placing the labels onto the device externally, Ghost Controls may elect to place the FCC ID inside of the removable housing of the device, as well as put the FCC ID in the printed user manual.

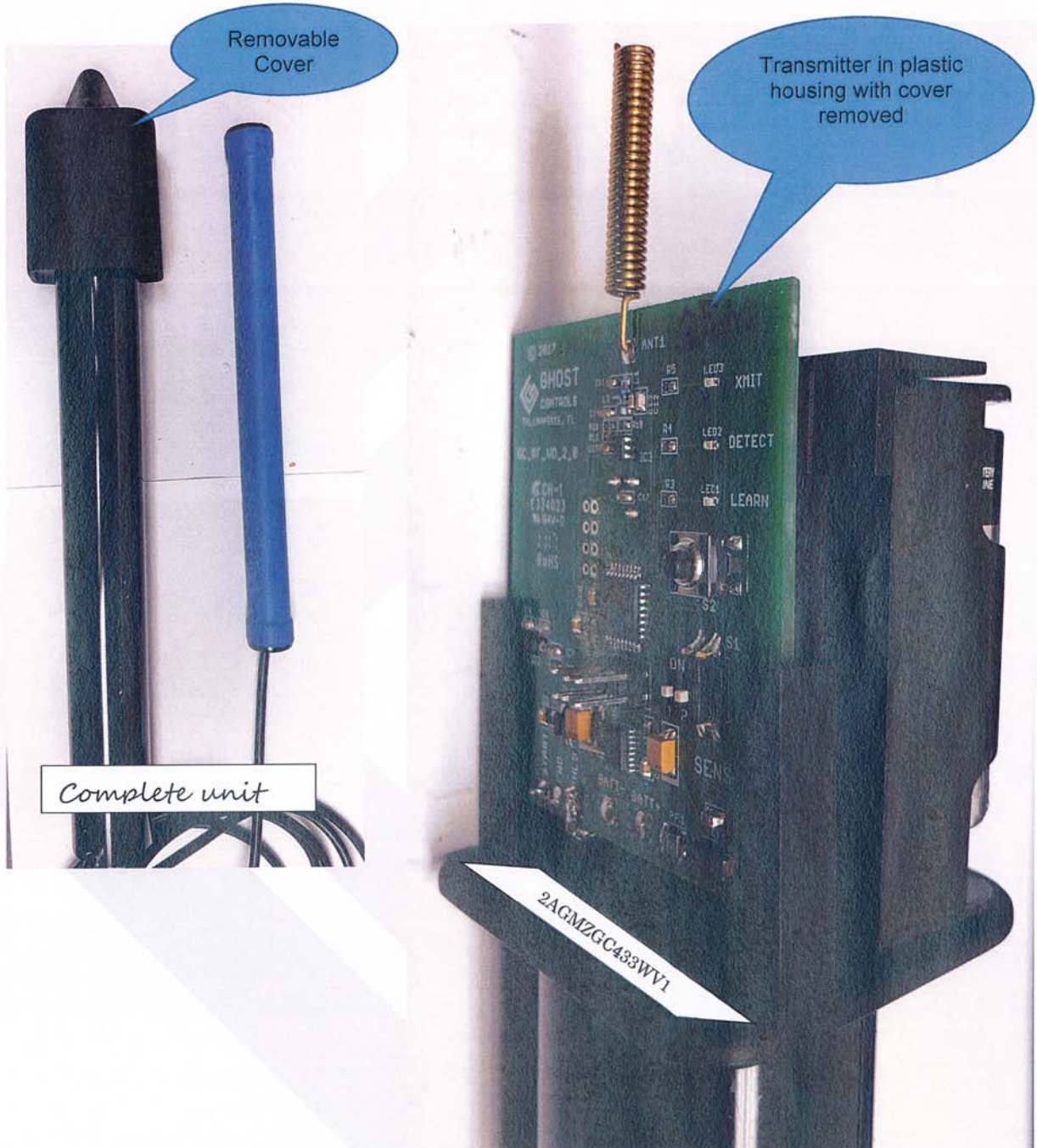
