





For Conducted Emissions:




For Radiated Emissions (Below 1GHz):

### FCC §15.203 - ANTENNA REQUIREMENT

#### **Applicable Standard**

According to § 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the user of a standard antenna jack or electrical connector is prohibited. The structure and application of the EUT were analyzed to determine compliance with section §15.203 of the rules. §15.203 state that the subject device must meet the following criteria:

- a. Antenna must be permanently attached to the unit.
- b. Antenna must use a unique type of connector to attach to the EUT.

Unit must be professionally installed, and installer shall be responsible for verifying that the correct antenna is employed with the unit.

And according to FCC 47 CFR section 15.247 (b), if the transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

#### **Antenna Connector Construction**

The EUT has a PCB Antenna for BLE and the antenna gain is 1.0 dBi, the antenna permanently attached to the EUT, fulfill the requirement of this section. Please refer to the EUT photos.



During the conducted emission test, the lamp holder was connected to the outlet of the LISN.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All final data was recorded in the Quasi-peak and average detection mode.

#### Corrected Factor & Over Limit Calculation

The Corrected Factor is calculated by adding LISN VDF (Voltage Division Factor), Cable Loss and Transient Limiter Attenuation. The basic equation is as follows:

#### **Test Procedure**

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz, Peak and Average detection mode above 1 GHz.

### **Corrected Amplitude & Margin Calculation**

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude ( $dB\mu V/m$ ) = Meter Reading ( $dB\mu V$ ) + Antenna Factor (dB/m) + Cable Loss (dB) - Amplifier Gain (dB)



### **FCC §15.247(d) – BAND EDGE**


