Requirement of Public Notice 15.212	Reference to Sengled Bluetooth Module
1. The modular transmitter must have its own RF shielding.	The module have its own RF shielding. Please see external photo.pdf
2. The modular transmitter must have buffered modulation/data inputs.	The modular has buffered data inputs, it is integrated in chip.Please see schematic.pdf
3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated before energizing other circuits internal to the 825x. Please see schematic.pdf
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The Sengled Bluetooth Module meets the FCC antenna requirements.
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The Sengled Bluetooth Module was tested in a stand-alone configuration via a PCMCIA extender. Please see conducted set-up photo.pdf and spurious set-up.
6. The modular transmitter must be labeled with its own FCC ID number, and, if the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module. The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements. A copy of these instructions must be included in the application for equipment authorization.	The Sengled Bluetooth Module is compliant with all applicable FCC rules. Detail instructions are given in the Users Manual.
