## 4. Test Configuration

### Test Mode

The EUT was programmed to be in continuously transmitting mode and the transmit duty cycle is not less than 98%.

The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application.

The radiated emission was measured in the following position: EUT stand-up position (Z axis), lie-down position (X, Y axis). The worst emission was found in stand-up position (Z axis) and the worst case was recorded.

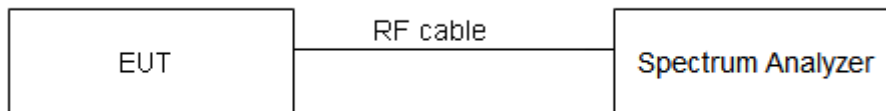

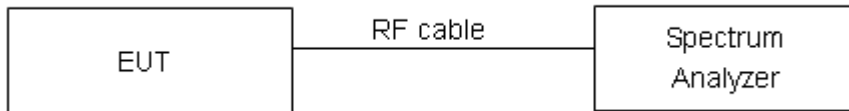

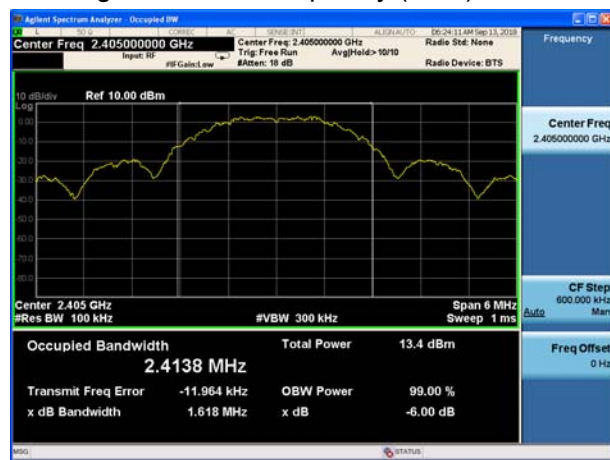

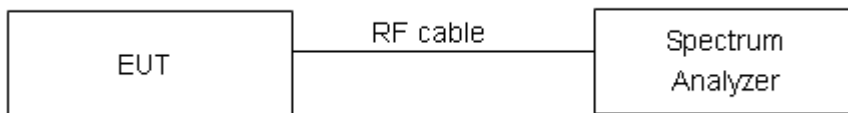

The EUT was connected to the spectrum analyzer through an external attenuator (20dB) and a known loss cable the band edge of the lowest and highest channels were measured. The peak detector is used and RBW is set to 100 kHz and VBW is set to 300 kHz on spectrum analyzer. Spectrum analyzer plots are included on the following pages.

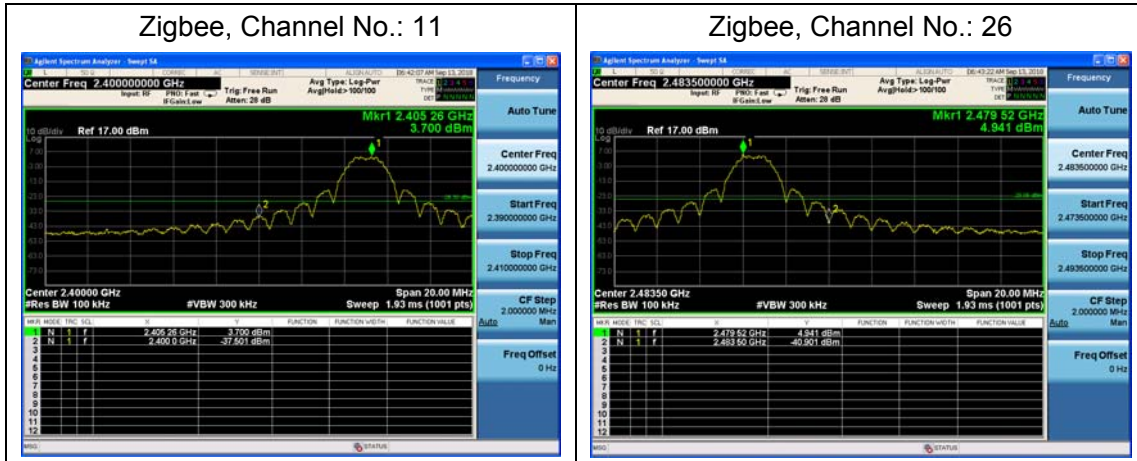

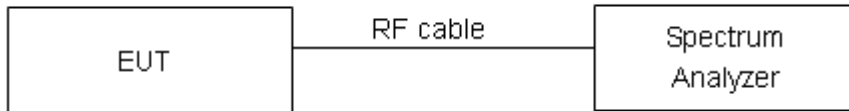
#### Method of Measurement

The EUT was connected to the spectrum analyzer through an external attenuator (20dB) and a known loss cable.

RBW is set to 3 kHz and VBW is set to 10 kHz for Zigbee on spectrum analyzer.

Set the span to 1.5 times the DTS channel bandwidth. Sweep time = auto couple. Trace mode = max hold. The peak power spectral density is recorded.

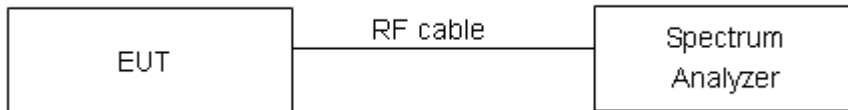

The EUT was connected to the spectrum analyzer with a known loss. The spectrum analyzer scans from 30MHz to the 10th harmonic of the carrier. The peak detector is used. Set RBW to 100kHz and VBW to 300 kHz, Sweep is set to ATUO.

The test is in transmitting mode.



#### Limits

Rule Part 15.247(d) pacifies that “In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 30 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power.” If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.”

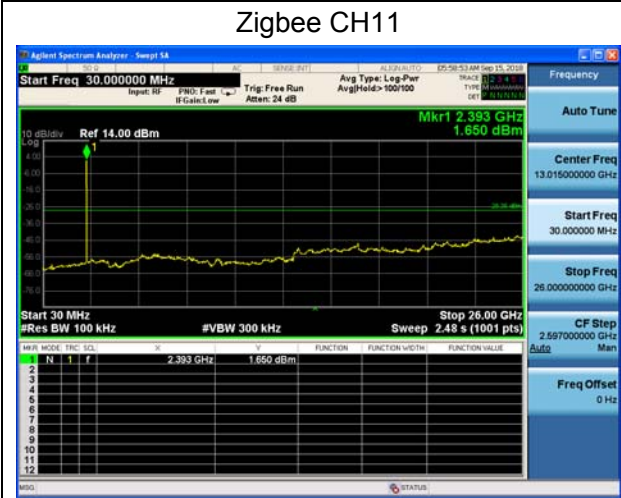

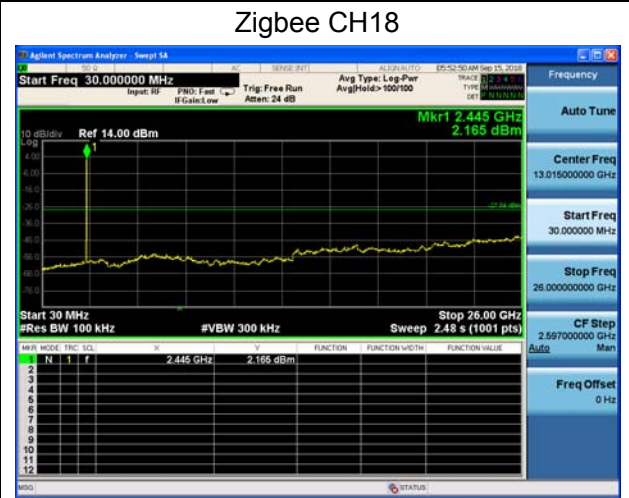

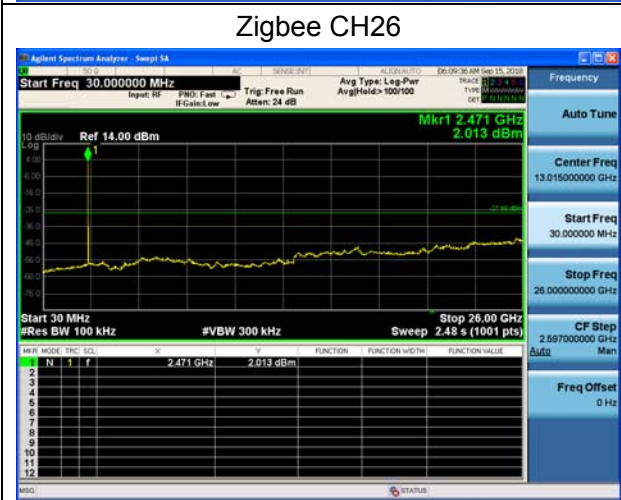

## 5.6. Unwanted Emission

### Ambient condition

### Method of Measurement

The test set-up was made in accordance to the general provisions of ANSI C63.10-2013. The Equipment Under Test (EUT) was set up on a non-conductive table in the semi-anechoic chamber. The test was performed at the distance of 3 m between the EUT and the receiving antenna.

The turntable shall be rotated from 0 to 360 degrees for detecting the maximum of radiated spurious signal level. The measurements shall be repeated with orthogonal polarization of the test antenna. RBW is set to 100kHz. The data of cable loss and antenna factor has been calibrated in full testing frequency range before the testing. Sweep the whole frequency band through the range from 9kHz to the 10th harmonic of the carrier, and the emissions less than 20 dB below the permissible value are reported.

The radiated emissions measurements were made in a typical installation configuration. Sweep the whole frequency band through the range from 9 kHz to the 10th harmonic of the carrier, and the emissions less than 20 dB below the permissible value are reported.

Set the spectrum analyzer in the following:

- (a) PEAK: RBW=VBW=3MHz / Sweep=AUTO
- (b) AVERAGE: RBW=1MHz / VBW=3MHz / Sweep=AUTO

This setting method can refer to ANSI C63.10-2013.

During the test, below 30MHz, the center of the loop shall be 1 meters; above 30MHz, the height of receive antenna shall be moved from 1 to 4 meters, and the antenna shall be performed under horizontal and vertical polarization.

The data of cable loss and antenna factor has been calibrated in full testing frequency range before the testing.

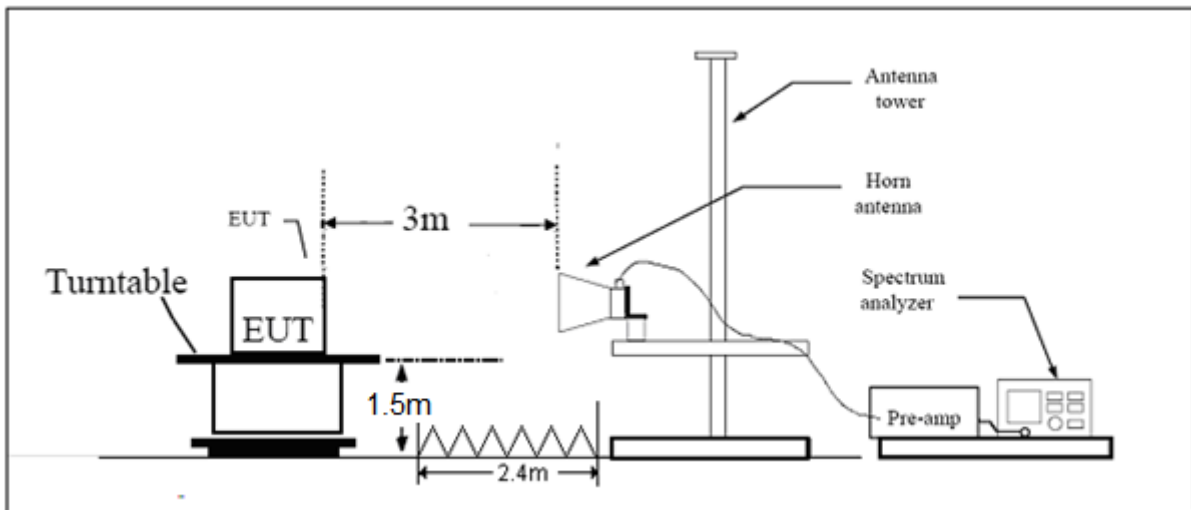

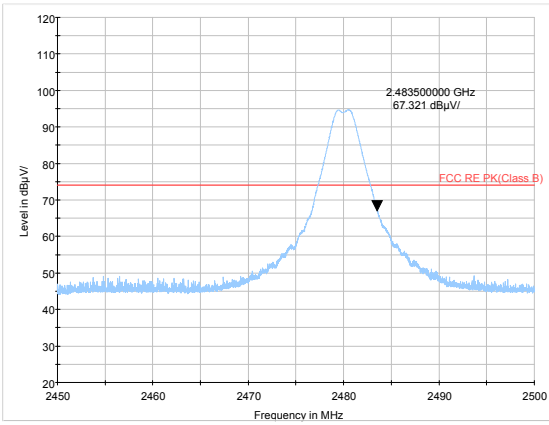
Zigbee-Channel 11: Peak



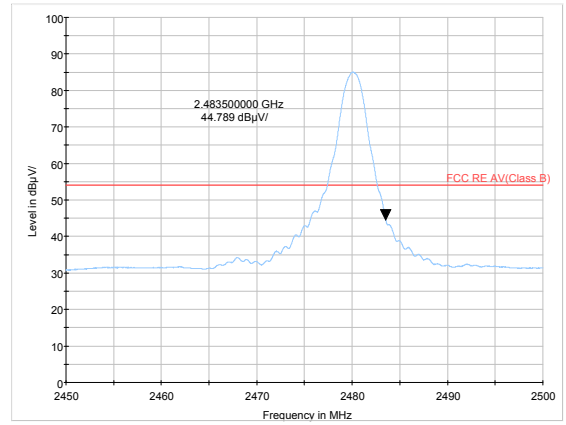
Zigbee-Channel 11: Average

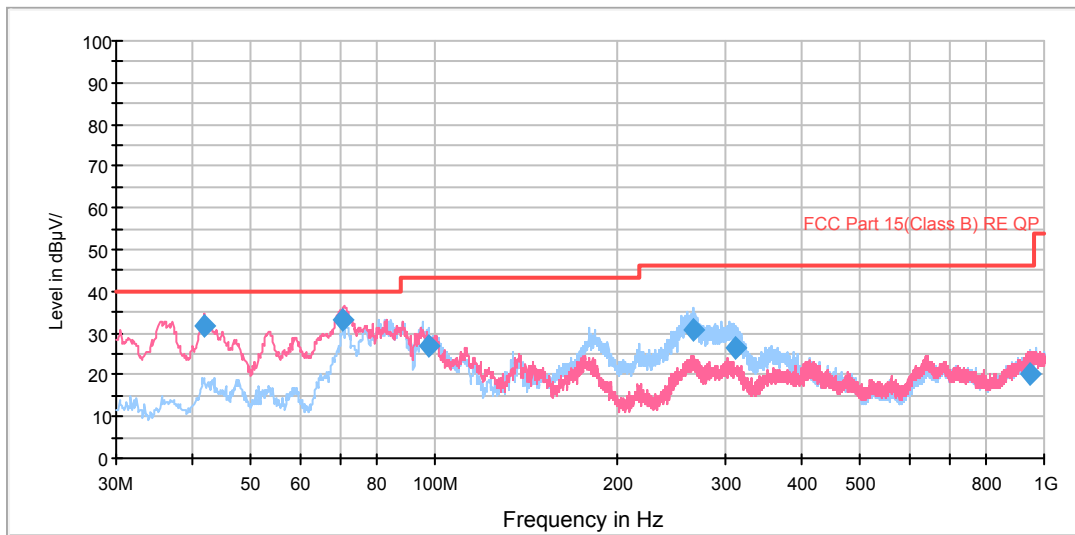
Sweep the whole frequency band through the range from 9kHz to the 10th harmonic of the carrier, the Emissions in the frequency band 9kHz-30MHz and 18GHz-26.5GHz are more than 20dB below the limit are not reported.

The following graphs display the maximum values of horizontal and vertical by software. For above 1GHz, Blue trace uses the peak detection, Green trace uses the average detection.

During the test, the Radiates Emission from 30MHz to 1GHz was performed in all modes with all channels, Zigbee, Channel 11 are selected as the worst condition. The test data of the worst-case condition was recorded in this report.

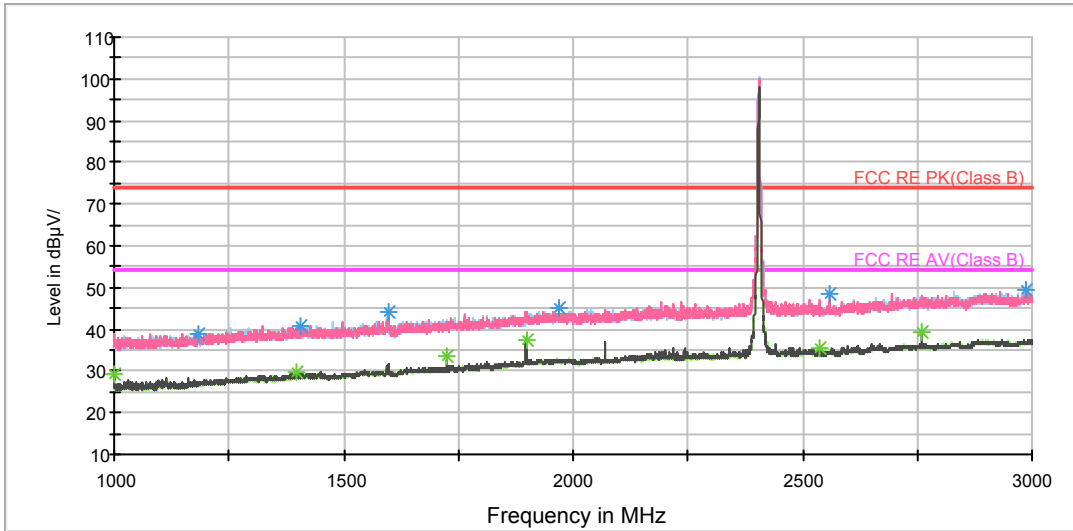

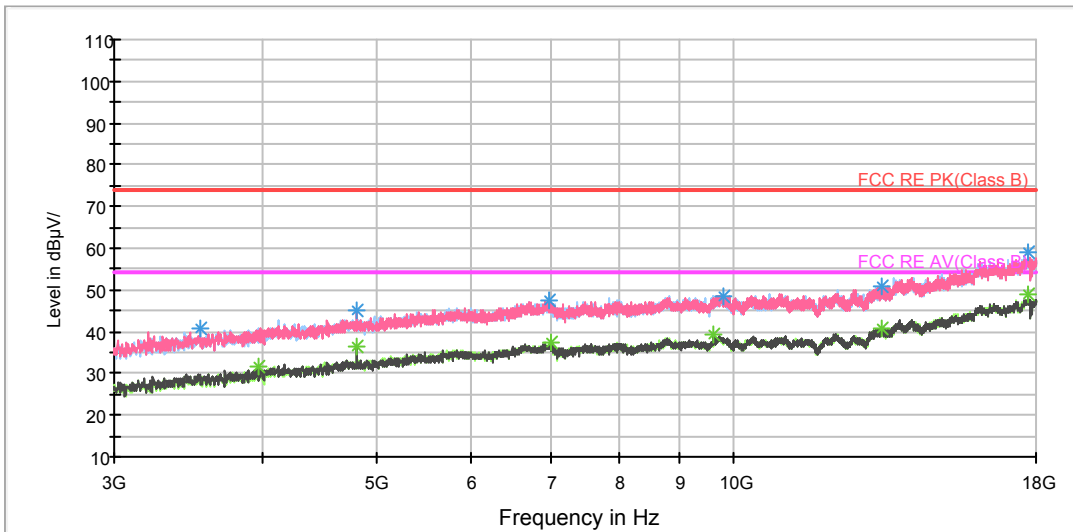

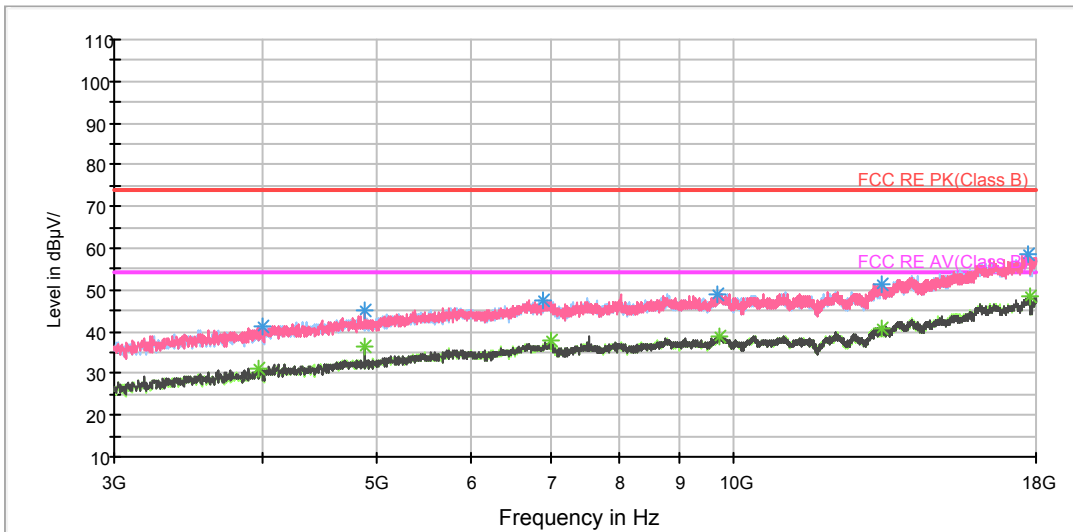

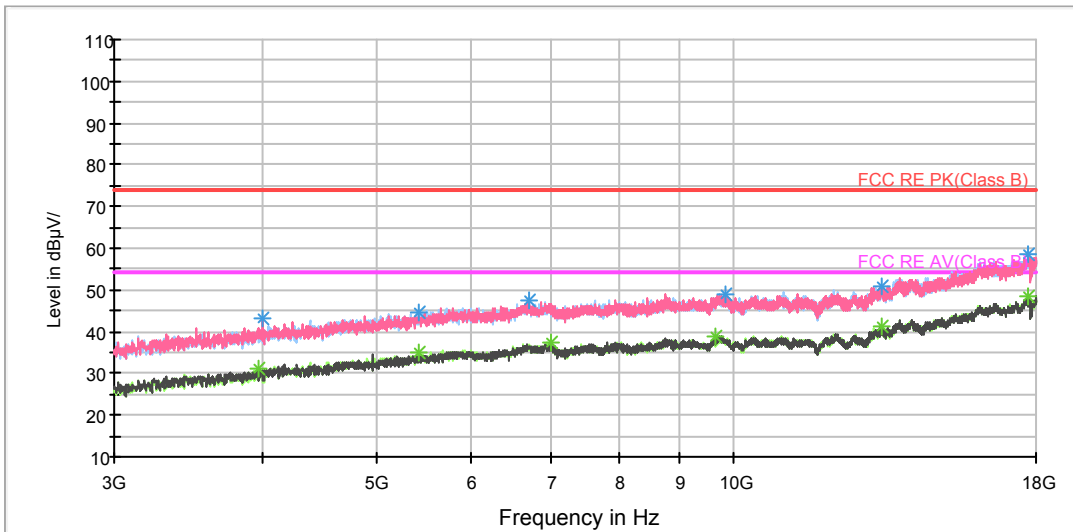

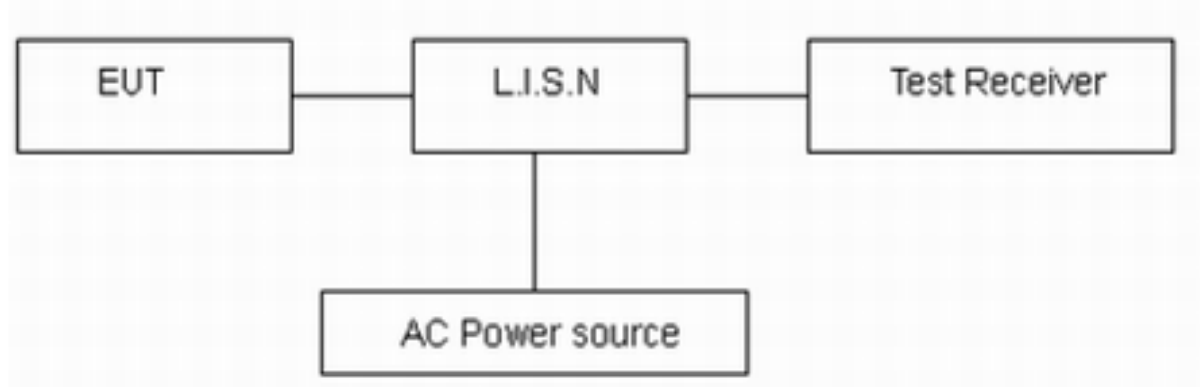

#### Methods of Measurement

The EUT is placed on a non-metallic table of 80cm height above the horizontal metal reference ground plane. During the test, the EUT was operating in its typical mode. The test method is according to ANSI C63.10-2013. Connect the AC power line of the EUT to the L.I.S.N. Use EMI receiver to detect the average and Quasi-peak value. RBW is set to 9 kHz, VBW is set to 30kHz. The measurement result should include both L line and N line.

The test is in transmitting mode.

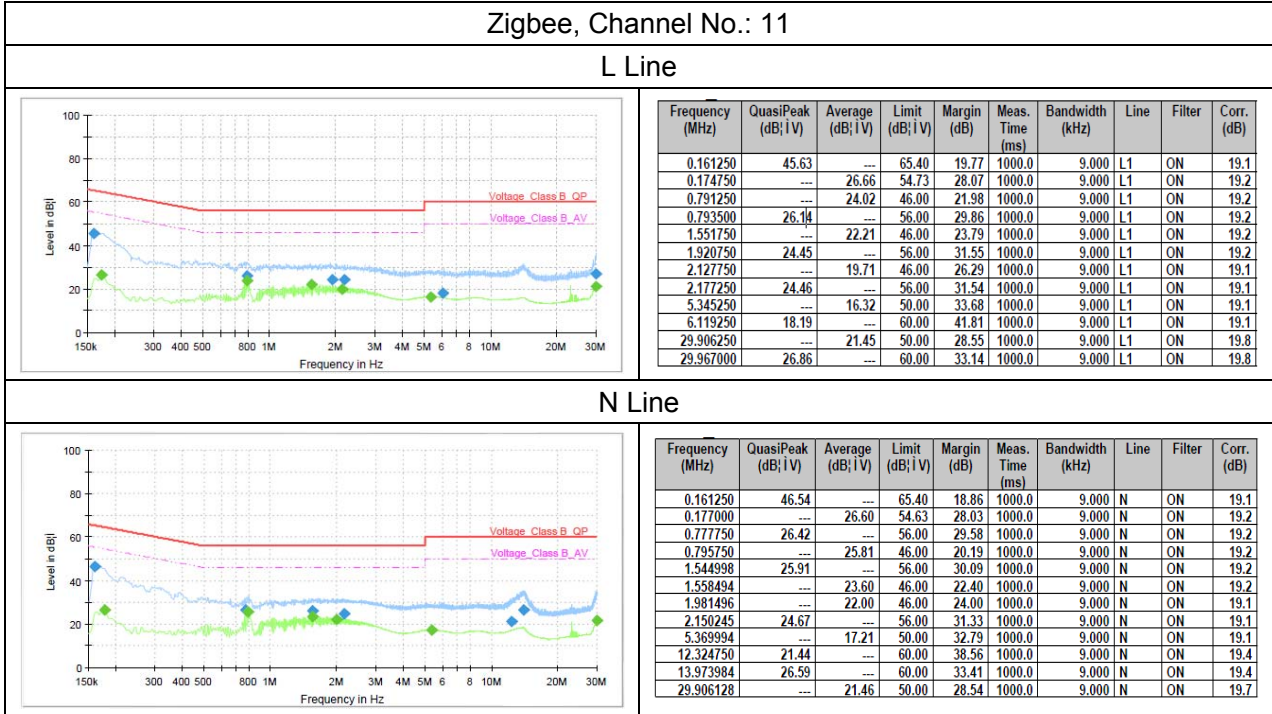
#### Measurement Uncertainty

The assessed measurement uncertainty to ensure 95% confidence level for the normal distribution is with the coverage factor  $k = 1.96$ ,  $U = 2.69$  dB.



**Test Results:**

Following plots, Blue trace uses the peak detection and Green trace uses the average detection. During the test, the Conducted Emission was performed in all channels, Zigbee, Channel No.: 11 are selected as the worst condition. The test data of the worst-case condition was recorded in this report.







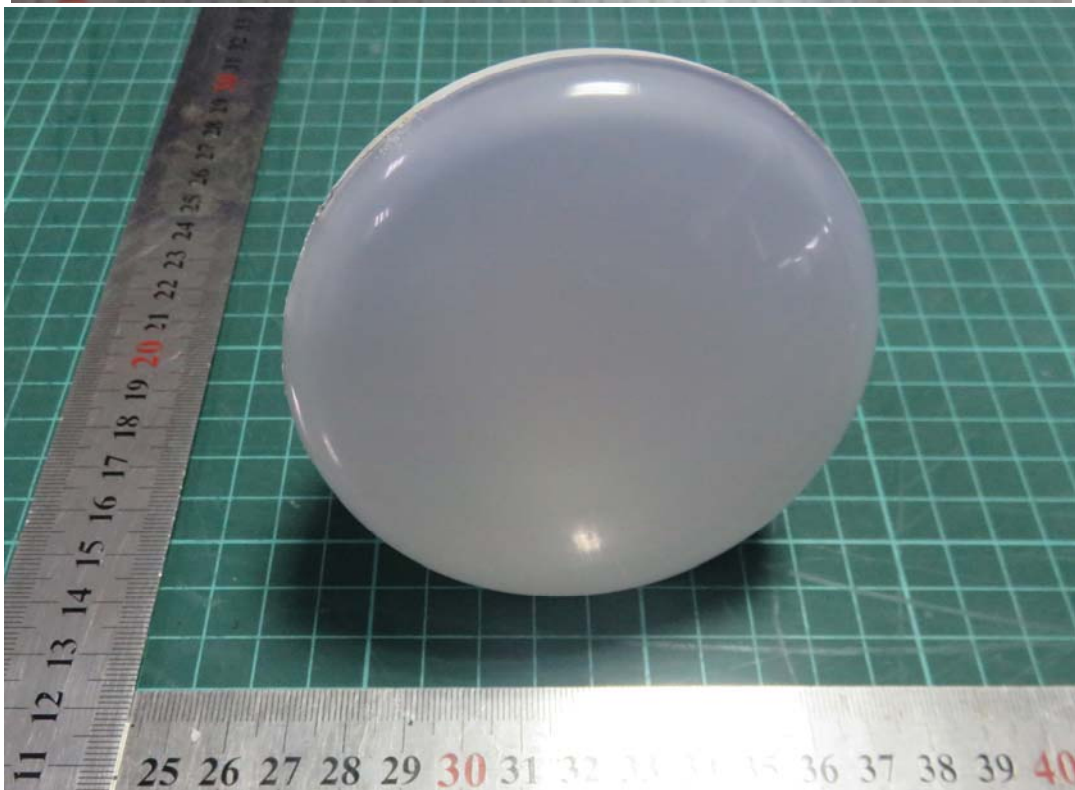

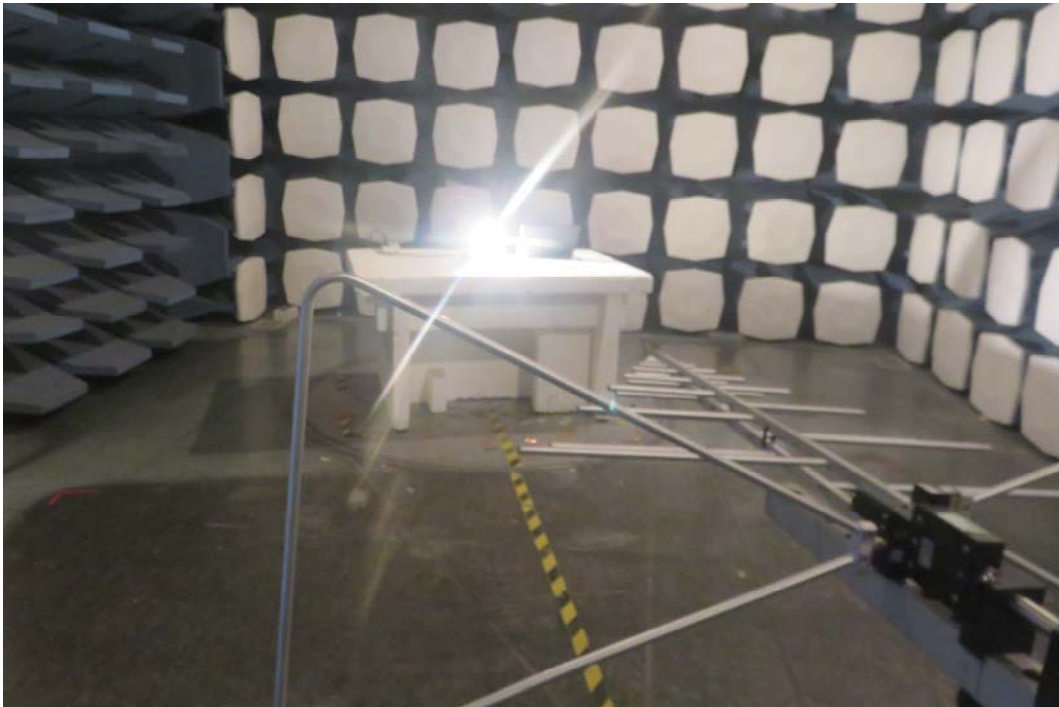

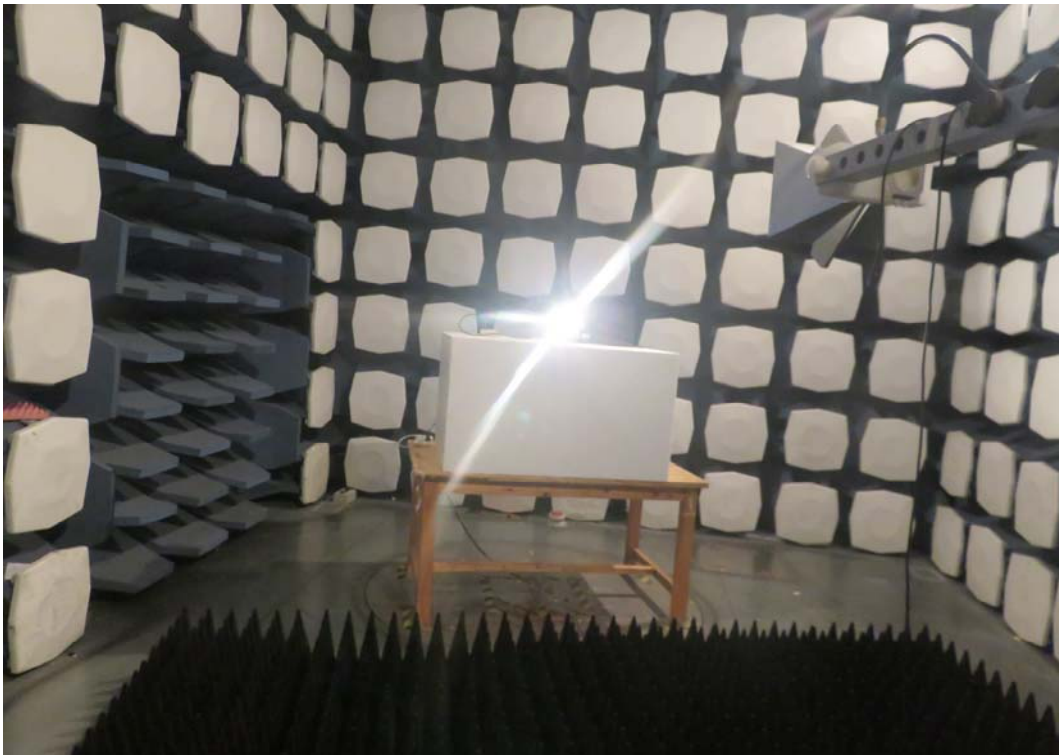
