1. The modular transmitter must have its own RF shielding.	The module have its own RF shielding. Please see external photo.pdf
2. The modular transmitter must have buffered modulation/data inputs.	The modular has buffered data inputs, it is integrated in chip.Please see schematic.pdf
3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated before energizing other circuits internal. Please see schematic.pdf
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The Sengled Wifi Module meets the FCC antenna requirements.
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The Sengled Wifi Module was tested in a stand-alone configuration via a PCMCIA extender. Please see conducted set-up photo.pdf and spurious set-up.
