Darling circle is based on canine psychological behavior characteristics of complete guide training dogs.

The complete process including:

First step: the dog near darling stick trigger darling the vibration of the ring to give warning that dog behavior;



Second step : the dog left darling posted warning disappears.

Receives the vibration and sound stimulus, the dog dog will leave darling recognition area

In the test experiment, we found that dogs tend to appear the following response:

1, sensitive dogs trigger vibration response, leave immediately darling stick warning area:

It is the most ideal situation and not to be to guide the training, but after using for a long time, likely to become for 3 kinds of situation;

2, trigger the dog after vibration response is sensitive, but still where he was:

In this case, the owner shall timely guide dogs to leave darling, make it clear to the dog, just left the vibration will disappear;

3, trigger the dog after vibration response is not sensitive, continue to stay in the darling stick induction range:

In this case, we can such training: stick the darling of the sensing range to adjust to the largest, when darling circle trigger vibration, master match "scold" dogs, guide dogs left darling, and playing with the dog, reward the dog likes to eat snacks or toys, repeated several times. Do you want to be the product the best effect, the need to continue training and patience.

Warm reminder:

This product only auxiliary tool for dog, dog effect for dogs and master the discipline of different ways.
