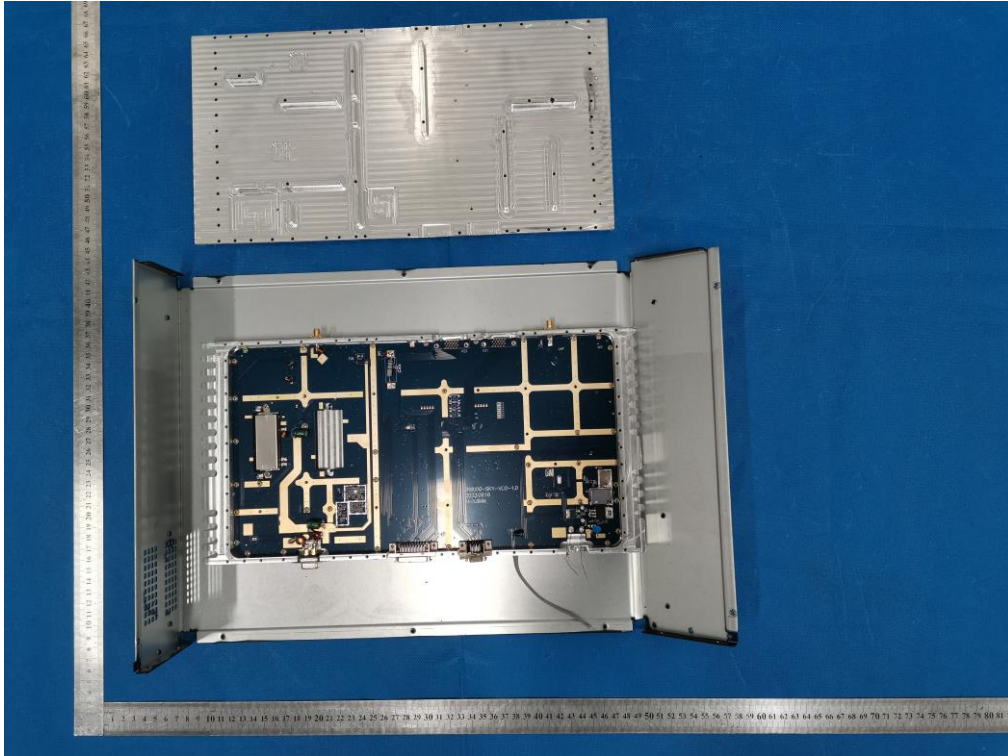

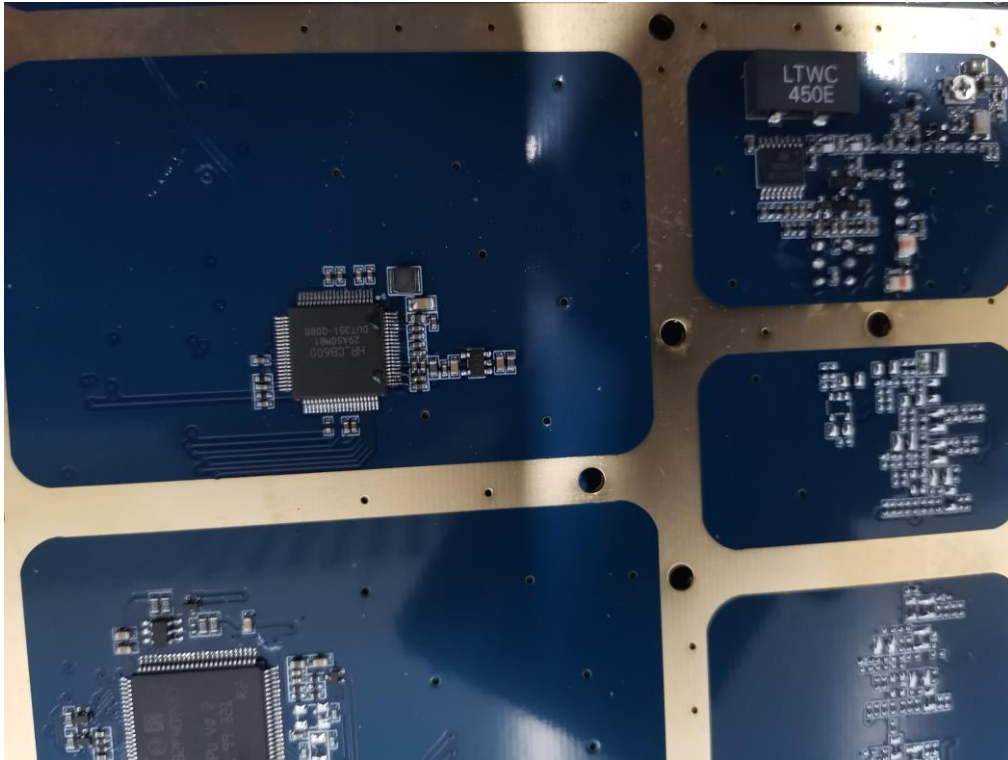

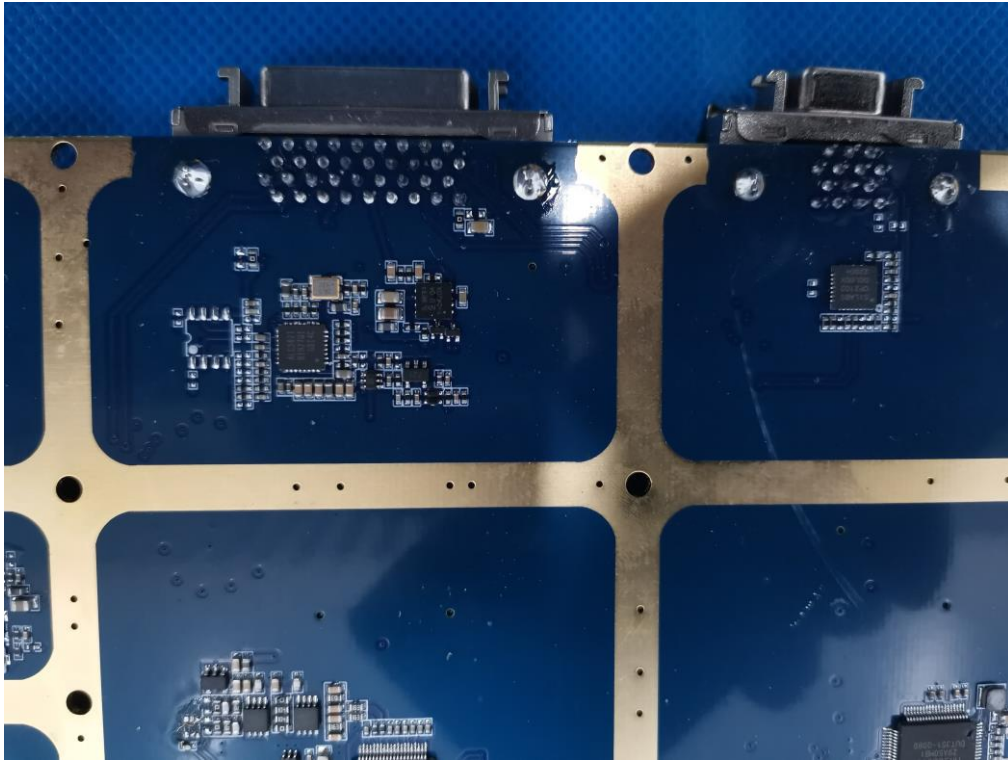

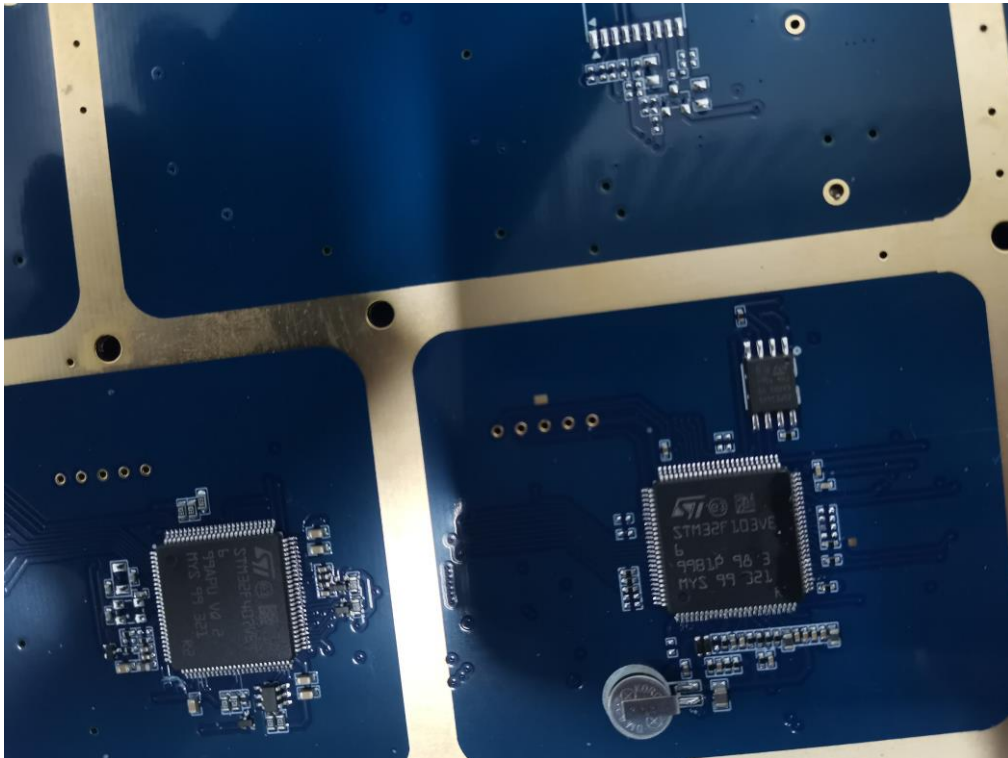

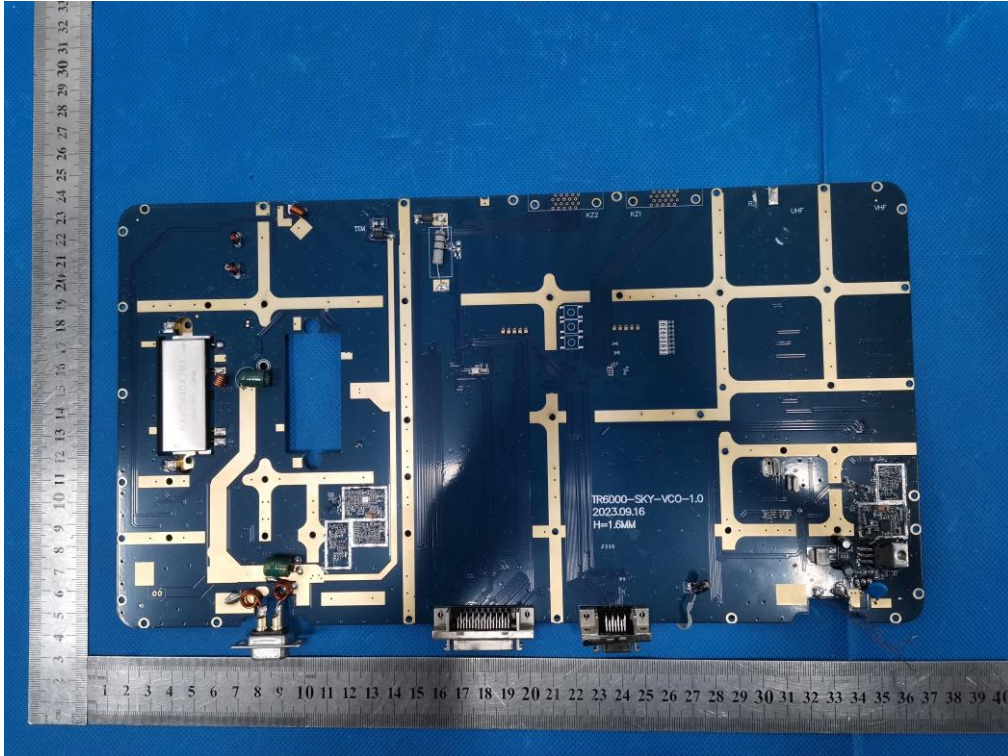

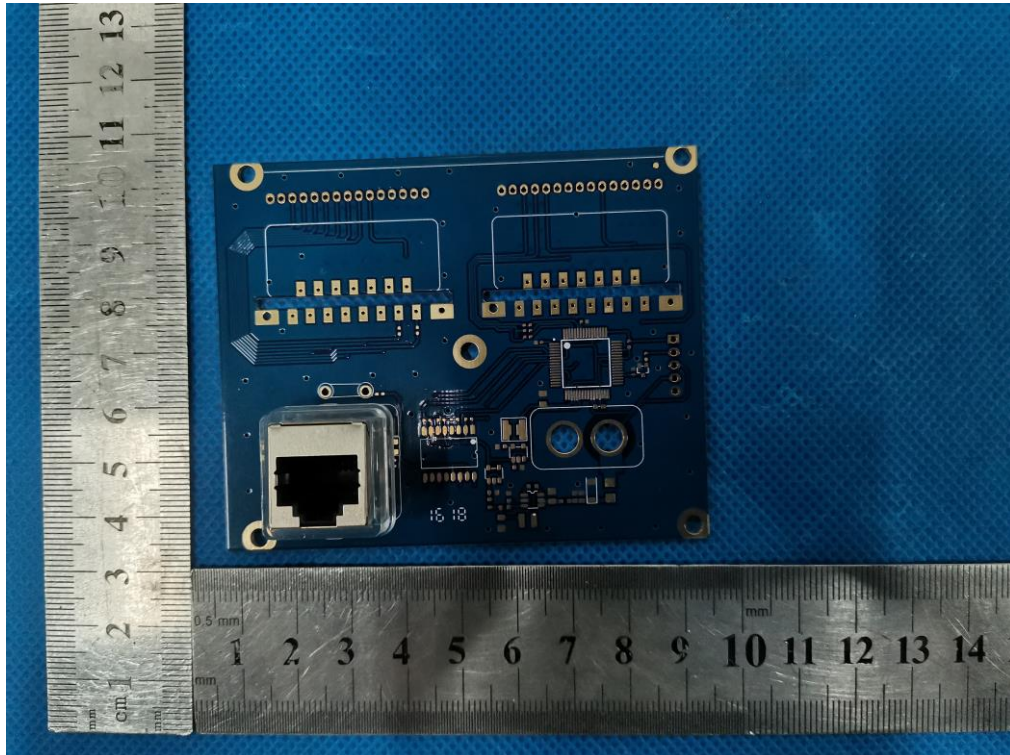

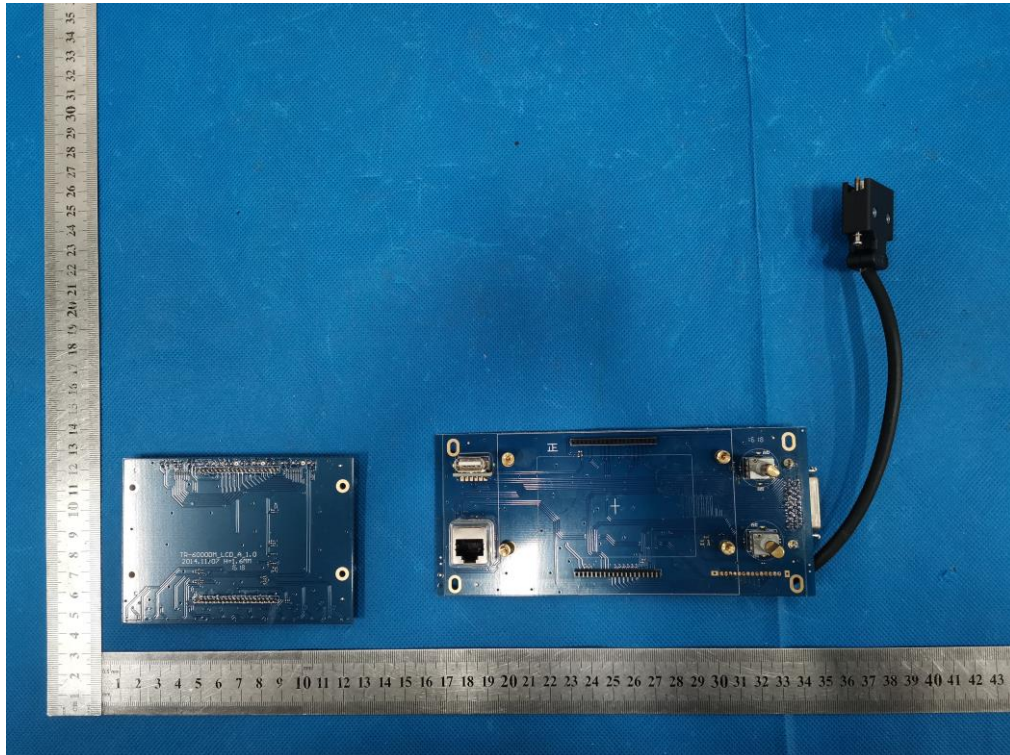

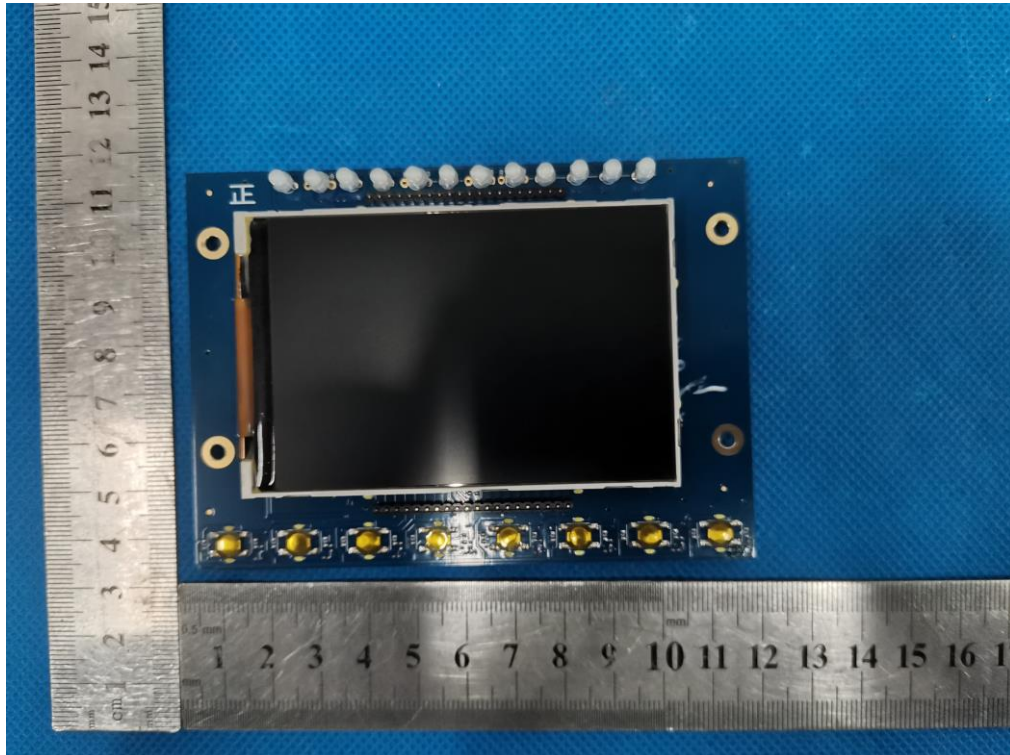

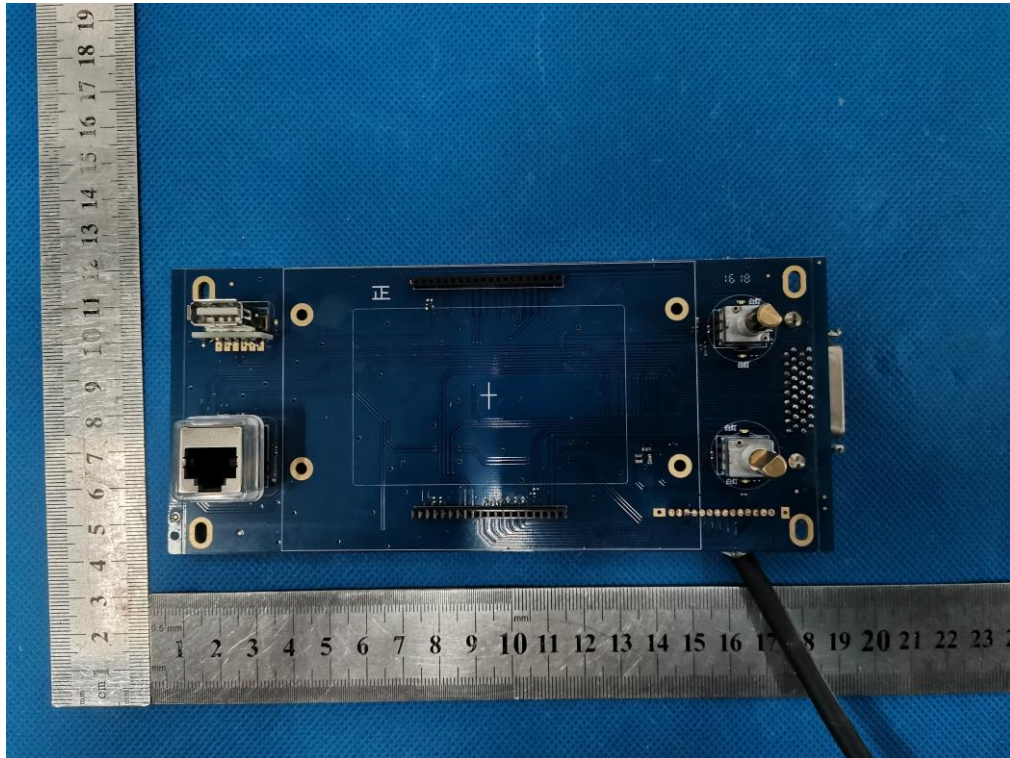

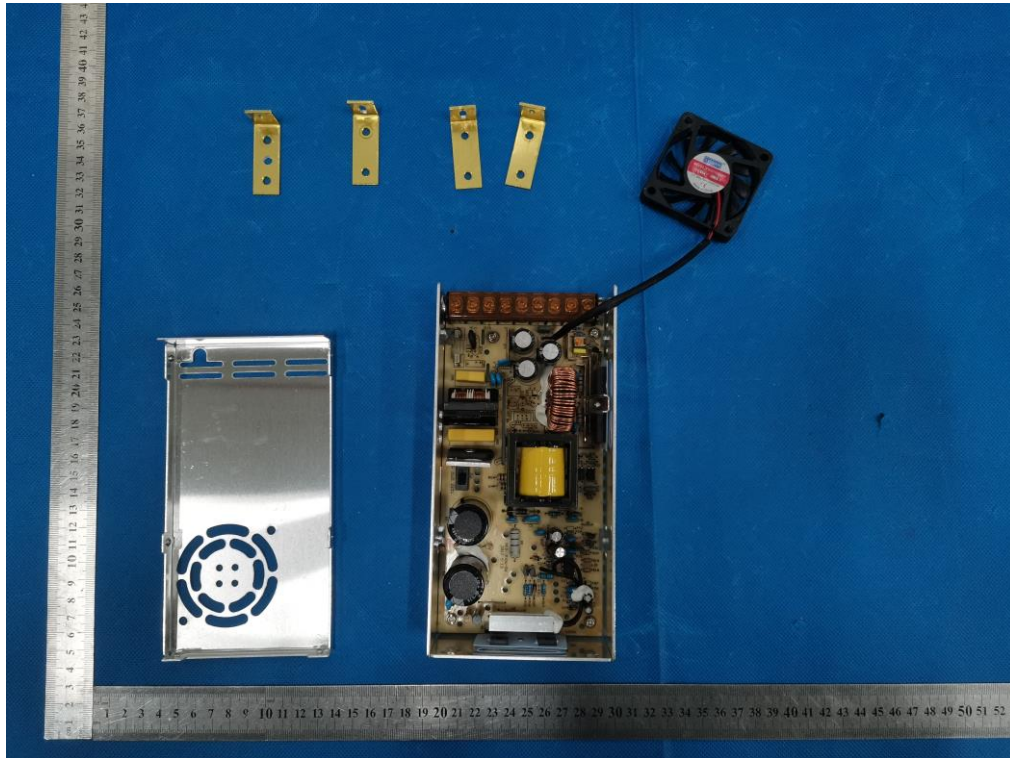

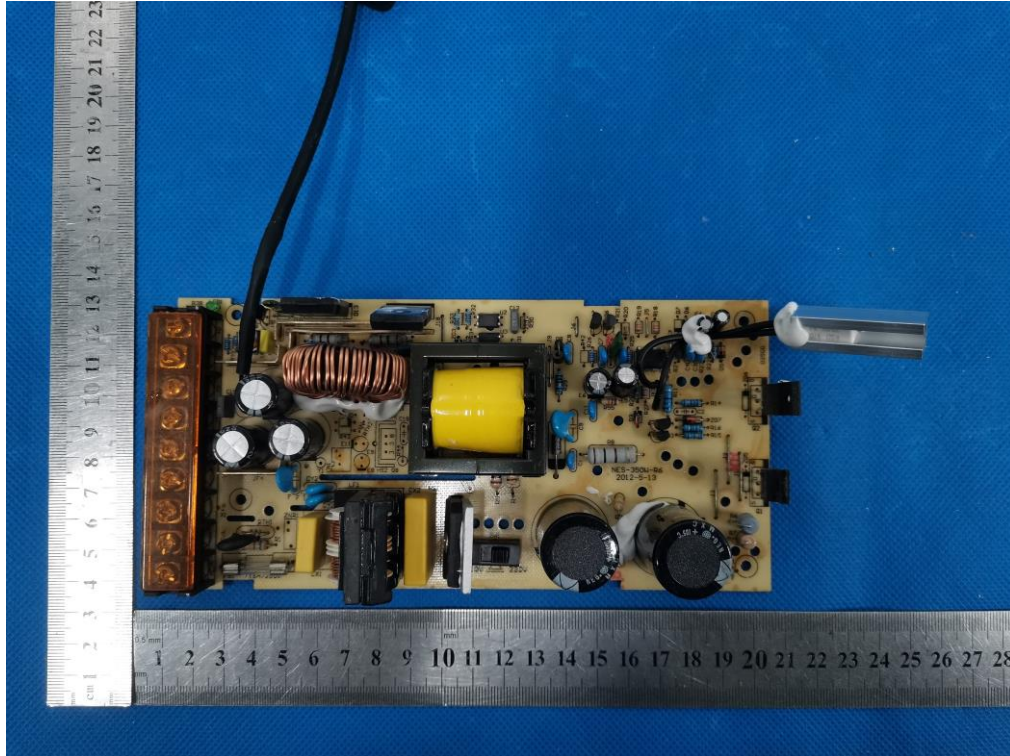

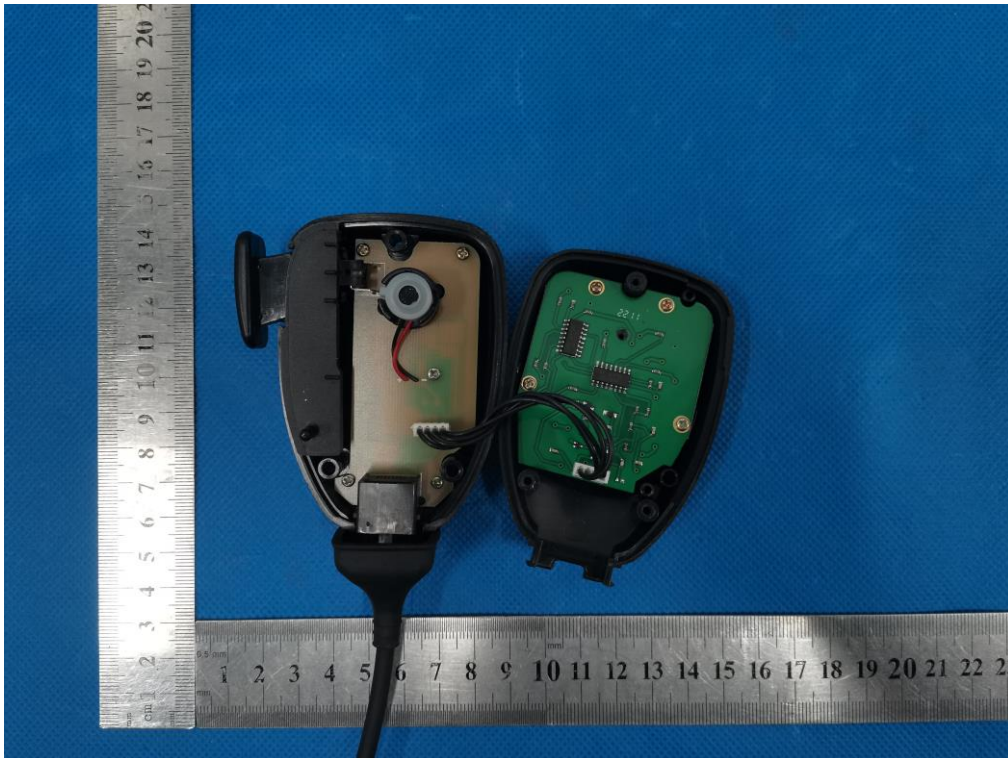
INTERNAL VIEW OF EUT (FIGURE 22)



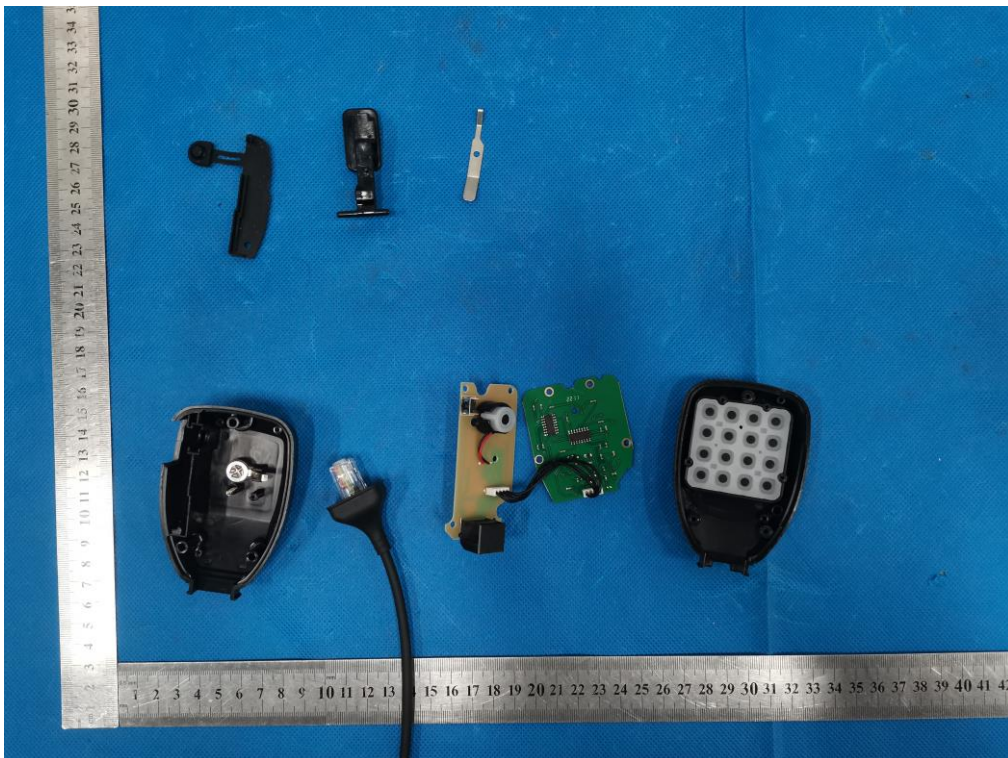

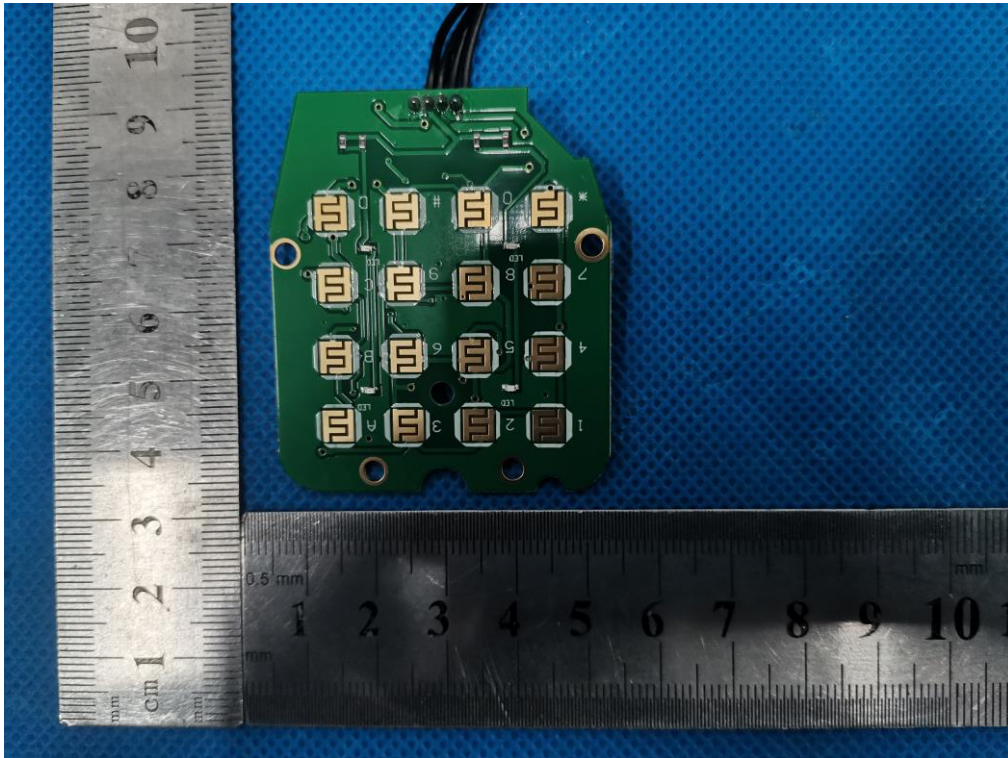

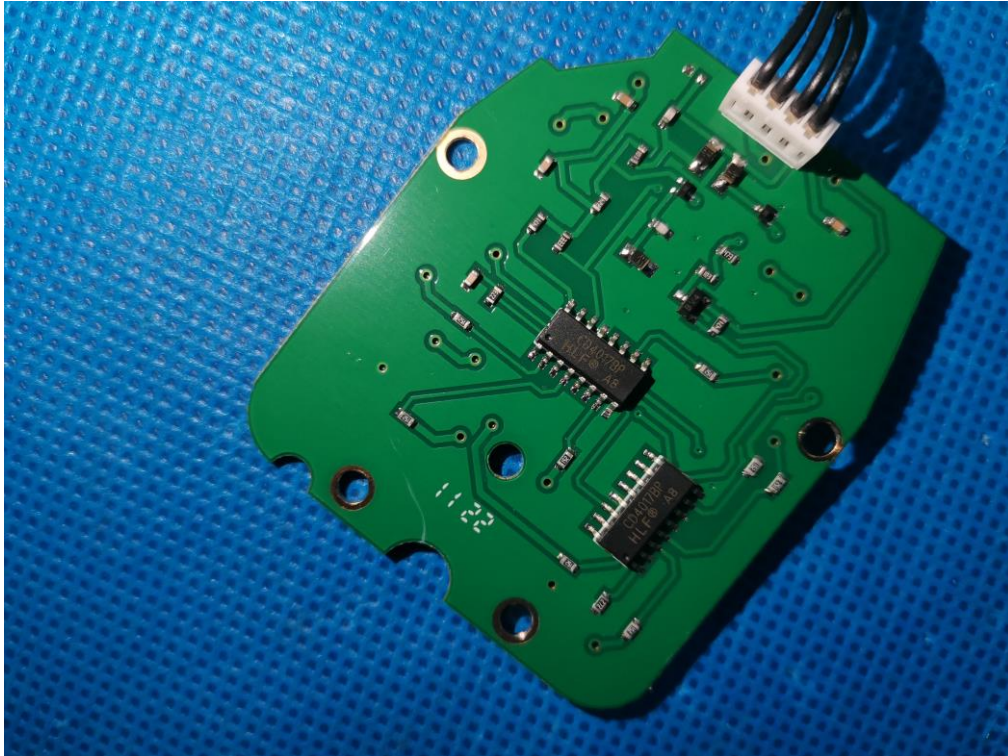
