- 1) Synchronize Data and upload: Connect Hesvitband with mobile phone via Bluetooth, then the data will be automatically synchronized to the APP, the data in the APP will be automatically uploaded to the Cloud Server.
- 2) Turn on backlight Press the Hesvithand button to turn on the screen backlight. It goes out automatically in 5s
- 3) Heart rate test

Heart Rate Monitor: Automatic measurement at integral time: Automatic measurement function will be started at every integral time point; Measure dynamic heart rate: continuously press heart rate button two times to open dynamic heartbeat monitoring. Measure constant heart rate: long press heart rate button to open constant, heart rate test

Turn off heart rate test: when the heart rate test is turned on. long press or continuous two-time press heart rate button can turn off the heart rate test

Set the time

Automatically set the time after being connected with mobile APP.

Vibration reminder

At vibration reminder, press the Hesvitband button once to stop the vibration reminder.

6) WeChat Official account

Scan the below QR code in the Quick Start Guide via Wechat APP. After binding the wristband to Wechat official account "Hesvit", you can check the data of wristband and receive message from official account "Hesvit".

Notes and FAOs

- 1) Charging for first time use
- Hesvit S4's standby time is 10 days. During the transportation, the battery may already run out. If the screen does not light up, charge it for 2-3 hours via the USB port at the bottom of the wristband.
- If power of band is exhausted, using solar charging can't directly activate the band. still need charging band by micro USB cable to turn it on.
- 2) Upgrade
- · When upgrading Hesvitband, if progress bar appears stuck, first return or quit the APP, then upgrade again, If still failed, turn off the phone Bluetooth and on again. Then re-upgrade.
- Connection
- When a phone with Android 6.0 or above uses the Hesvitband APP to bind a wristband, please enable all phone

- permissions, such as location permission, to ensure the mobile phone can find the wristband and complete the binding successfully:
- When an IOS phone uses the Hesvitband APP to bind a wristband, if no wristband can be found in the Hesvithand APP please access the phone Bluetooth setting, select to neglect the connected wristhand, then you'll be able to find the wristband in the APP and complete the binding successfully
- 4) Inconsistency between WeChat official account "Hesvit" and wristband steps
- If users have bound multiple units with stens-counting function or the phone has such function. WeChat official account "Hesvit" will synchronously get the steps from the bound units including the phone with steps-counting function. The WeChat official account will select the one with the highest value to display on the leaderboard. To let the data displayed by the WeChat official account "Hesvit" be the same as that of the Hesvitband, do the following settings:
- Disable the steps-counting function of the mobile phone
- IOS phones: Access phone "Settings" -> "WeChat" -> Disable "Sports and Fitness":
- Android phones: Access "WeChat" -> "Message" -> "WeChat Sports (Official Account)" -> "More" -> "Settings" -> Disable "Enable

- Delete all other steps-counting units except the Hesvitband
- Access "WeChat" -> "Me" -> "Settings" -> "Device" -> Select the steps-counting device to be deleted -> "Delete the device" .
- Attentions for heart rate test
- To wear the wristband, adjust the wrist strap to a proper position, ensure the heart rate sensor at the bottom of the wristband touch the skin tightly.
- · When testing the heart rate, keep the wristband standstill. Do not shake it;
- Heart rate test may fail due to thick body hair and dark skin,
- Waterproof
- Hesvit S4 has IP67-rated waterproof and dustproof. All waterproof standards are designed on the basis of cold water. Do not wear it during shower or sauna. Otherwise, the user is liable for the damage caused thereby.
