## 1.2. Objective

The primary objective of the manufacturer is compliance with Subpart C of Part 15 of FCC Rules for the radiated and conducted emissions of intentional radiators. Certification of these devices is required as a prerequisite to marketing as defined in Part 2 the FCC Rules.

Certification is a procedure where the manufacturer or a contracted laboratory makes measurements and submits the test data and technical information to the FCC. The FCC issues a grant of equipment authorization upon successful completion of their review of the submitted documents. Once the equipment authorization has been obtained, the label indicating compliance must be attached to all identical units, which are subsequently manufactured.

Maintenance of compliance is the responsibility of the manufacturer. In both modes the carrier current device within the EUT was operational. When we press the button the EUT will transmit one signal and continue transmitting for 0.2075s.

## 2. TEST METHODOLOGY

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Shenzhen LCS Compliance Testing Laboratory Ltd..

# 2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

### 2.2. EUT Exercise

The EUT was operated in the normal operating mode. The TX frequency that was fixed which was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209 and 15.231 under the FCC Rules Part 15 Subpart C.

### 2.3. General Test Procedures

#### 2.3.1 Conducted Emissions(N/A)

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

#### 2.3.2 Radiated Emissions

The EUT is placed on a turn table, which is 1.5 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2013

### 2.4. Instrument Calibration

All test equipment is regularly checked to ensure that performance is maintained in accordance with the manufacturer's specifications. All antennas are calibrated at regular intervals with respect to tuned half-wave dipoles. An exhibit of this report contains the list of test equipment used and calibration information.

#### 2.5. Test Mode

The EUT has been tested under engineering mode. The field strength of radiation emission was measured in the following position: EUT stand-up position (Y axis), lie-down position (X, Z axis).

The worst case of X axis was reported.

A new battery supplied DC 12.0V power to the EUT for testing.



- --- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.
- --- If the EUT is a floor standing device, it is placed on the ground.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions.
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

#### **Premeasurement:**

- --- The turntable rotates from 0 °to 315 °using 45 °steps.
- --- The antenna height is 0.8 meter.
- --- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

#### **Final measurement:**

- --- Identified emissions during the premeasurement the software maximizes by rotating the turntable position (0  $^{\circ}$ to 360  $^{\circ}$ ) and by rotating the elevation axes (0  $^{\circ}$ to 360  $^{\circ}$ ).
- --- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.

- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

#### **Premeasurement:**

- --- The turntable rotates from 0 °to 315 °using 45 °steps.
- --- The antenna is polarized vertical and horizontal.
- --- The antenna height changes from 1 to 3 meter.
- --- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

## **Final measurement:**

- --- The final measurement will be performed with minimum the six highest peaks.
- --- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ( $\pm45$ °) and antenna movement between 1 and 4 meter.
- --- The final measurement will be done with QP detector with an EMI receiver.
- --- The final levels, frequency, measuring time, bandwidth, antenna height, antenna polarization, turntable angle, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.

## 3) Sequence of testing 1 GHz to 18 GHz

#### **Setup:**

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a rotatable table with 1.5 m height is used.
- --- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

#### **Premeasurement:**

- --- The turntable rotates from 0 °to 315 °using 45 °steps.
- --- The antenna is polarized vertical and horizontal.
- --- The antenna height scan range is 1 meter to 2.5 meter.
- --- At each turntable position and antenna polarization the analyzer sweeps with peak detection to find the maximum of all emissions.

#### **Final measurement:**

- --- The final measurement will be performed with minimum the six highest peaks.
- --- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ( $\pm 45$  °) and antenna movement between 1 and 4 meter. This procedure is repeated for both antenna polarizations.
- --- The final measurement will be done in the position (turntable, EUT-table and antenna polarization) causing the highest emissions with Peak and Average detector.
- --- The final levels, frequency, measuring time, bandwidth, turntable position, EUT-table position, antenna polarization, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.

- --- If the EUT is a tabletop system, a rotatable table with 1.5 m height is used.

- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 1 meter.



With the EUT's antenna attached, the EUT's 20dB Bandwidth power was received by the test antenna which was connected to the spectrum analyzer with the START and STOP frequencies set to the EUT's operation band.

## 5.4. Duty cycle

#### 5.4.1. Limit

No dedicated limit specified in the Rules.

- 5.4.2. Test Procedure
- 5.4.2.1. Place the EUT on the table and set it in transmitting mode.
- 5.4.2.2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
- 5.4.2.3. Set centre frequency of spectrum analyzer=operating frequency.
- 5.4.2.4. Set the spectrum analyzer as RBW=100kHz, VBW=100KHz, Span=0Hz, Adjust Sweep time.
- 5.4.2.5. Repeat above procedures until all frequency measured was complete.






