

(TEM-Cell: ifi110 EXX, Waveguide: R22)






Receiving Pattern (Φ), θ=0°






Conversion Factor Assessment








Receiving Pattern (Φ), θ=0°

f=1800 MHz, R22






f=750 MHz, WGLS R9(H_convF)
