5. DEVICE UNDER TEST

The EUT is a mmWave transceiver, operating in the FR2 n260 band. The EUT also contains a BLE and 5GHz WLAN radio.

Output power and Antenna gain data for the 37GHz radio is excerpted UL LLC test report R14753279-E3. Information pertaining to the BLE and 5GHz WLAN radios are extracted from UL LLC test reports R14753279-E1 and R14753279-E2 respectively.

6. MAXIMUM PERMISSIBLE EXPOSURE (LIMITS AND EQUATIONS)

6.1. FCC RULES

§1.1310 The criteria listed in Table 1 shall be used to evaluate the environmental impact of human exposure to radio-frequency (RF) radiation as specified in §1.1307(b), except in the case of portable devices which shall be evaluated according to the provisions of §2.1093 of this chapter.

Notes:

- (1) Occupational/controlled exposure limits apply in situations in which persons are exposed as a consequence of their employment provided those persons are fully aware of the potential for exposure and can exercise control over their exposure. Limits for occupational/controlled exposure also apply in situations when a person is transient through a location where occupational/controlled limits apply provided he or she is made aware of the potential for exposure.
- (2) General population/uncontrolled exposure limits apply in situations in which the general public may be exposed, or in which persons who are exposed as a consequence of their employment may not be fully aware of the potential for exposure or cannot exercise control over their exposure.

6.2. EQUATIONS

POWER DENSITY

Power density is given by:

 $S = EIRP / (4 * Pi * D^2)$

Where

S = Power density in mW/cm² EIRP = Equivalent Isotropic Radiated Power in mW D = Separation distance in cm

Power density in units of mW/cm² is converted to units of W/m² by multiplying by 10.

DISTANCE

Distance is given by:

D = SQRT (EIRP / (4 * Pi * S))

Where

D = Separation distance in cm EIRP = Equivalent Isotropic Radiated Power in mW S = Power density in mW/cm²

SOURCE-BASED DUTY CYCLE

Where applicable (for example, multi-slot cell phone applications) a duty cycle factor may be applied.

Source-based time-averaged EIRP = (DC / 100) * EIRP

Where

DC = Duty Cycle in %, as applicable EIRP = Equivalent Isotropic Radiated Power in mW

7. RF EXPOSURE RESULTS

In the table(s) below, Power and Gain are entered in units of dBm and dBi respectively and conversions to linear forms are used for the calculations.

Notes:

- 1) For MPE, KDB 447498 requires the calculations to use the maximum rated power; that power should be declared by the manufacturer and should not be lower than the measured power.
- 2) Maximum average output power are extracted from applicable test reports and separation values derived accordingly.
- 3) The manufacturer specified manufacturer tolerances for BLE and 5GHz WLAN is +/-1.0dB. This has been added into the above output avg power section.
- 4) The manufacturer configures output power so that the maximum power, after accounting for manufacturing tolerances, will never exceed the maximum power level measured.
- 5) The antenna gain in the table above is the maximum declared antenna gain.
- 6) Duty cycle is assumed at 100% as a worst-case condition.
- 7) EIRP for the mmwave radio was determined directly as a radiated measurement and reported accordingly.

Conclusion:

The computed power density values are less than the corresponding limits at a worse case separation distance of 632 cm; therefore, the device is compliant with the RF exposure limits for general population / uncontrolled exposure.
