扫码底座为智能金融终端提供 (旋转) 扫码、充电、USB 接口扩展和 Wi-Fi 上网功能。装上主机，开始充电，可通过底座进行扫码，或通过底座上网 (可选)；未装上主机，可通过搜索并连接底座 WiFi 进行上网；如果需要改变底座 WiFi 配置，先移除以太网接口的网线，主机连接底座 WiFi，在主机的浏览器网页输入 "192.168.1.1"，进入路由器设置系统 (账号: admin, 密码: admin)，进入 "无线-热点设置" 设置 WiFi 名称和密码。

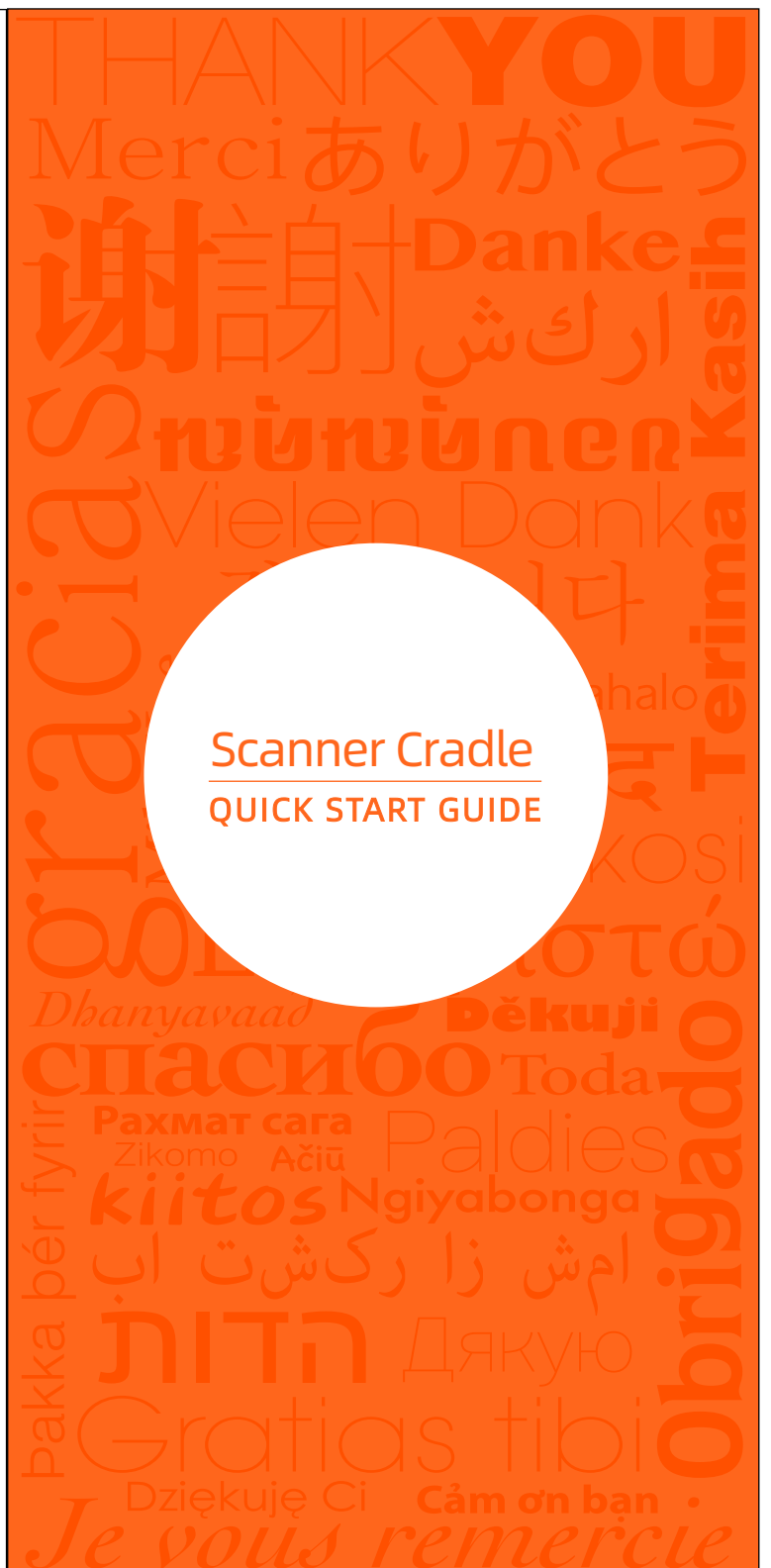
