





Fig.1 Peak Conducted Output Power CH0, DH1


Fig.2 Peak Conducted Output Power CH39, DH1





Fig.4 Peak Conducted Output Power CH0, 2DH1








Fig.10 Frequency Band Edge: GFSK, Ch0, Hopping OFF









Fig.12 Frequency Band Edge: GFSK, Ch78, Hopping OFF











Fig.15 Frequency Band Edge: $\pi/4$ DQPSK, Ch0, Hopping ON





Fig.17 Frequency Band Edge: $\pi/4$ DQPSK, Ch78, Hopping ON



Fig.18 Frequency Band Edge: 8DPSK, Ch0, Hopping OFF












Fig.23 Conducted spurious emission: GFSK, Ch0, 30MHz~26GHz









Fig.25 Conducted spurious emission: GFSK, Ch39, 30MHz~26GHz











Fig.28 Conducted spurious emission: π/4 DQPSK, Ch0, 2402MHz





Fig.30 Conducted spurious emission: π/4 DQPSK, Ch39, 2441MHz




Fig.31 Conducted spurious emission: π/4 DQPSK, Ch39, 30MHz~26GHz








Fig.33 Conducted spurious emission: π/4 DQPSK, Ch78, 30MHz~26GHz











Fig.36 Conducted spurious emission: 8DPSK, Ch39, 2441MHz





Fig.38 Conducted spurious emission: 8DPSK, Ch78, 2480MHz

A.4.2 Test Method

Portable, small, lightweight, or modular devices that may be handheld, worn on the body, or placed on a table during operation shall be positioned on a non-conducting platform, the top of which is 80 cm above the reference ground plane. The preferred area occupied by the EUT arrangement is 1 m by 1.5 m, For emissions testing at or below 1 GHz, the table height shall be 80 cm above the reference ground plane. For emission measurements above 1 GHz, the table height shall be 1.5 m. but it may be larger or smaller to accommodate various sized EUTs. For testing purposes, ceiling- and wall-mounted devices also shall be positioned on a tabletop (see also ANSI C63.10-2013 section 6.3.4 and 6.3.5). In making any tests involving handheld, body-worn, or ceiling-mounted equipment, it is essential to recognize that the measured levels may be dependent on the orientation (attitude) of the three orthogonal axes of the EUT. Thus, exploratory tests as specified in 8.3.1 shall be carried out for various axes orientations to determine the attitude having maximum or near-maximum emission level.

The EUT was placed on a non-conductive table. The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and the EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. This maximization process was repeated with the EUT positioned in each of its three orthogonal orientations.






Fig.40 Radiated emission: GFSK, Ch0, 30MHz~1GHz



Fig.41 Radiated emission: GFSK, Ch0, 1GHz~3GHz











Fig.43 Radiated emission (Low): GFSK, low channel








Fig.44 Radiated emission (High): GFSK, high channel




Fig.45 Radiated emission: π/4 DQPSK, Ch0, 30MHz~1GHz






Fig.46 Radiated emission: π/4 DQPSK, Ch0, 1GHz~3GHz




Fig.47 Radiated emission: $\pi/4$ DQPSK, Ch0, 3GHz~18GHz






Fig.48 Radiated emission (Low): π/4 DQPSK, low channel






Fig.49 Radiated emission (High): π/4 DQPSK, high channel






Fig.50 Radiated emission: 8DPSK, Ch0, 30MHz~1GHz




Fig.51 Radiated emission: 8DPSK, Ch0, 1GHz~3GHz







Fig.52 Radiated emission: 8DPSK, Ch0, 3GHz~18GHz









Fig.53 Radiated emission (Low): 8DPSK, low channel









Fig.54 Radiated emission (High): 8DPSK, high channel

Fig.56 Number of Transmissions Measurement: Ch39, Packet DH1












Fig.58 Number of Transmissions Measurement: Ch39, Packet DH3












Fig.60 Number of Transmissions Measurement: Ch39, Packet DH5















Fig.62 Number of Transmissions Measurement: Ch39, Packet 2-DH1













Fig.64 Number of Transmissions Measurement: Ch39, Packet 2-DH3















Fig.66 Number of Transmissions Measurement: Ch39, Packet 2-DH5













Fig.68 Number of Transmissions Measurement: Ch39, Packet 3-DH1












Fig.82 Carrier separation measurement: GFSK, Ch39



- 3. Span: The frequency band of operation. Depending on the number of channels the device supports, it may be necessary to divide the frequency range of operation across multiple spans, to allow the individual channels to be clearly seen.
- 4. RBW: To identify clearly the individual channels, set the RBW to less than 30% of the channel spacing or the 20 dB bandwidth, whichever is smaller.
- 5. VBW \geq RBW.
- 6. Sweep: Auto.
- 7. Detector function: Peak.
- 8. Trace: Max hold.
- 9. Allow the trace to stabilize.
- 10. Record the test rsults.









ANNEX A.9. AC Powerline Conducted Emission

Method of Measurement: See ANSI C63.10-2013-clause 6.2

- 1 The one EUT cable configuration and arrangement and mode of operation that produced the emission with the highest amplitude relative to the limit is selected for the final measurement, while applying the appropriate modulating signal to the EUT.
- 2 If the EUT is relocated from an exploratory test site to a final test site, the highest emissions shall be



remaximized at the final test location before final ac power-line conducted emission measurements are performed.

- 3 The final test on all current-carrying conductors of all of the power cords to the equipment that comprises the EUT (but not the cords associated with other non-EUT equipment in the system) is then performed for the full frequency range for which the EUT is being tested for compliance without further variation of the EUT arrangement, cable positions, or EUT mode of operation.
- 4 If the EUT is comprised of equipment units that have their own separate ac power connections, e.g., floor-standing equipment with independent power cords for each shelf that are able to connect directly to the ac power network, each current-carrying conductor of one unit is measured while the other units are connected to a second (or more) LISN(s). All units shall be separately measured. If a power strip is provided by the manufacturer, to supply all of the units making up the EUT, only the conductors in the power cord of the power strip shall be measured.

If the EUT uses a detachable antenna, these measurements shall be made with a suitable dummy load connected to the antenna output terminals; otherwise, the tests shall be made with the antenna connected and, if adjustable, fully extended. When measuring the ac conducted emissions from a device that operates between 150 kHz and 30 MHz a non-detachable antenna may be replaced with a dummy load for the measurements within the fundamental emission band of the transmitter, but only for those measurements.36 Record the six highest EUT emissions relative to the limit of each of the current-carrying conductors of the power cords of the equipment that comprises the EUT over the frequency range specified by the procuring or regulatory agency. 


Fig.91 AC Powerline Conducted Emission
