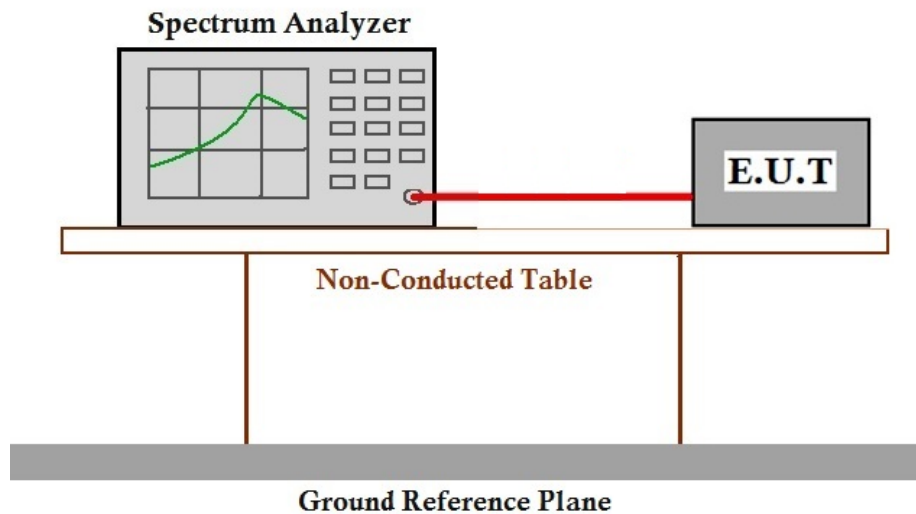

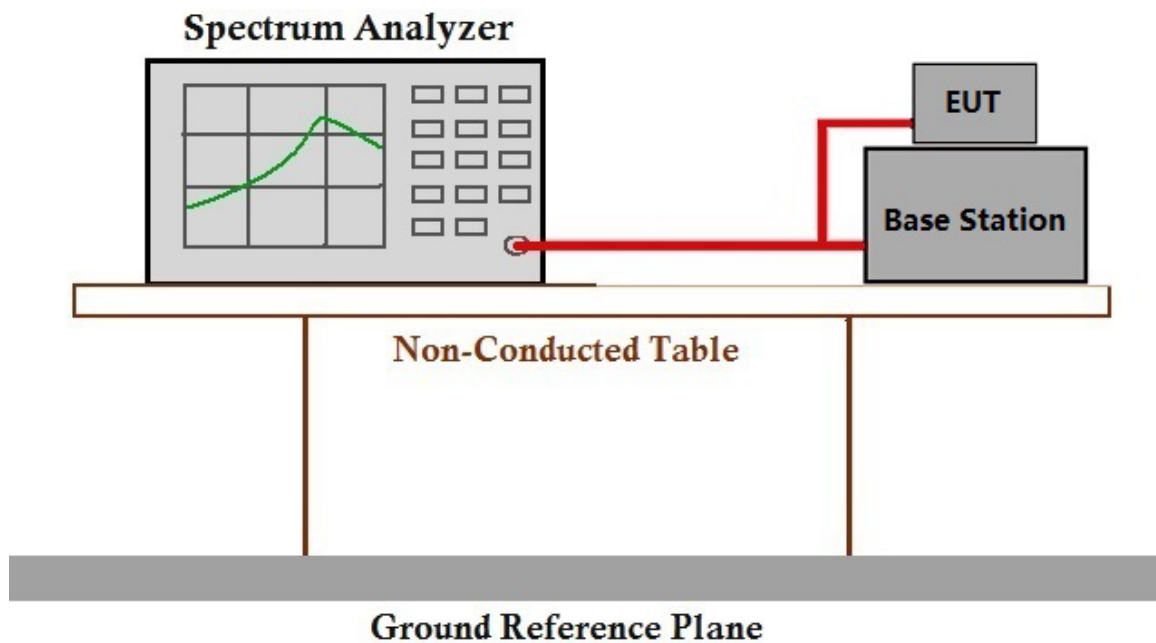

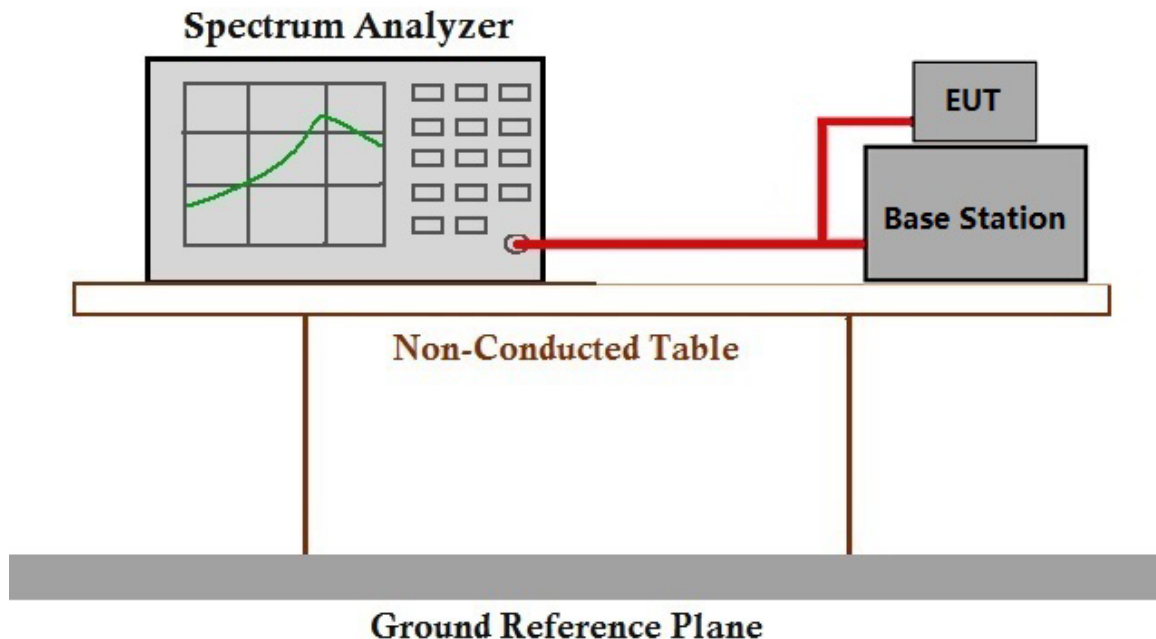

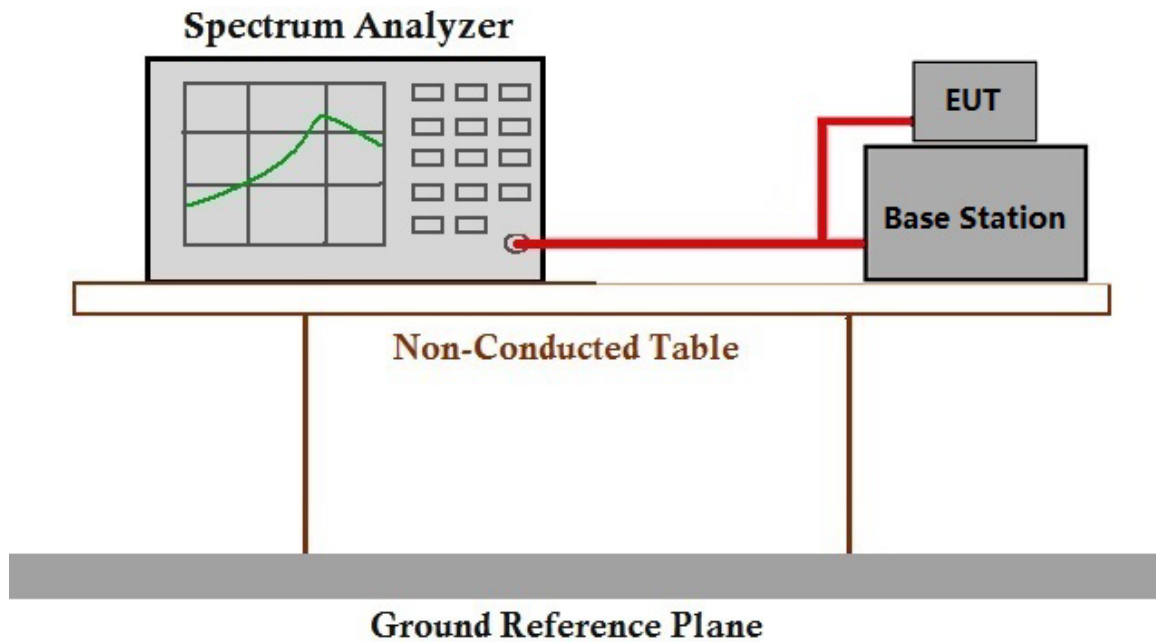

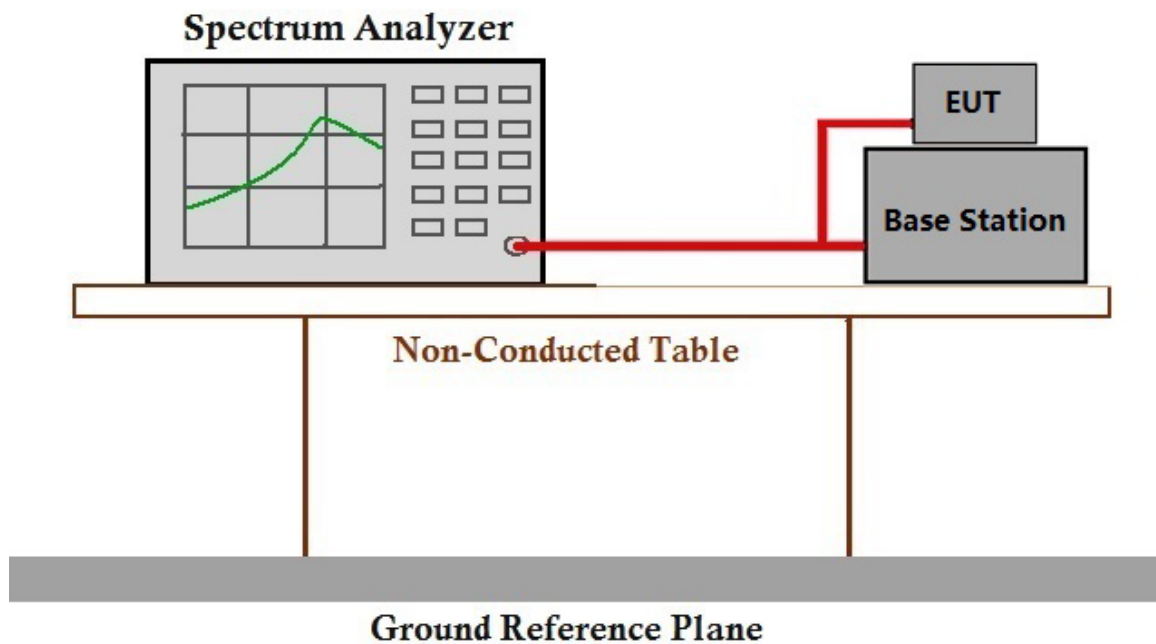

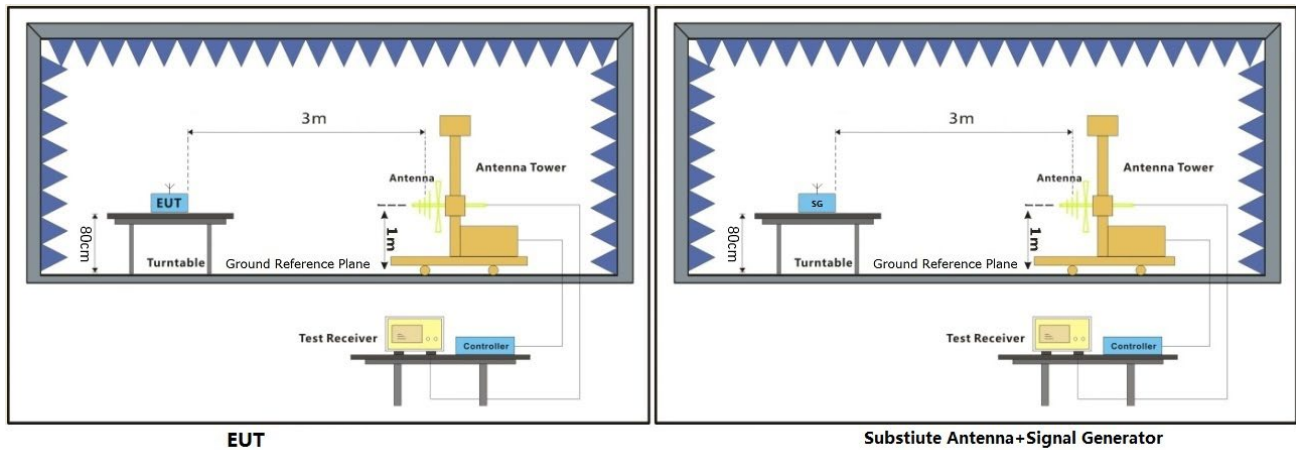

**6.6.3 Measurement Procedure and Data**

**Test Procedure:**

- (1) On a test site, the EUT shall be placed on a turntable and in the position closest to the normal use as declared by the user.

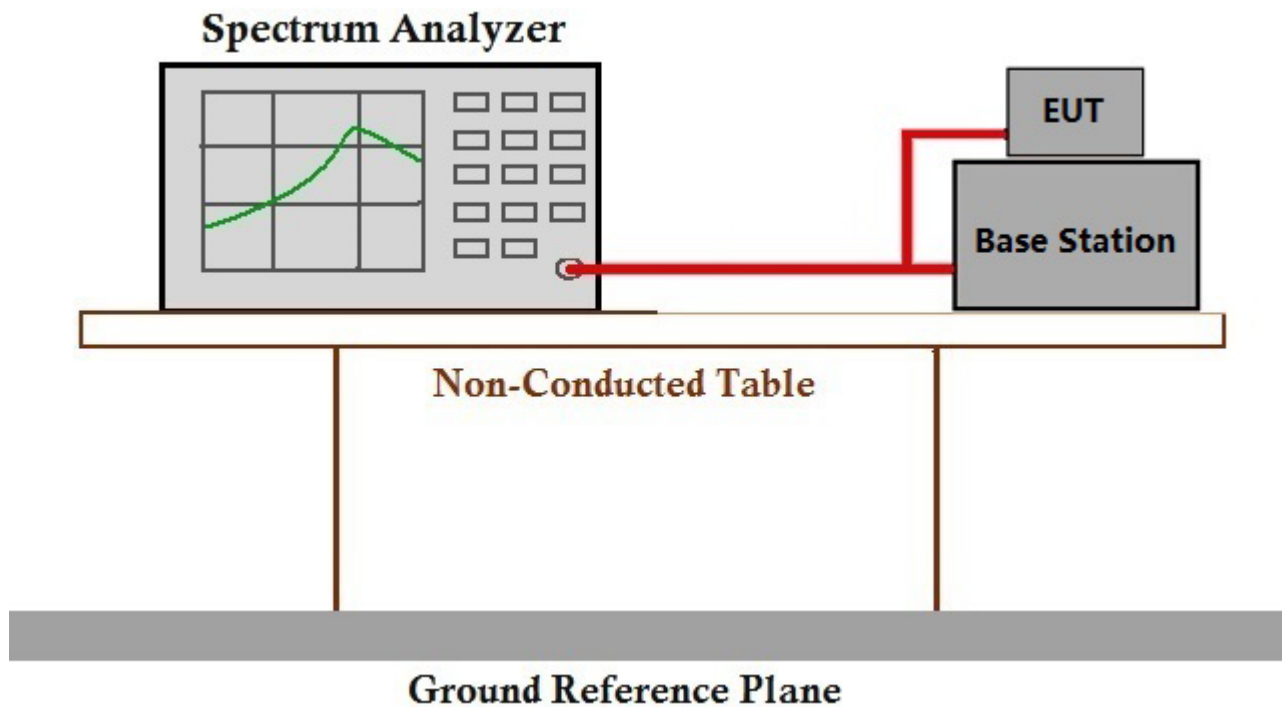

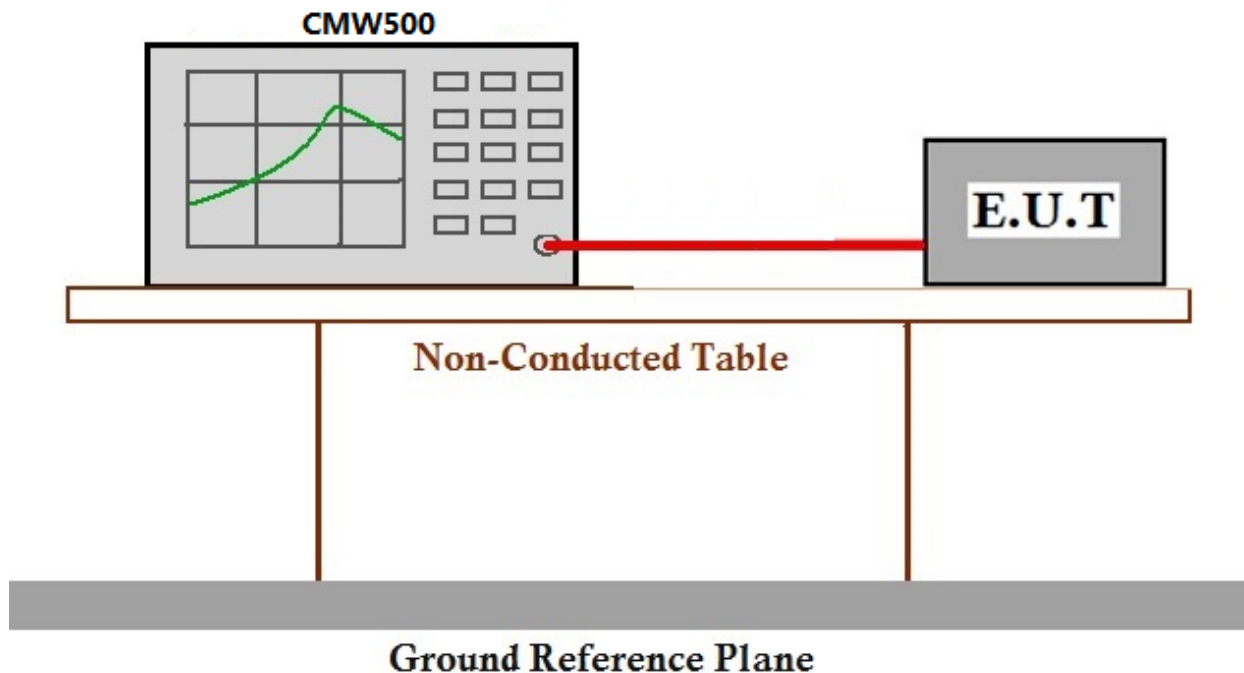
