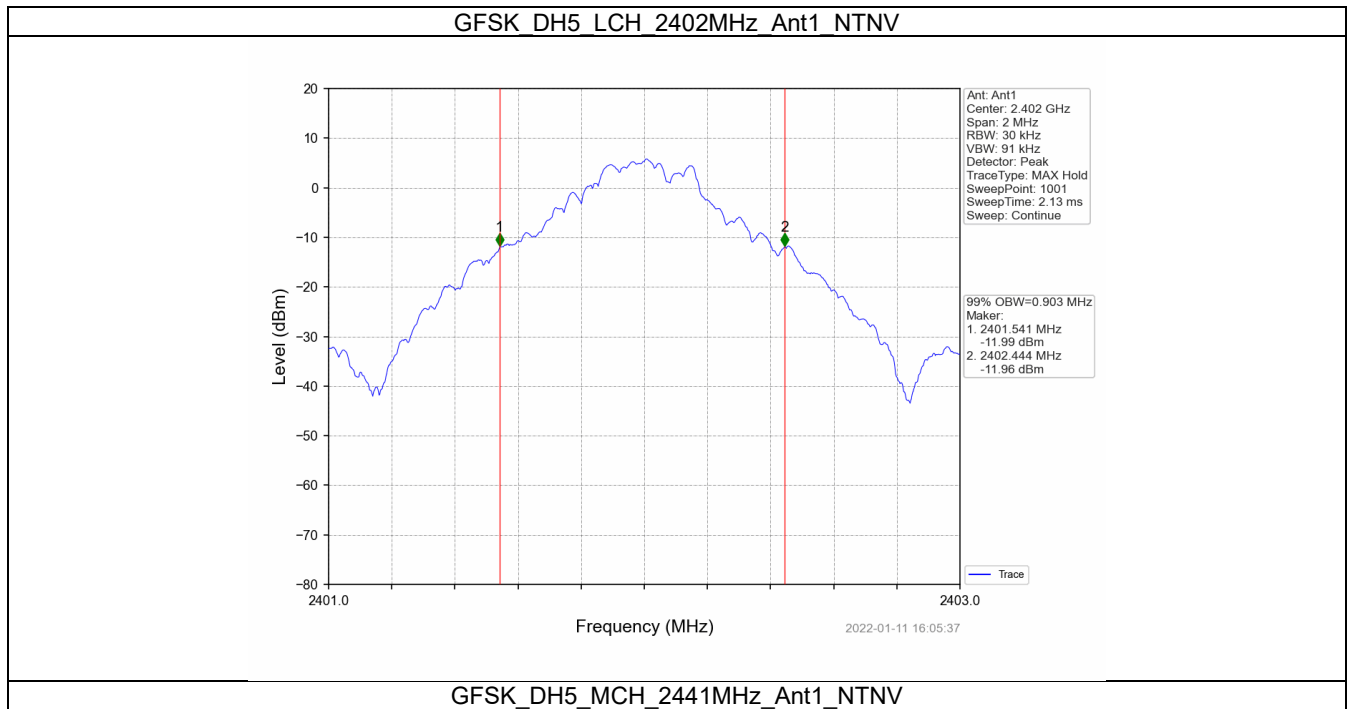

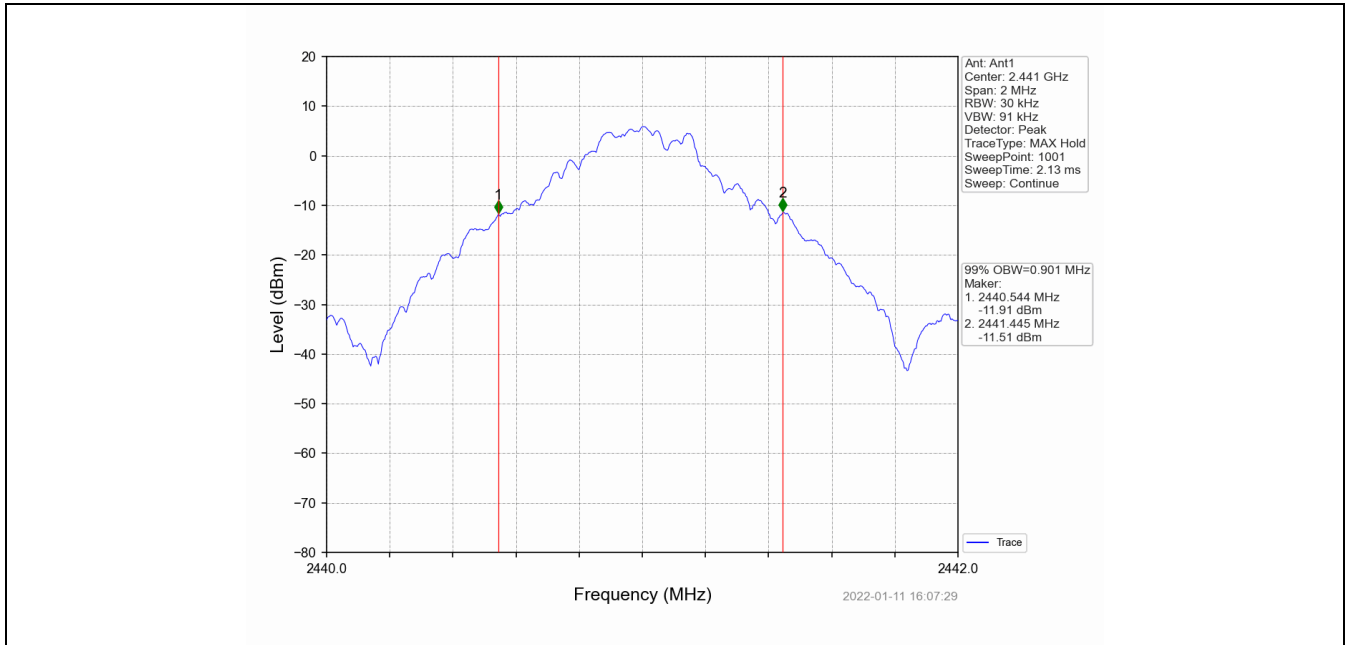

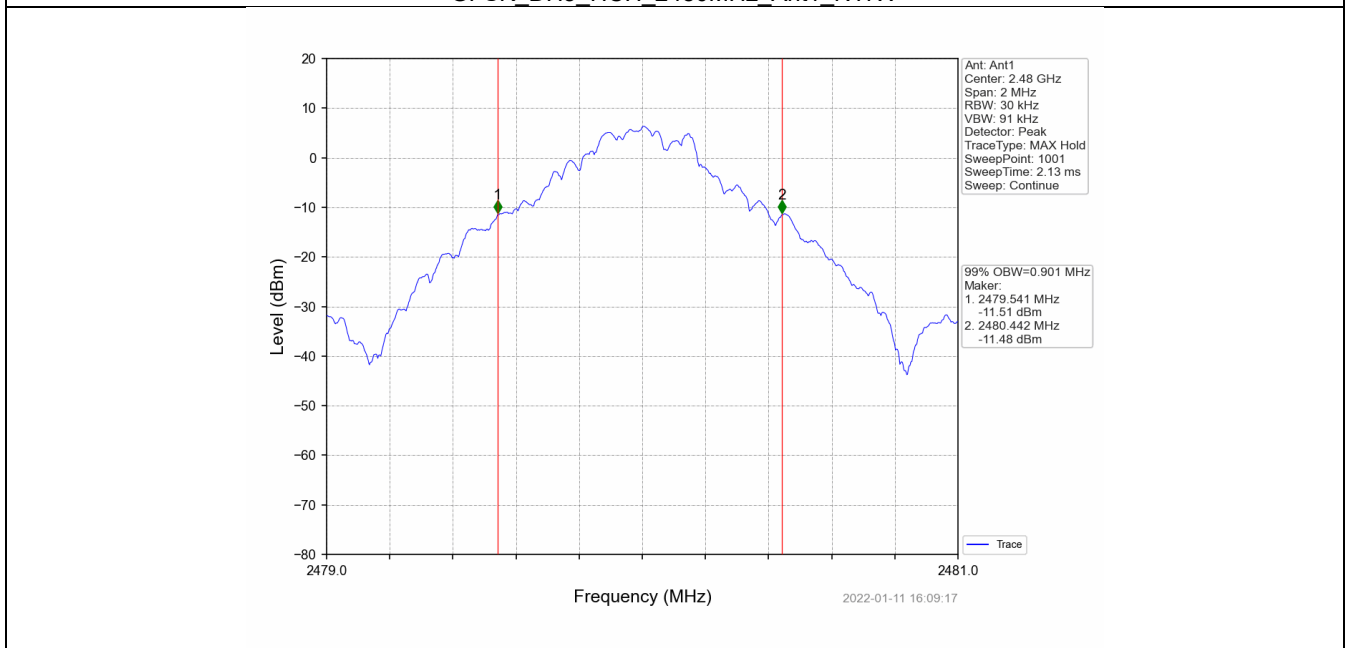

GFSK DH5 HCH 2480MHz Ant1 NTN

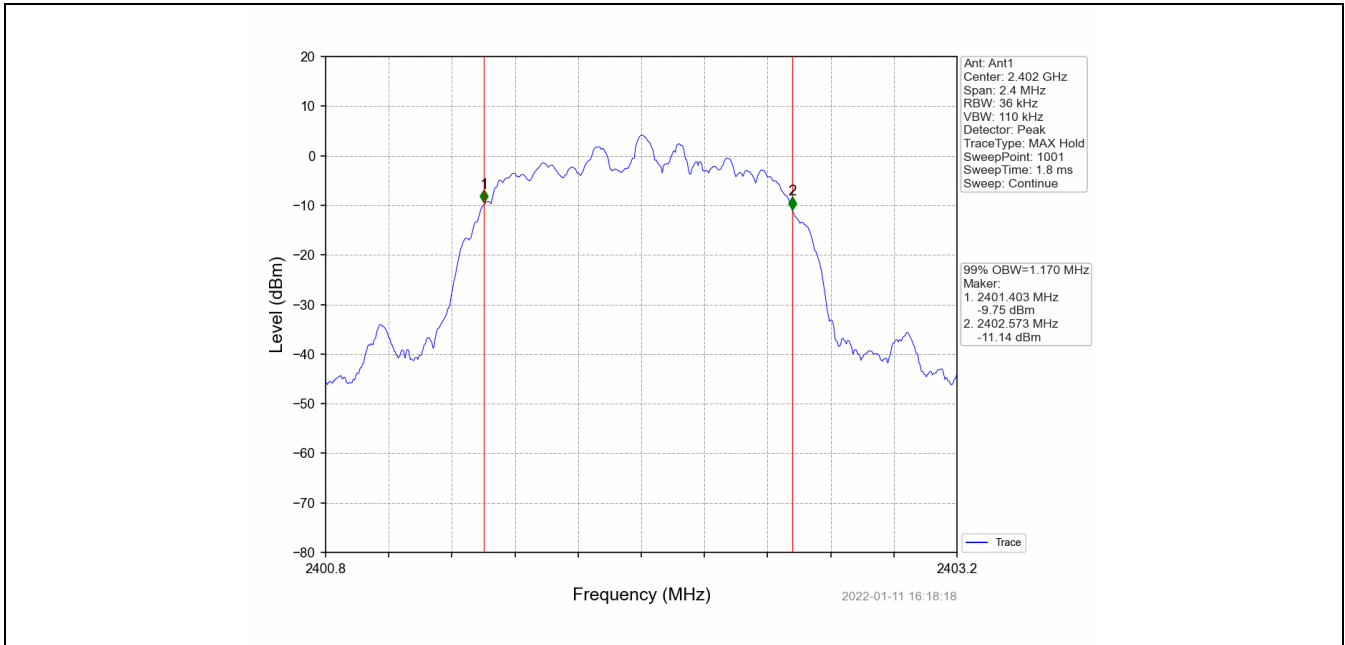


Pi/4DQPSK 2DH5 LCH 2402MHz Ant1 NTN

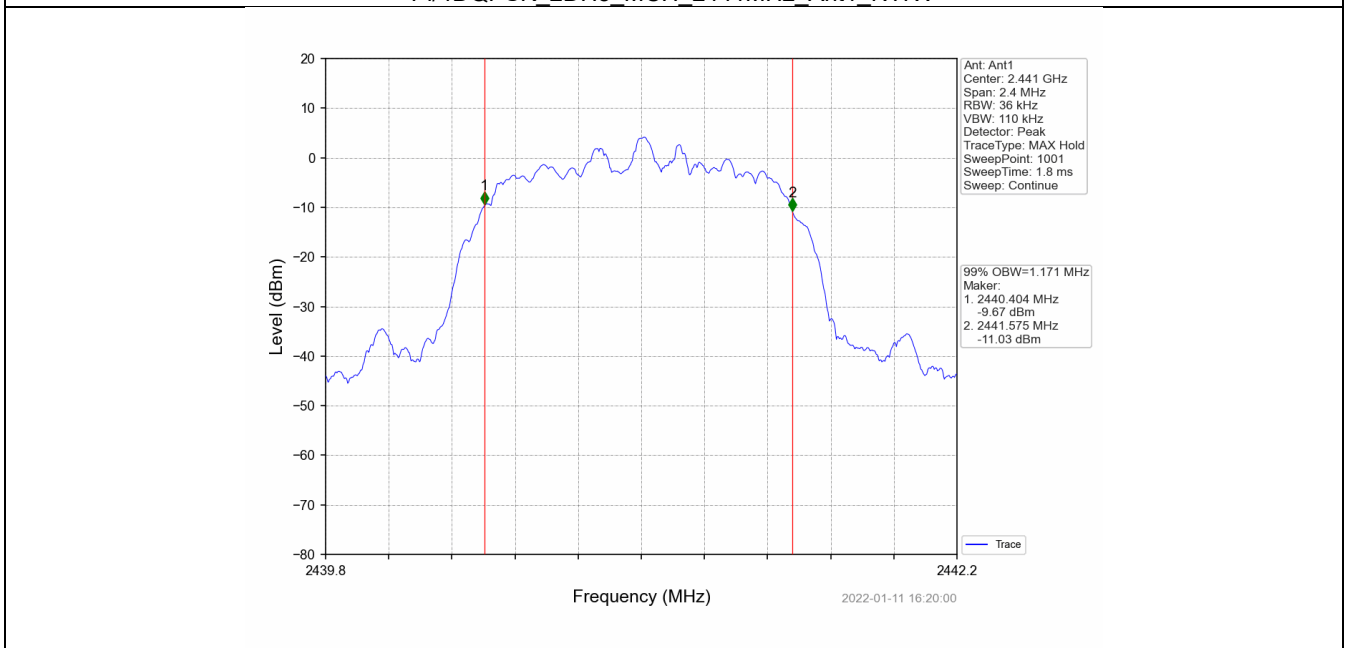

Pi/4DQPSK 2DH5 MCH 2441MHz Ant1 NTN

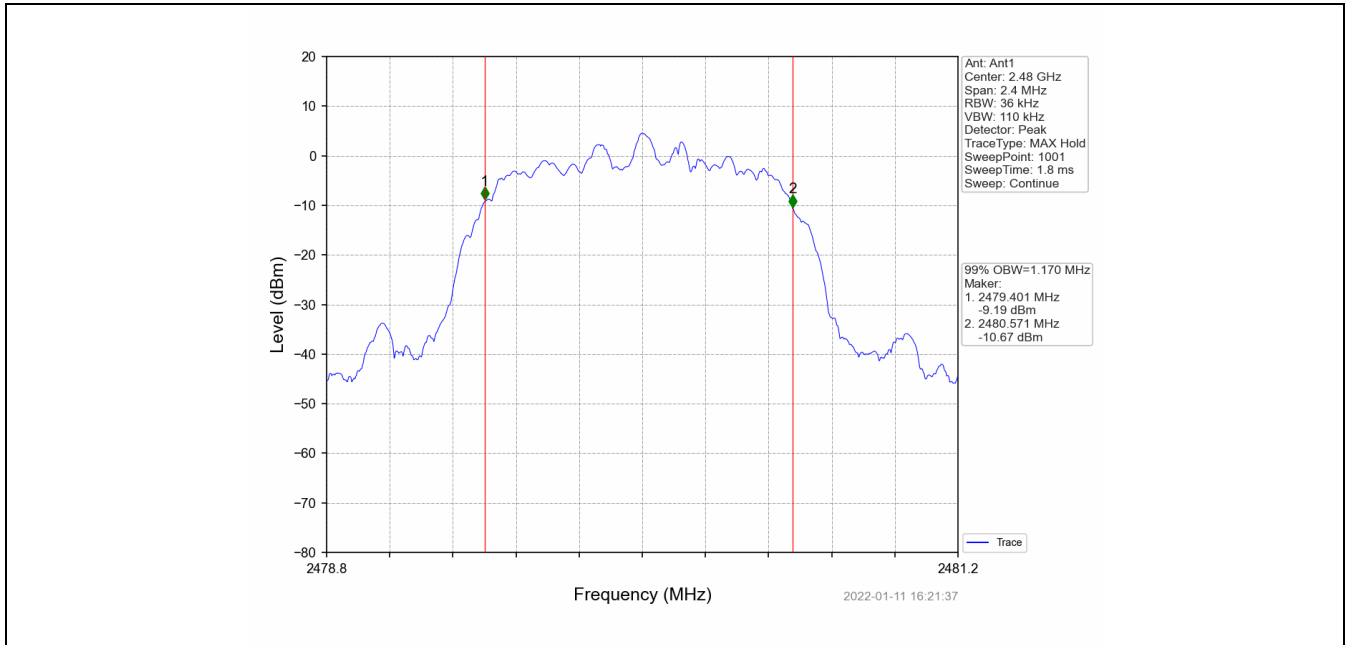


Pi/4DQPSK 2DH5 HCH 2480MHz Ant1 NTN

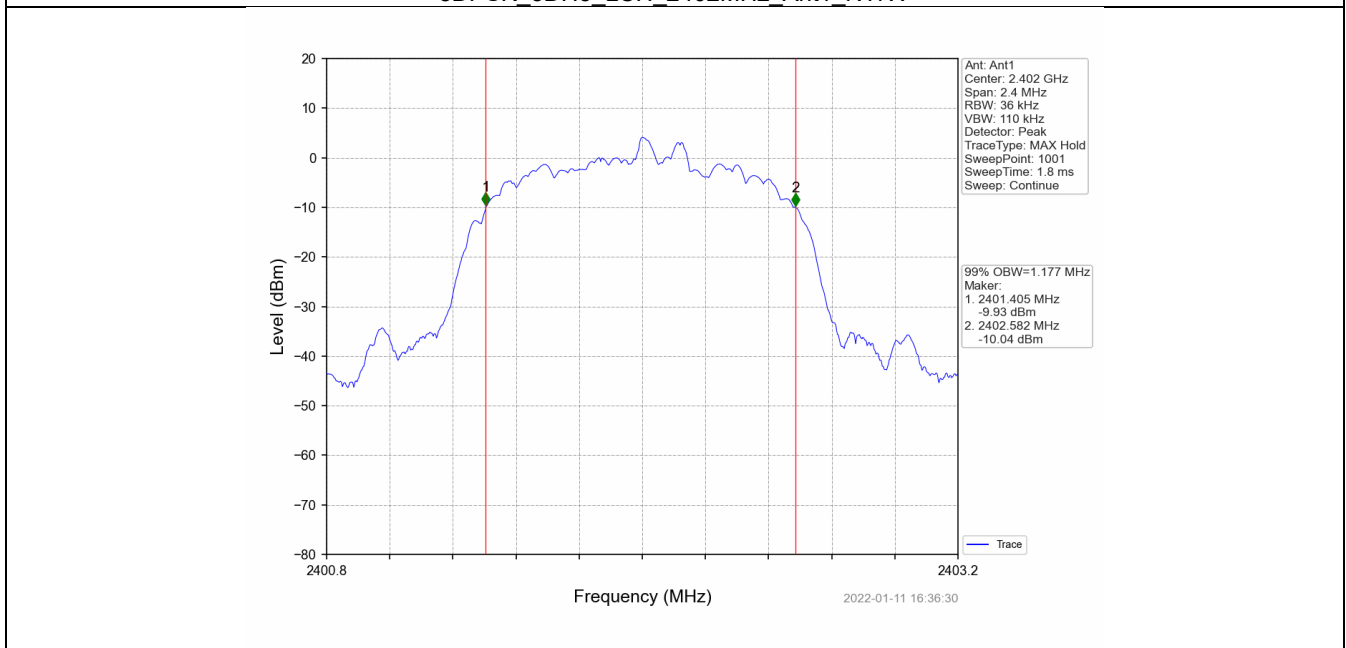

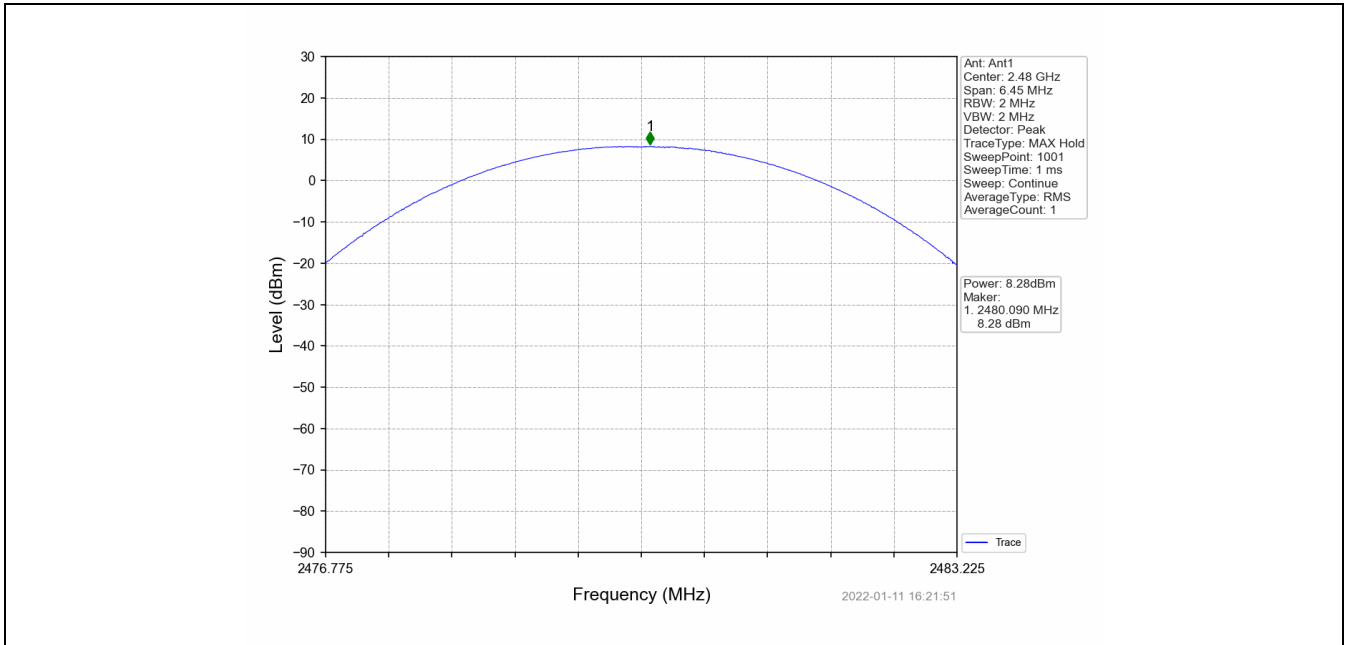


Pi/4DQPSK 2DH5 HCH 2480MHz Ant1 NTN

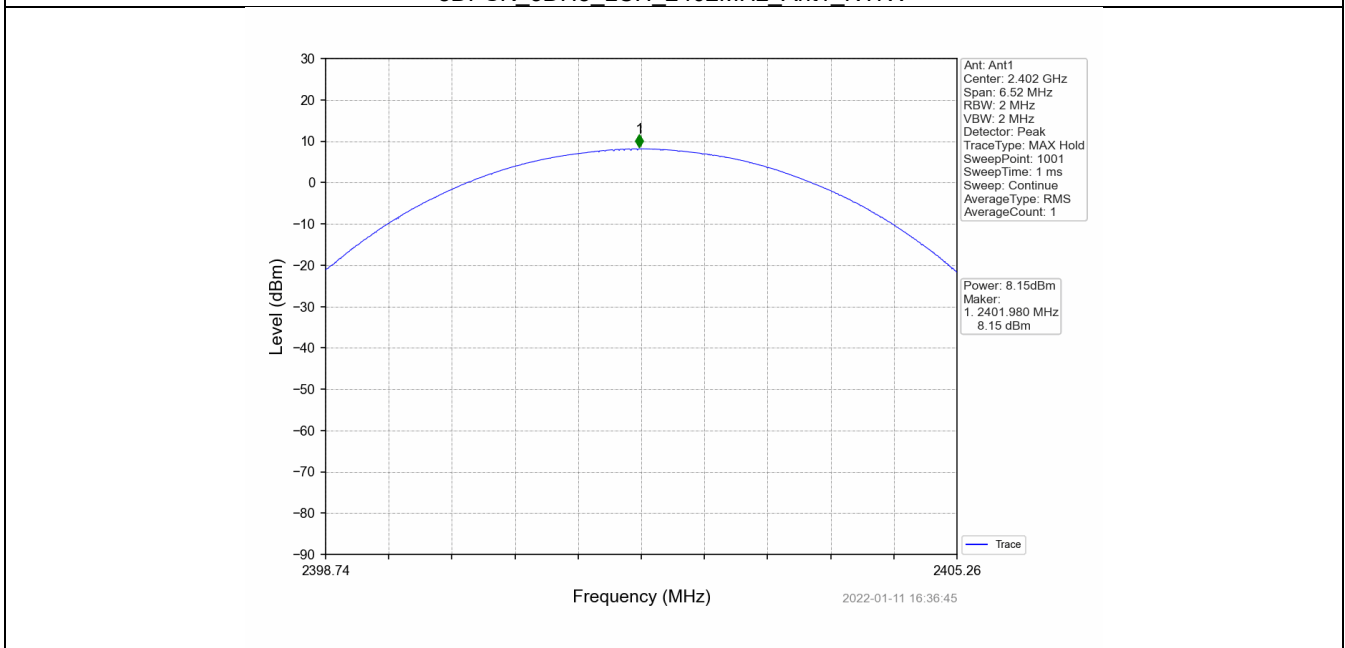
