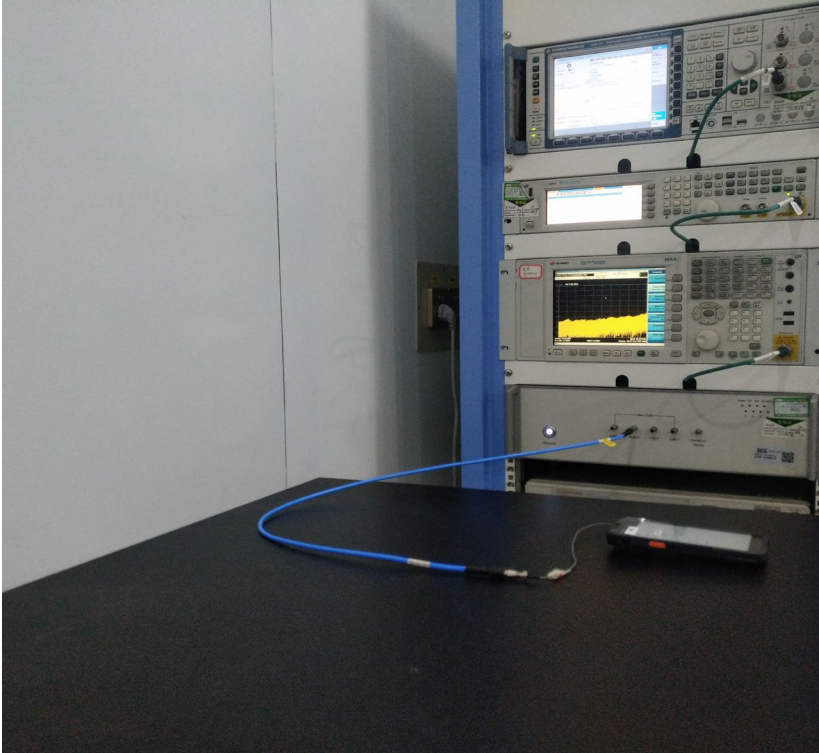

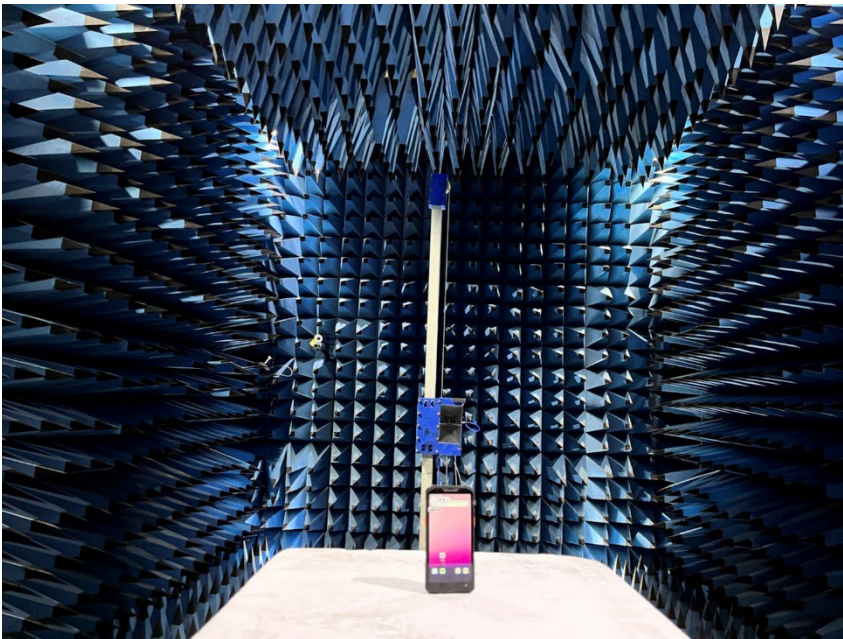

### Radiated Emissions 30MHz - 1GHz

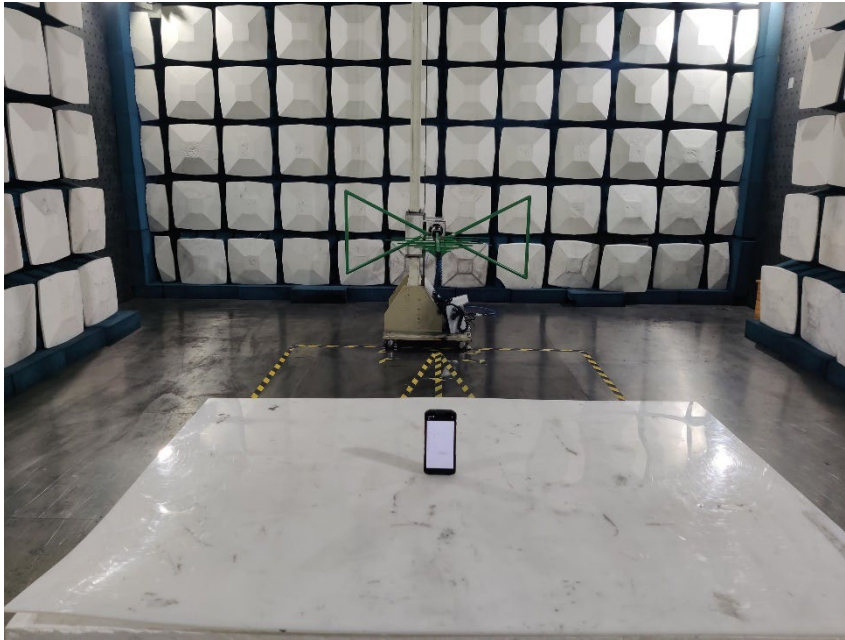

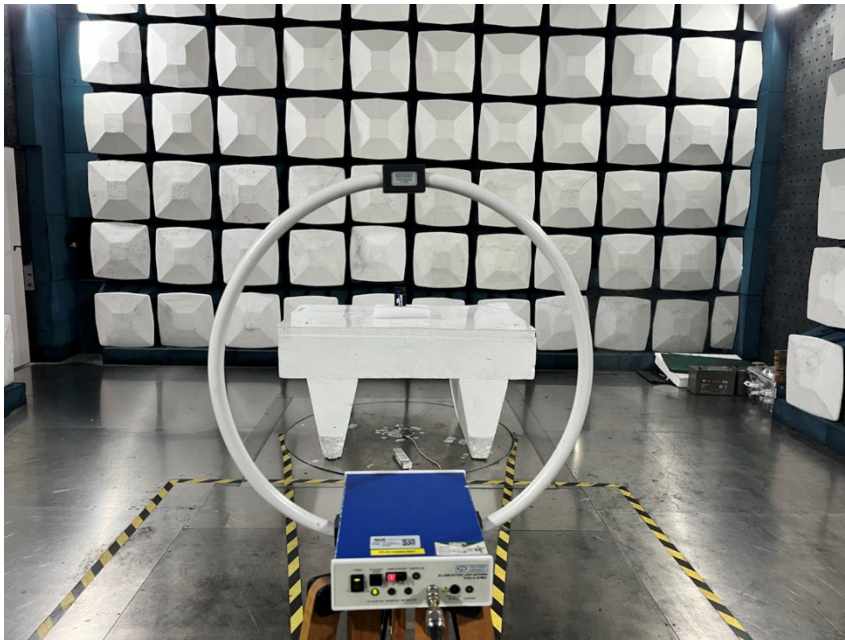

### Radiated Emissions Below 30MHz



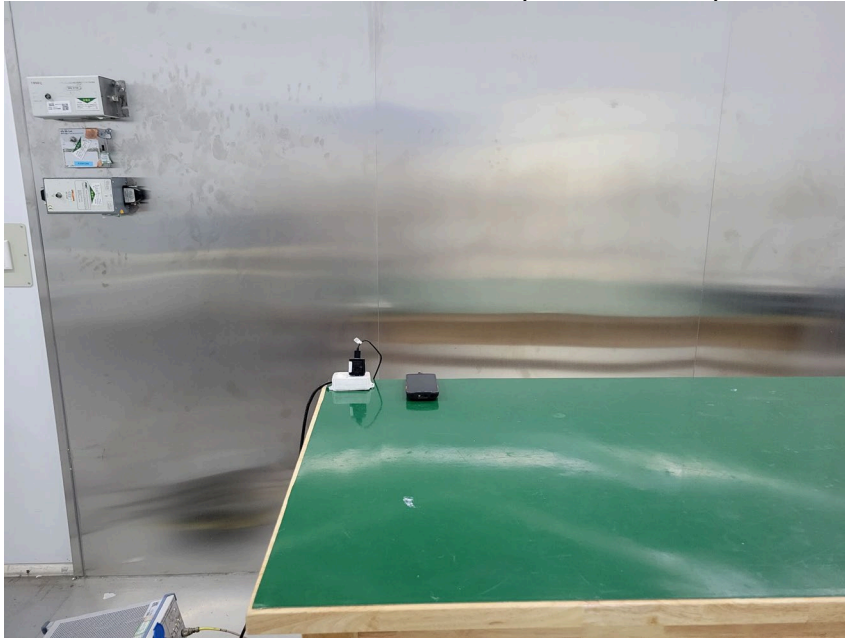
