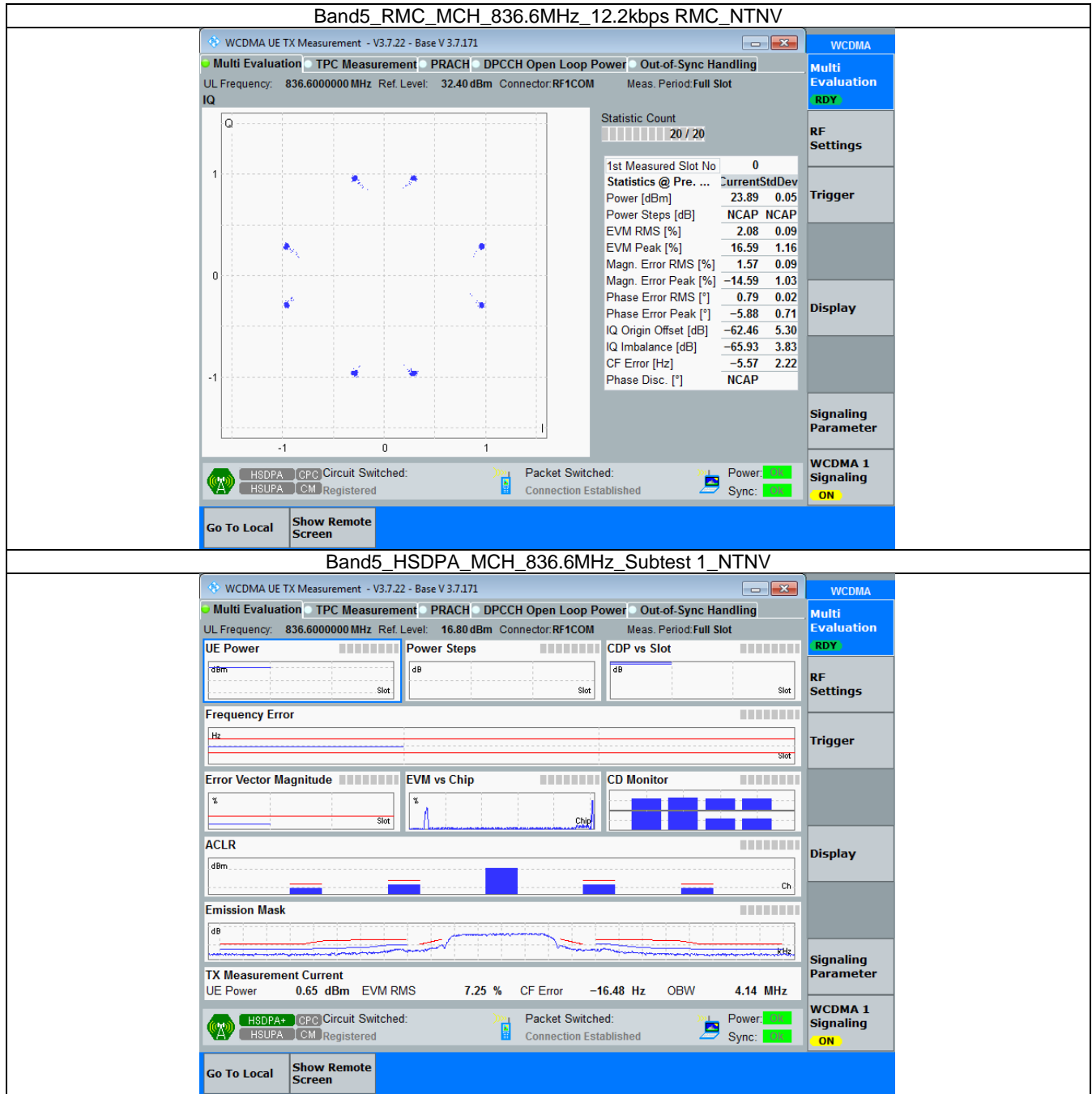

3.1.2 Test Graph

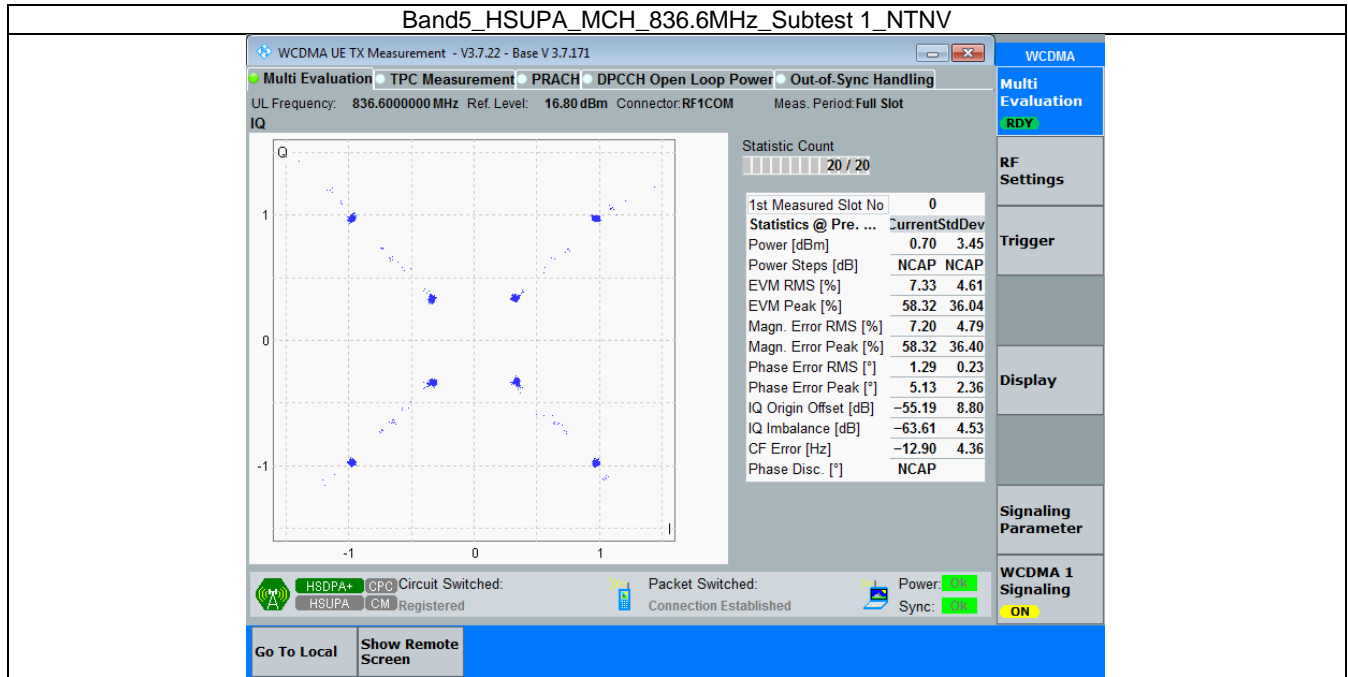

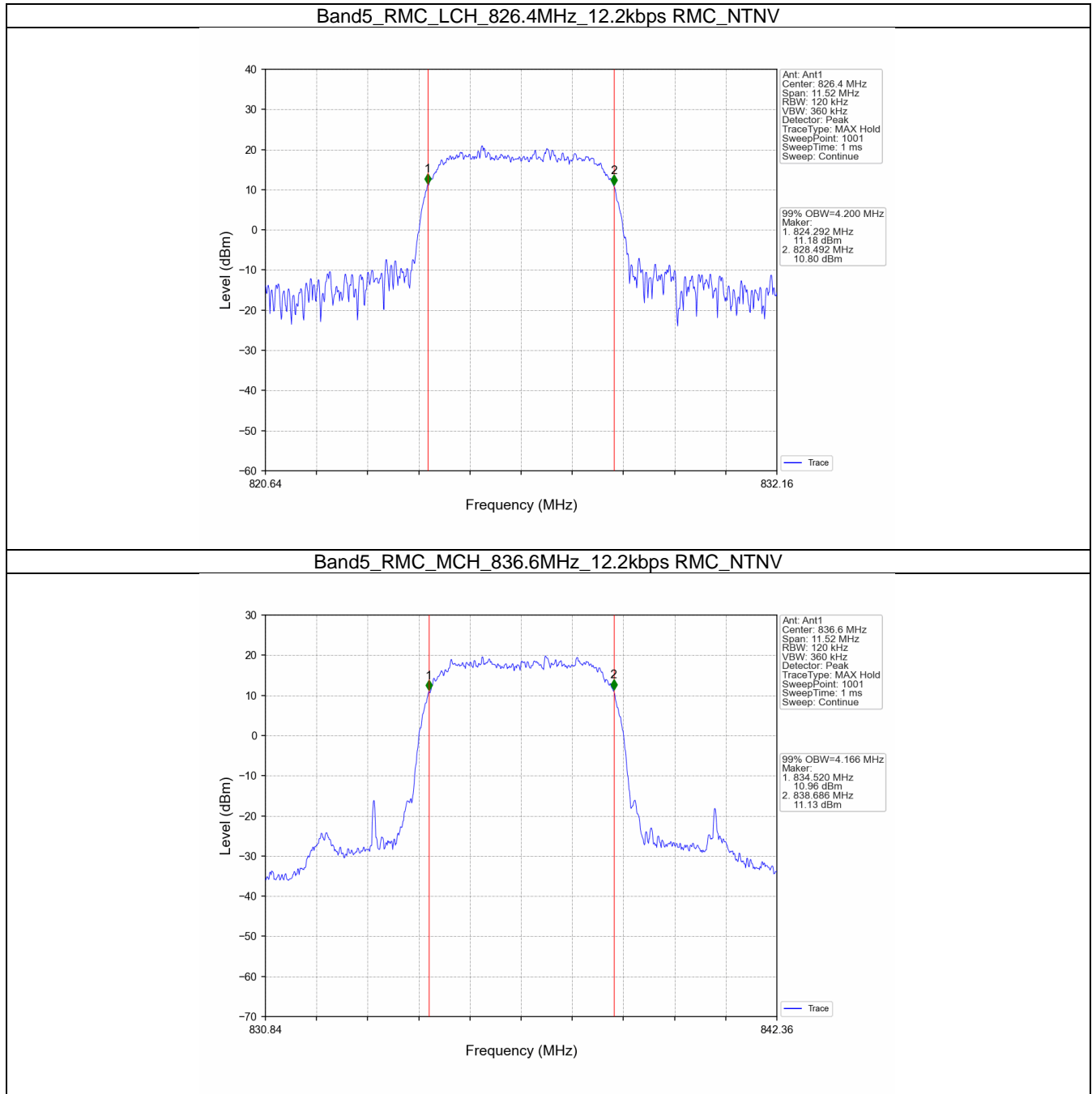

4.1.2 Test Graph



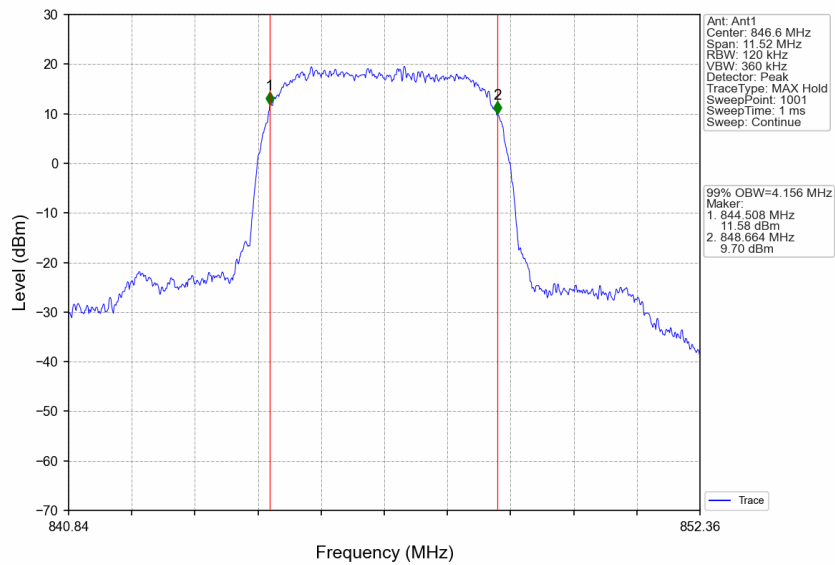

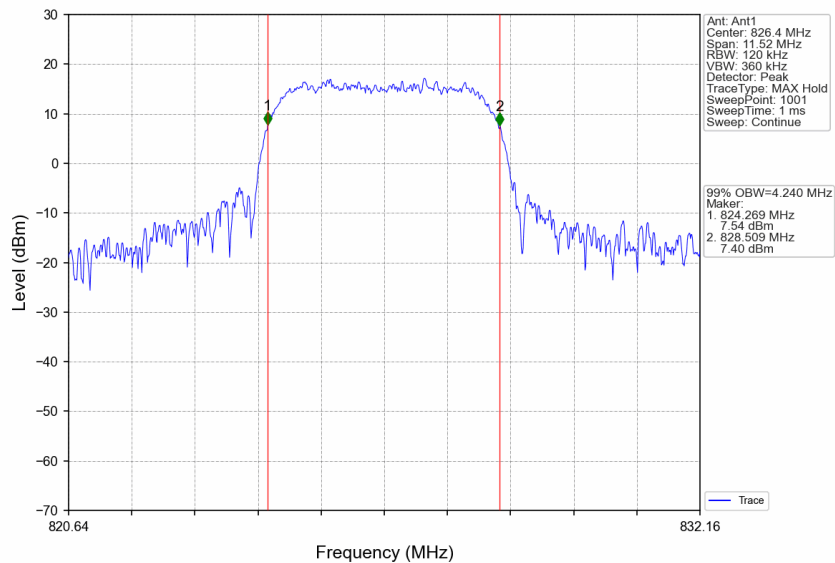

Band5_HSDPA_LCH_826.4MHz_Subtest 1_NTNV



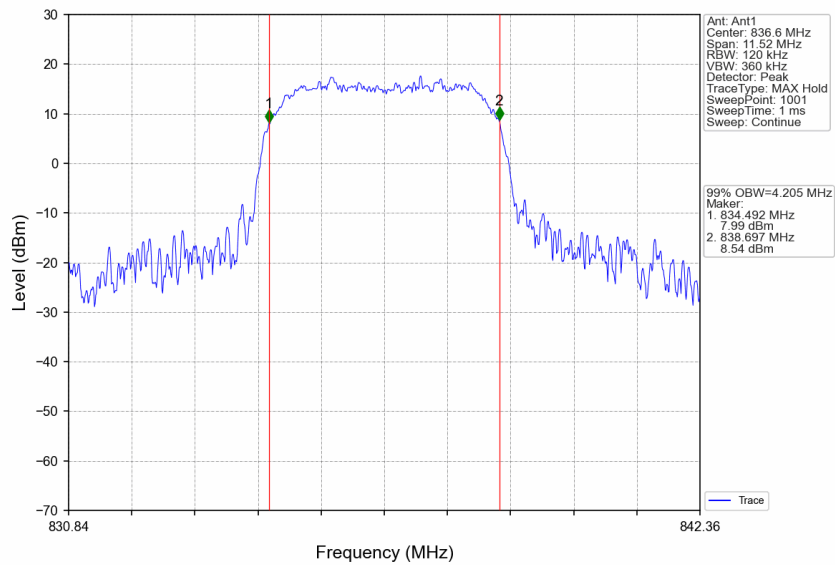
