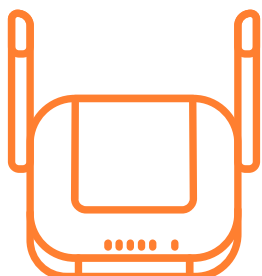

Optional: Plug in the Ethernet cable. After a few minutes, the light on the hub will turn solid blue, indicating the hub is online.
