1. This report is issued as a supplementary report of BV CPS report no.: RFBGGV-WTW-P21120247-3. The differences compared with the original report are reducing power setting and changing internal antenna 1 from 3.5 dBi to 3.03 dBi gain and antenna 2 from 3.5 dBi to 2.6 dBi gain. The output power is lowered via firmware/software settings only (and cannot be changed by end-user / any other third parties). Therefore, only antenna port conducted measurement tests were verified and recorded in this report.







- c. Trace mode = max hold.
- d. Sweep = auto couple.
- e. Measure the maximum width of the emission that is constrained by the frequencies associated with the two amplitude points (upper and lower) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.



Average power sensor was used to perform output power measurement, trigger and gating function of wide band power meter is enabled to measure max output power of TX on burst. Duty factor is not added to measured value.




4.4.7 Test Results
