1- Carga tu nueva Xtreme “Wireless Audio Receiver” totalmente por el puerto que conecta a un cargador USB mediante el cable micro USB incluido por un mínimo de 3 horas

2- Encienda pulsando el botón multifunción (MFB) hasta que el indicador led parpadea en rojo y azul). {enchufe a los auriculares o entrada estéreo en el conector . puede utilizar el adaptador imcluido, según sea necesario

3- Unidad entrará en el modo de emparejamiento. Activar el modo de búsqueda Bluetooth en su dispositivo de audio y buscar el nombre de emparejamiento “XBA9-1007” y seleccione en el dispositivo de audio. Una vez “XT Audio Plug” está conectado, el indicador LED dejará de parpadear y permanecerá azul

1- Charge your new Xtreme “Wireless Audio Receiver” fully by connecting port to a USB charger via the included micro USB cable for a minimum of 3 hours

2- Turn on by pressing the multifunction button (MFB) until led indicator flashes red and Blue). {plug in headphone or stereo input into jack. you can use the include adapter as needed

3- Unit will enter pairing mode. Enable Bluetooth search mode on your audio device and search for pairing name “XBA9-1007” and select it on your audio device. Once XT Audio Plug is connected , the led indicator will slowly flash blue.

The unit will automatically switch to phone mode when receiving calls and will switch back to music mode when call is finished
