The mikme pocket is designed for capturing studio quality sound and transmitting it via Bluetooth to your smartphone. This device is protected against splash water and dust, and may be used outdoors. However, you should not submerge your mikme pocket in water or expose it to heavy rain. Only use this device as described in the user manual. Any other use will be deemed as not in accordance with the instructions and may lead to physical damage and or injury of persons. The manufacturer accepts no liability of damage caused by improper use. Before operating the mikme pocket please first read the safety notes and user manual carefully.
