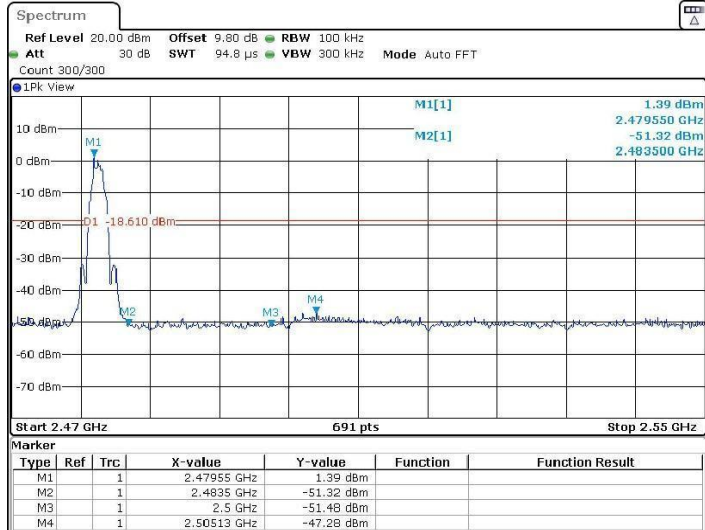


BLE 2M Ant1 Low 2402





BLE 2M Ant1 High 2480



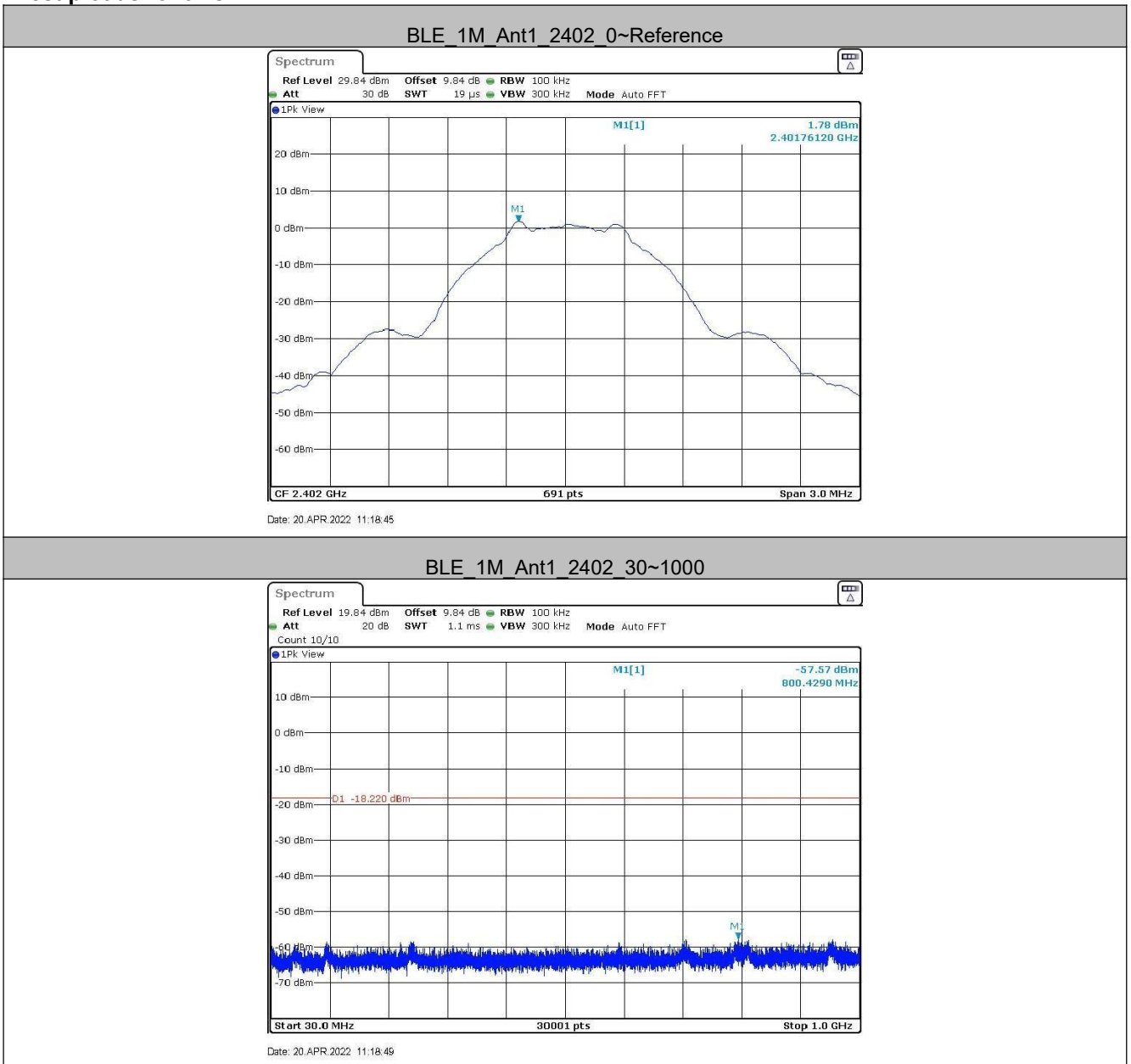

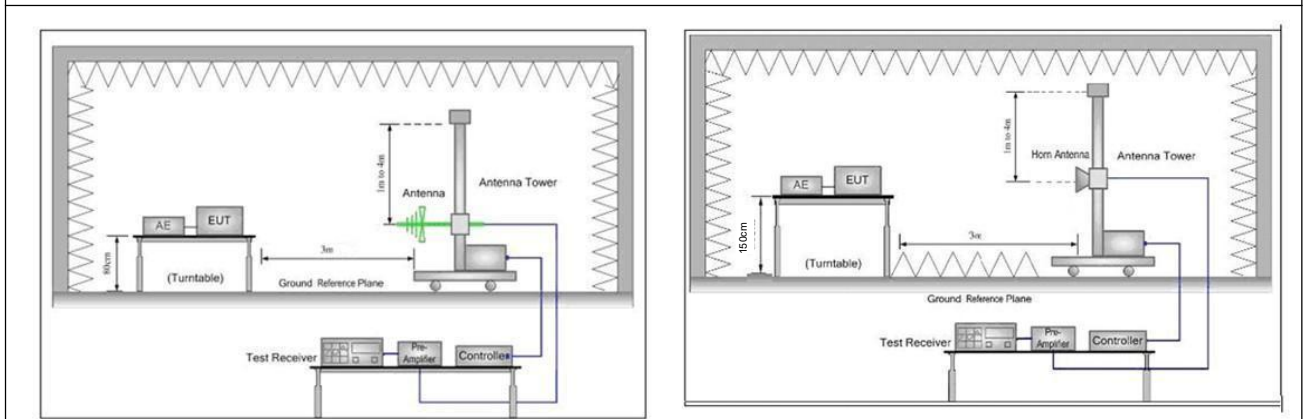
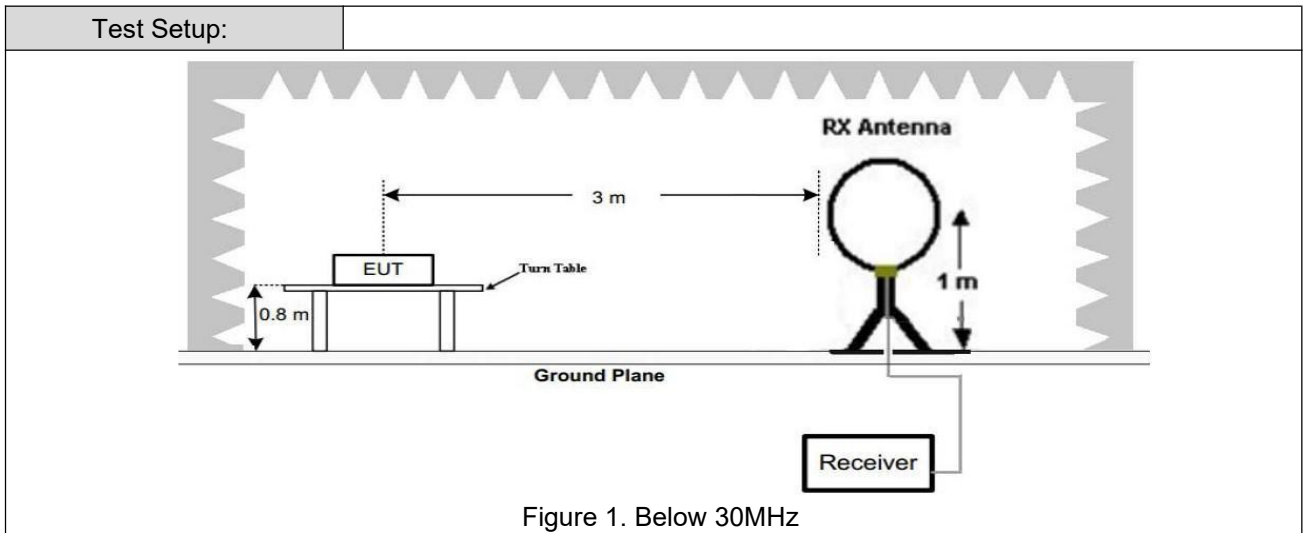


Figure 2. 30MHz to 1GHz

Figure 3. Above 1 GHz

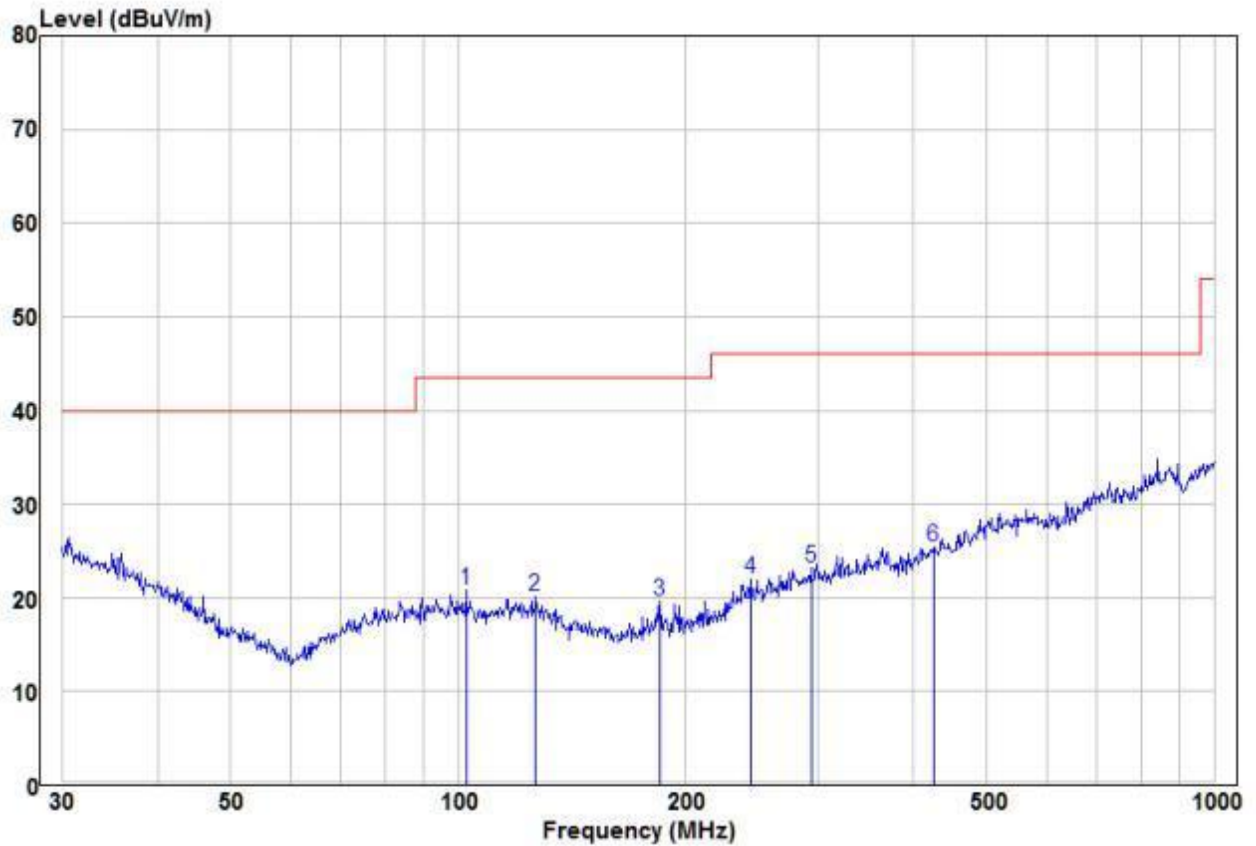

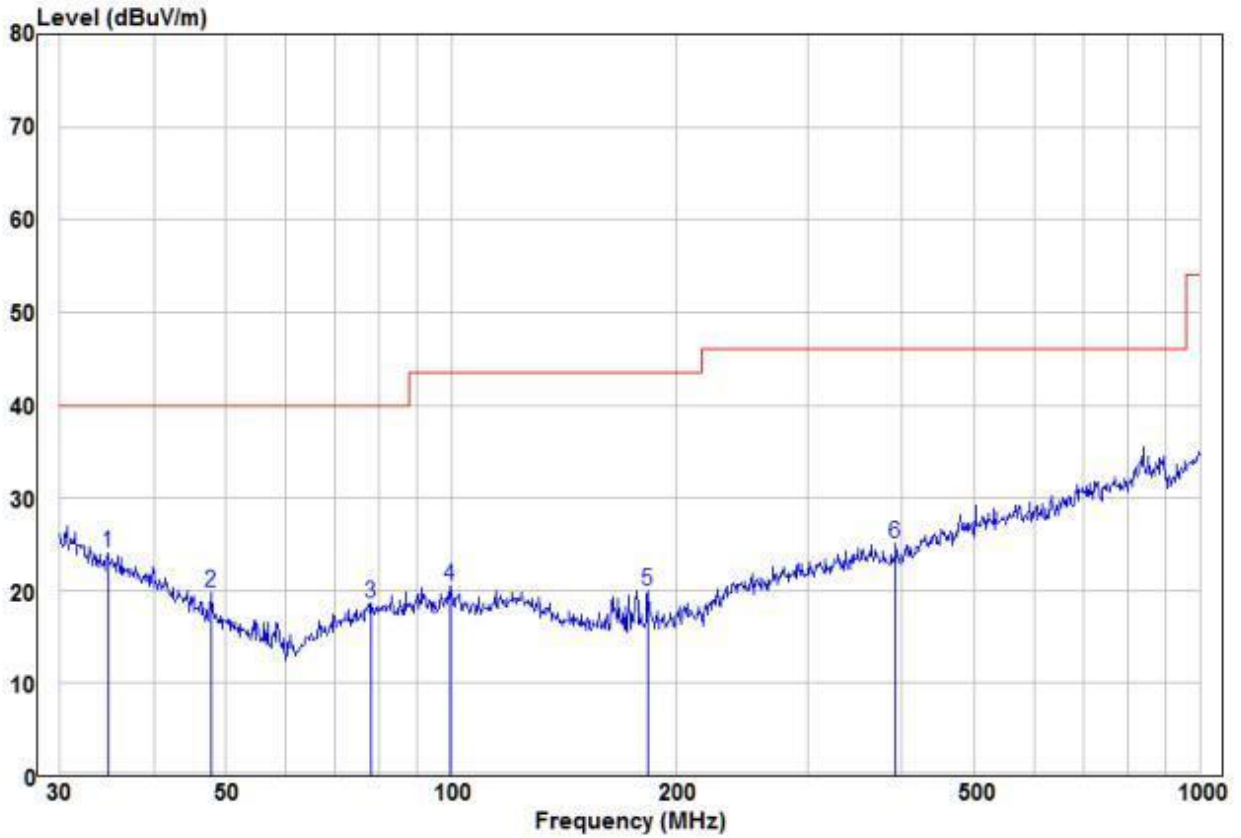

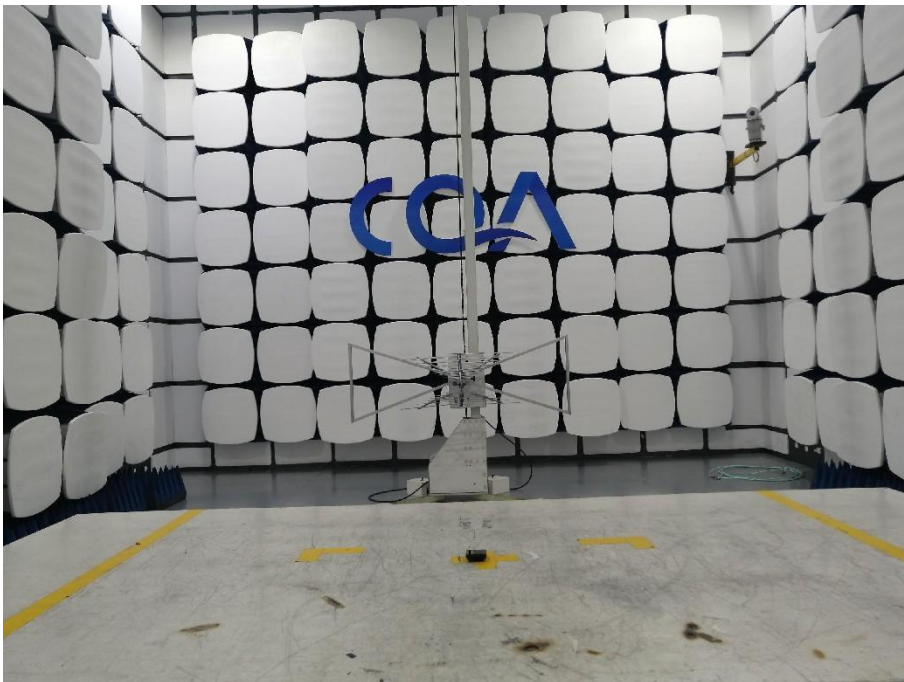
