

### 15.247(b) (4) requirement:

Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

### EUT Antenna:

The antenna is attached on the intentional radiator and no consideration of replacement. The best case gain of the antenna is -3.81dBi.







Final Test Level =Receiver Reading + Antenna Factor + Cable Factor - Preamplifier Factor

- 3) Scan from 9kHz to 25GHz, the disturbance above 18GHz and below 30MHz was very low. The points marked on above plots are the highest emissions could be found when testing, so only above points had been displayed. The amplitude of spurious emissions from the radiator which are attenuated more than 20dB below the limit need not be reported.
- 4) For frequencies above 1GHz, the field strength limits are based on average limits. However, the peak field strength of any emission shall not exceed the maximum permitted average limits specified above by more than 20 dB under any condition of modulation. #### 8.2 Radiated Spurious Emissions Test Setup


