
# TRANSFORMER CAR INSTRUCTIONS

## USE 3X1.5V "AA" BATTERIES (NOT INCLUDED)

- 1.Put 3"AA" size batteries into the car and 2 "AA" size batteries into the remote control as pictured.
- 2.Turn the red switch on the bottom of the car to "NO".
- 3. Forward: Use the left joystick forward, the right joystick left, and operate at the same time.

Backward: Use the left rocker is backward and the right rocker is right.

Turn left:Use right rocker left operation.


Turn right: Use operate the left rocker forward.

Rotate right in place: Use left joystick forward, right joystick right, and operate simultaneously.

Left rotation: Use left joystick backward, right joystick left, simultaneous operation.
