2.1. TEST STANDARDS

The tests were performed according to following standards:

2.2. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

2.3. EUT Exercise

The EUT has been tested under typical operating condition and The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.

2.4. General Test Procedures

2.4.1 Conducted Emissions

2.4.2 Radiated Emissions

The EUT is placed on a turntable, which is directly placed on the ground. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2013



5. MEASUREMENT RESULTS

- 5.1. Maximum Transmitter Power
- 5.1.1 Block Diagram of Test Setup



5.1.2 Limit

According to FCC Part 95.567:

Each FRS transmitter type must be designed such that the effective radiated power (ERP) on channels 8 through 14 does not exceed 0.5 Watts and the ERP on channels 1 through 7 and 15 through 22 does not exceed 2.0 Watts.

5.1.3 Test Procedure

- 1. EUT was placed on a 1.5meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The height of receiving antenna is 1.5m. Detected emissions were maximized at each frequency by rotating the EUT through 360° and adjusting the receiving antenna polarization. The radiated emission measurements of all test transmit frequencies were measured with peak detector.
- 2. A log-periodic antenna or double-ridged waveguide horn antenna shall be substituted in place of the EUT. The log-periodic antenna will be driven by a signal generator and the level will be adjusted till the same power value on the spectrum analyzer or receiver. The level of the spurious emissions can be calculated through the level of the signal generator, cable loss, the gain of the substitution antenna

- and the reading of the spectrum analyzer or receiver.
- 3. The EUT is then put into continuously transmitting mode at its maximum power level during the test. Set Test Receiver or Spectrum RBW=1MHz, VBW=3MHz, and the maximum value of the receiver should be recorded as (P_r).
- 4. The EUT shall be replaced by a substitution antenna. In the chamber, a substitution antenna for the frequency band of interest is placed at the reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (P_{Mea}) is applied to the input of the substitution antenna, and adjust the level of the signal generator output until the value of the receiver reach the previously recorded (P_r). The power of signal source (P_{Mea}) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.
- 5. An amplifier may be connected to the Signal Source output port. And the cable should be connect between the Amplifier and the Substitution Antenna. The cable loss (Pcl), the Substitution Antenna Gain (Ga) and the Amplifier Gain (PAg) should be recorded after test.

The measurement results are obtained as described below:

Power (EIRP) = $P_{Mea} + P_{Ag} - P_{cl} + G_a$

- 6. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15dBi) and known input power.
- 7. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP-2.15dBi.

5.2. Occupied Bandwidth and Emission Mask

5.2.1 Limit

According to FCC 95.573:


Each FRS transmitter type must be designed such that the occupied bandwidth does not exceed 12.5kHz.

According to FCC 95.579:

Attenuation requirements. The power of unwanted emissions must be attenuated below the carrier power output in Watts (P) by at least:

- (1) 25 dB (decibels) in the frequency band 6.25 kHz to 12.5 kHz removed from the channel center frequency.
- (2) 35 dB in the frequency band 12.5 kHz to 31.25 kHz removed from the channel center frequency.
- (3) 43 + 10 log (P) dB in any frequency band removed from the channel center frequency by more than 31.25 kHz.

5.2.2 Block Diagram of Test Setup



5.2.3 Test Procedure

- 1. The EUT was modulated by 2.5 KHz Sine wave audio signal; the level of the audio signal employed is 16 dB greater than that necessary to produce 50% of rated system deviation. Rated system deviation is 2.5 kHz (12.5 kHz channel spacing) and 5 kHz (25 kHz channel spacing).
- 2. Set SPA Center Frequency = fundamental frequency, RBW=300Hz, VBW= 3 KHz, span =50 KHz.
- 3. Set SPA Max hold. Mark peak, Set 99% Occupied Bandwidth and 26dB Occupied Bandwidth.






Test Plot of Occupied Bandwidth and Emission Mask









Channel 4: 462.6375MHz

5.3. Modulation Characteristic


5.3.1 Limit

According to CFR47 section 2.1047(a), for Voice Modulation Communication Equipment, the frequency response of the audio modulation circuit over a range of 100 to 5000Hz shall be measured.

According to FCC 95.575:

Each FRS transmitter type must be designed such that the peak frequency deviation does not exceed 2.5 kHz, and the highest audio frequency contributing substantially to modulation must not exceed 3.125 kHz.

5.3.2 Block Diagram of Test Setup



5.3.3 Test Procedure

Modulation Limit

- 1. Configure the EUT as shown in clause 5.3.2, adjust the audio input for 60% of rated system deviation at 1KHz using this level as a reference (0dB) and vary the input level from –20 to +20dB. Record the frequency deviation obtained as a function of the input level.
- 2. Repeat step 1 with input frequency changing to 300, 1004, 1500 and 2500Hz in sequence.


- 1. Configure the EUT as shown in clause 5.3.2.
- 2. Adjust the audio input for 20% of rated system deviation at 1 KHz using this level as a reference (0dB).
- 3. Vary the Audio frequency from 100 Hz to 3 KHz and record the frequency deviation.
- 4. Audio Frequency Response =20log₁₀ (Deviation of test frequency/Deviation of 1 KHz reference).






5.4. Frequency Stability

5.4.1 Limit

According to FCC 95.565

Each FRS transmitter type must be designed such that the carrier frequencies remain within ±2.5 parts-per-million of the channel center frequencies specified in §95.563 during normal operating conditions.

5.4.2 Block Diagram of Test Setup



5.4.3 Test Procedure

The EUT was set in the climate chamber and connected to an external DC power supply. The RF output was directly connected to Spectrum Analyzer. The coupling loss of the additional cables was recorded and taken in account for all the measurements. After temperature stabilization (approx. 20 min for each stage), the frequency for the lower, the middle and the highest frequency range was recorded. For Frequency stability Vs. Voltage the EUT was connected to a DC power supply and the voltage was adjusted in the required ranges. The result was recorded.



5.5. Transmitter Radiated Spurious Emission

5.5.1 Limit

According to FCC section 95.579, At least 43 + 10 log (Transmit Power) dB on any frequency band removed from the channel center frequency by more than 31.25 kHz.

5.5.3 Test Procedure

- a. EUT was placed on a 1.5 meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The height of receiving antenna is 1.5m. Detected emissions were maximized at each frequency by rotating the EUT through 360° and adjusting the receiving antenna polarization. The radiated emission measurements of all test transmit frequencies were measured with peak detector.
- b. A log-periodic antenna or double-ridged waveguide horn antenna shall be substituted in place of the EUT. The log-periodic antenna will be driven by a signal generator and the level will be adjusted till the same power value on the spectrum analyzer or receiver. The level of the spurious emissions can be calculated through the level of the signal generator, cable loss, the gain of the substitution antenna and the reading of the spectrum analyzer or receiver.
- c. The EUT is then put into continuously transmitting mode at its maximum power level during the test. Set Test Receiver or Spectrum 100 kHz below 1GHz and 1MHz above 1GHz, Sweep from 30MHz to

the 10th harmonic of the fundamental frequency; and recorded the level of the concerned spurious emission point as (P_r).

d. The EUT then replaced by a substitution antenna. In the chamber, a substitution antenna for the frequency band of interest is placed at the reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (P_{Mea}) is applied to the input of the substitution antenna, and adjust the level of the signal generator output until the value of the receiver reach the previously recorded (P_r). The power of signal source (P_{Mea}) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization. The measurement results are obtained as described below:

Power (EIRP) = $P_{Mea} - P_{cl} + G_a$

Where:

P_{Mea} is the recorded signal generator level

Pcl is the cable loss connect between instruments

Ga Substitution Antenna Gain

- e. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15dBi) and known input power.
- f. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP -2.15dBi.
- g. Test site anechoic chamber refer to ANSI C63.10.
