Objective

This test report is in accordance with Part 2, Subpart J, and Part 15, Subparts A and C of the Federal Communications Commission's rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

All emissions measurement was performed at Shenzhen Accurate Technology Co., Ltd. The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

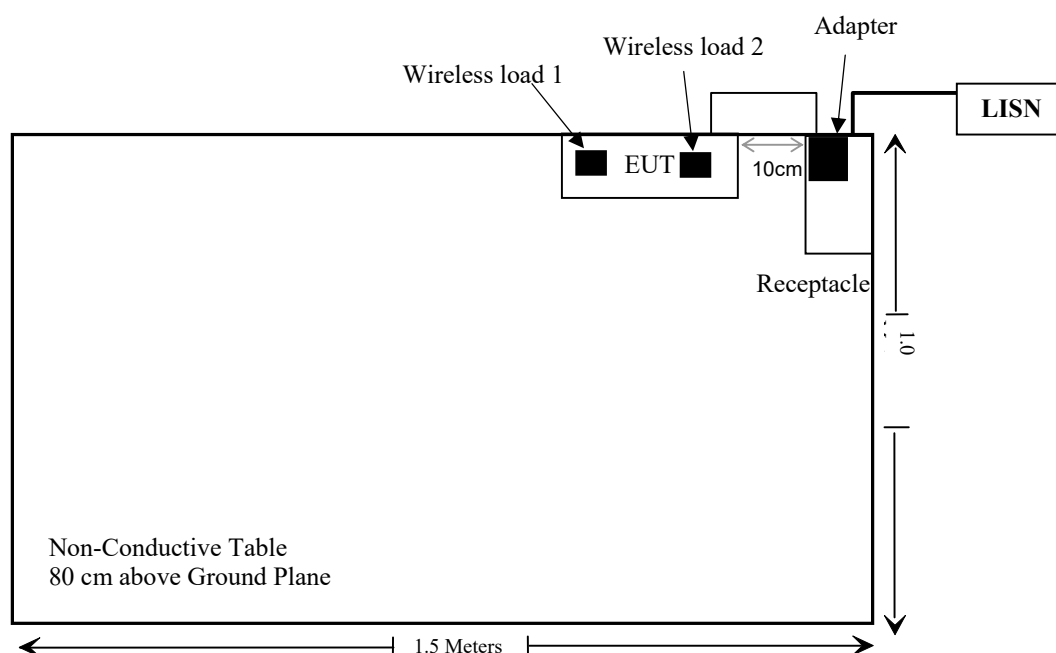

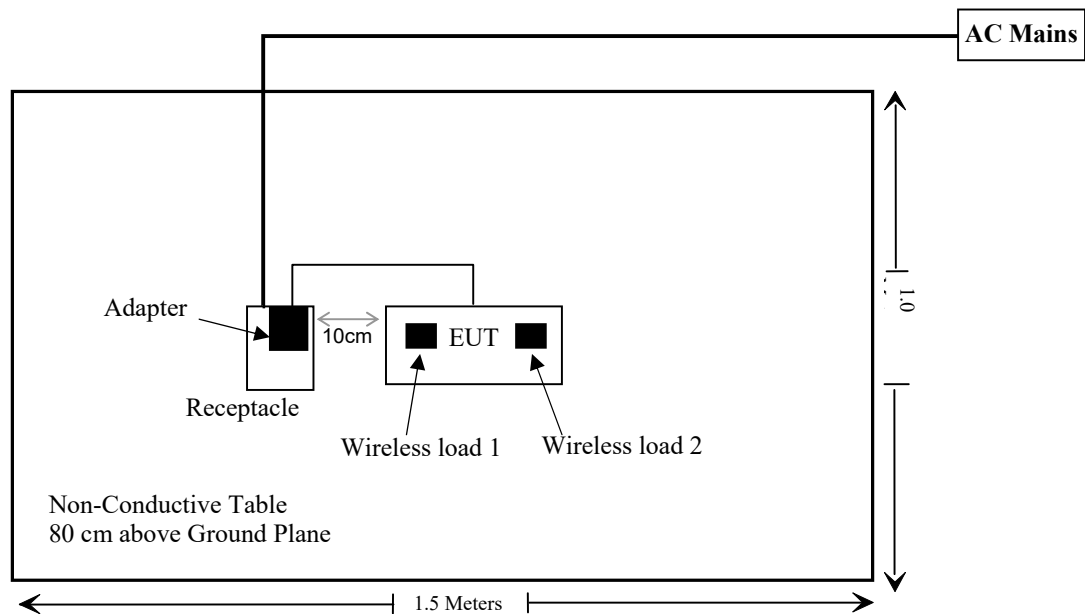

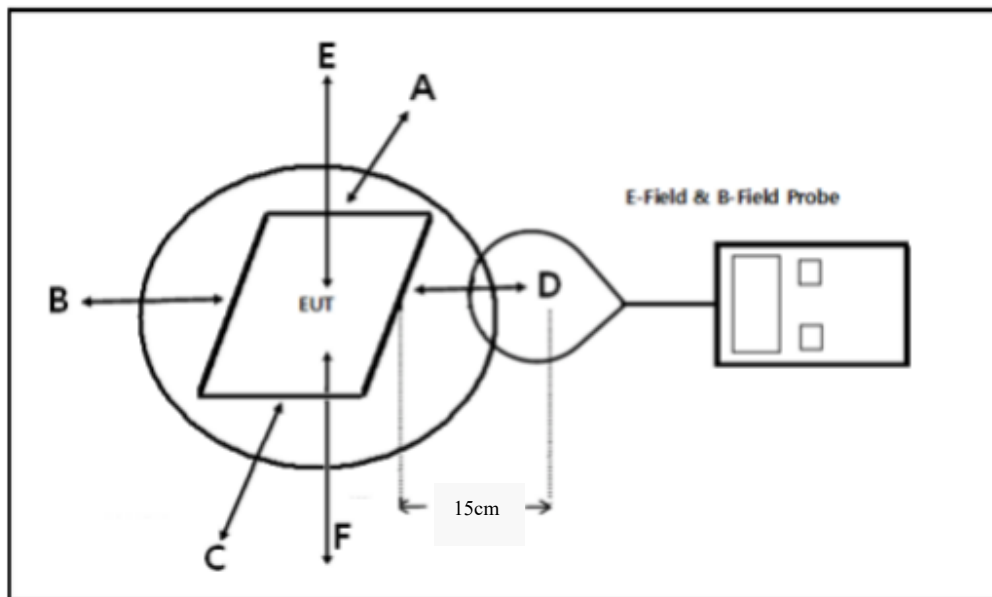

- c) For devices designed for typical desktop applications, such as wireless charging pads, RF exposure evaluation should be conducted assuming a user separation distance of 15 cm. E and H field strength measurements or numerical modeling may be used to demonstrate compliance. Measurements should be made from all sides and the top of the primary/client pair, with the 15 cm measured from the center of the probe(s) to the edge of the device. 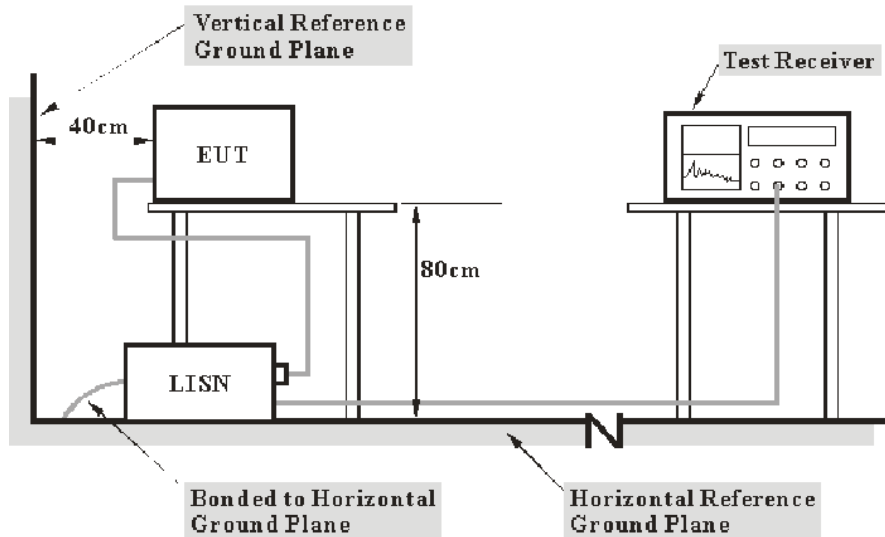

EMI Test Receiver Setup

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

During the conducted emission test, the EMI test receiver was set with the following configurations:

Test Procedure

During the conducted emission test, the adapter was connected to the outlet of the LISN.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All final data was recorded in the Quasi-peak and average detection mode.

Factor & Margin Calculation

The Factor is calculated by adding LISN VDF (Voltage Division Factor), Cable Loss. The basic equation is as follows:

$$\text{Factor} = \text{LISN VDF} + \text{Cable Loss}$$

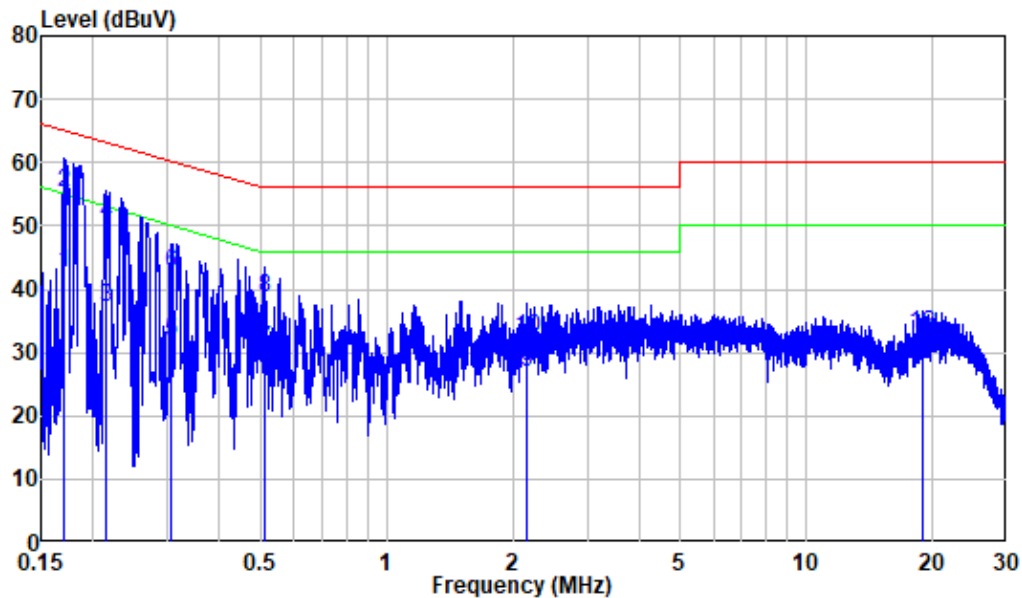

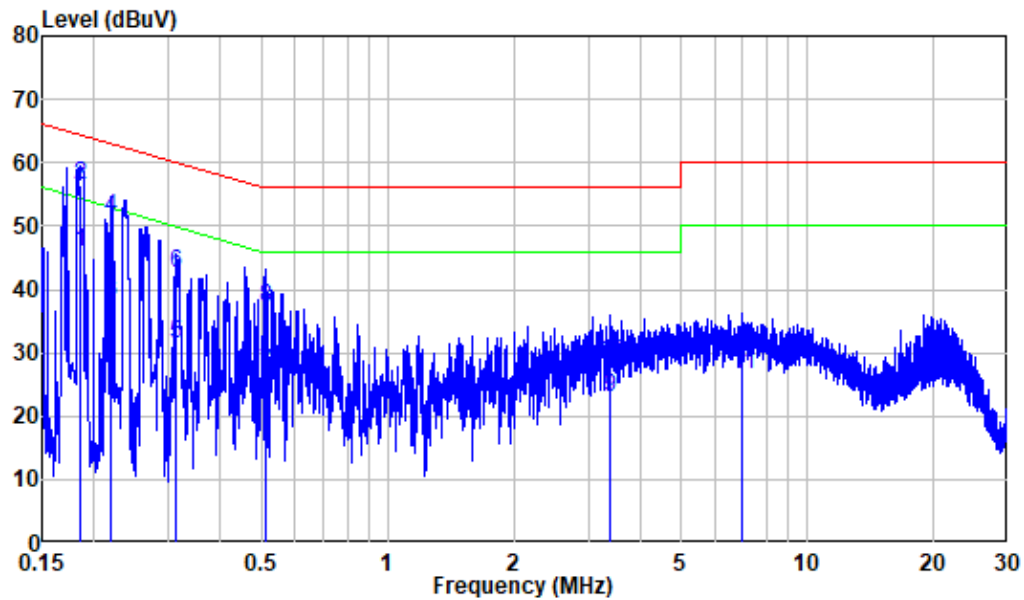

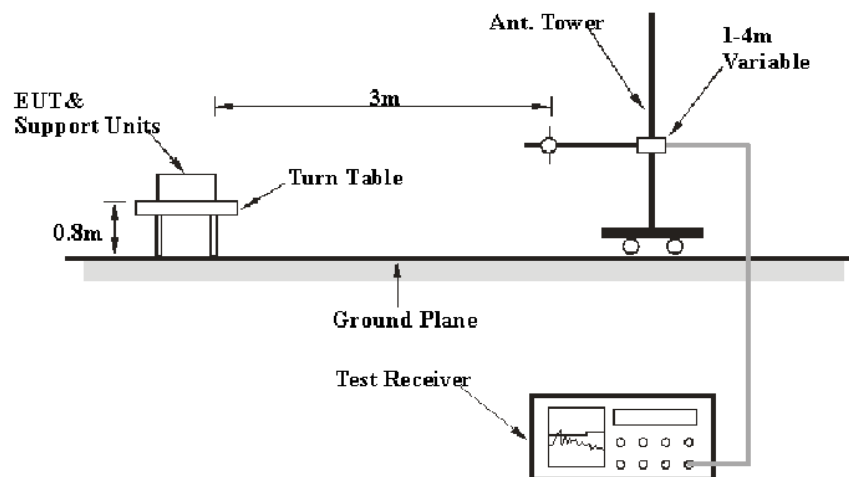

EUT Setup



The radiated emission tests were performed in the 3-meter chamber test site, using the setup accordance with the ANSI C63.10-2013. The specification used was the FCC Part Subpart C limits.

The spacing between the peripherals was 10 cm.

EMI Test Receiver Setup

During the radiated emission test, the EMI test Receiver was set with the following configurations:

If the maximized peak measured value complies with the limit, then it is unnecessary to perform an QP/Average measurement

Factor & Margin Calculation

The Factor is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain. The basic equation is as follows:
