

* Control Panel Instructions



- 1. ON/OFF : Power switch for turn on /off the unit
- 2. : Mode shift between BT/FM/AUX/MUSIC
- 3. Press the II for PAUSE/PLAY

Press & Hold **II** for auto search the FM frequency and

save the FM station in FM mode.

4. Press **VOL+NEXT I** to jump to the next song / FM Tuning,

Press & Hold **VOL+NEXT I** to increase the volume.

5. Short press **PREVIOUS I** to go back to the previous song / FM Tuning,

Press & Hold **PREVIOUS** I to decrease the volume.

(Remarks: also can turn the volume knob to adjust the volume)

- 6. **CHARGING** : plug in the USB cable for charging(adaptor not included)
- 7. AUX : 3.5mm aux-in jack
- 8. Equalizer for selection
- 9. TF CARD : Micro SD card slot
- 10. USB : Use 2.0 version Flash card in FAT 32 format

*Connect to BT device

1)Turn on the unit, it will enter into BT mode. Turn on the BT function on your mobile or other device and search for the model name "PS-02B". Then Pair the device.

2)Once device is paired, BT will automatically connect
