

### **Remote control us precautions**

- 1. Under normal circumstances, the remote control should be received in the remote window of about 6 meters, 30range .
- 2. Operate the remote control, remote control receiver window of the remote control at the amplifier, remote control and the amplifier should not be an obstacle
- 3. If the remote receiver is in the position of the remote control directly receive strong light may not be valid. In this case, place the subwoofer away in order
- **4.** Avoid mixing old and new batteries use ,regularly check whether the battery need be changed

### HOW TO USE BLUETOOTH

- 1. Press mode key and choose Bluetooth mode, Bluetooth indicator on front panel will flashing and speaker sound occurs short bleeping
