1.7. Description Of Test Modes

The EUT operates in the unlicensed ISM band at 902~928MHz. The following operating modes were applied for the related test items. And the new battery is used during the measurement.

The EUT received DC 4.5V power from 3*AAbattery which are new and full power. All test modes were tested, only the result of the worst case was recorded in the report.

The EUT is considered a portable unit; it was pre-tested on the positioned of each 3 axis. The worst case was found positioned on X-plane. Therefore only the test data of this X-plane was used for radiated emission measurement test.

Note: The EUT is designed to use DC 4.5V battery for power supply, so the conducted emission testing is not applicable.

2. TEST METHODOLOGY

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices

The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Shenzhen LCS Compliance Testing Laboratory Ltd.

2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

2.2. EUT Exercise

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209 and 15.249 under the FCC Rules Part 15 Subpart C.

2.3. General Test Procedures

2.3.1 Conducted Emissions(N/A)

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

2.3.2 Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2013

6. ANTENNA REQUIREMENT

6.1. Standard Applicable

According to §15.203, Antenna requirement.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

6.2. Antenna Connected Construction

6.2.1. Standard Applicable

According to §15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

6.2.2. Antenna Connector Construction

The directional gains of antenna used for transmitting is 2.0dBi, and the antenna is connect to PCB board and no consideration of replacement. Please see EUT photo for details.

1) Sequence of testing 9 kHz to 30 MHz

Setup:

--- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.

--- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.

--- If the EUT is a floor standing device, it is placed on the ground.

--- Auxiliary equipment and cables were positioned to simulate normal operation conditions.

--- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.

--- The measurement distance is 3 meter.

--- The EUT was set into operation.

Premeasurement:

--- The turntable rotates from 0 °to 315 °using 45 °steps.

--- The antenna height is 1.5 meter.

--- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

Final measurement:

--- Identified emissions during the premeasurement the software maximizes by rotating the turntable position (0 ° to 360 °) and by rotating the elevation axes (0 ° to 360 °).

--- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.

--- The antenna is polarized vertical and horizontal.

--- The antenna height changes from 1 to 3 meter.

--- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

--- Auxiliary equipment and cables were positioned to simulate normal operation conditions

--- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.

--- The measurement distance is 3 meter.

--- The EUT was set into operation.

Premeasurement:

- --- The turntable rotates from 0 ° to 315 ° using 45 ° steps.
- --- The antenna is polarized vertical and horizontal.
- --- The antenna height scan range is 1 meter to 2.5 meter.

--- At each turntable position and antenna polarization the analyzer sweeps with peak detection to find the maximum of all emissions.







8. BANDEDGES MEASUREMENT

8.1. Standard Applicable

Emissions radiated outside of the specified frequency bands, except for harmonics, shall be attenuated by at least 50 dB below the level of the fundamental or to the general radiated emission limits in Section 15.209, whichever is the lesser attenuation.


The EUT is placed on a turntable, which is 0.8m above the ground plane. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emission. Set the spectrum analyzer in the following setting in order to capture the lower and upper band-edges of the emission:

Peak: RBW=120KHz, RBW=300KHz / Sweep=AUTO Repeat the procedures until the peak versus polarization are measured.



9.3. Test Procedure

Use the following spectrum analyzer settings:

Span = approximately 2 to 3 times the 20 dB bandwidth, centered on a hopping channel

 $RBW \ge 1\%$ of the 20 dB bandwidth

 $VBW \ge RBW$

Sweep = auto

Detector function = peak

Trace = max hold

The EUT should be transmitting at its maximum data rate. Allow the trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission. Use the marker-delta function to measure 20 dB down one side of the emission.
