

#### 3.3 Test procedure and test setup

The measurement was applied in a semi-anechoic chamber for below 1 GHz and fully Anechoic Chamber for above 1GHz. While testing for spurious emission higher than 1GHz, if applied, the pre-amplifier would be equipped just at the output terminal of the antenna.

Tabletop devices shall be placed on a nonconducting platform with nominal top surface dimensions 1 m by 1.5 m. For emissions testing at or below 1 GHz, the table height shall be 80 cm above the reference ground plane. For emission measurements above 1 GHz, the table height shall be 1.5 m.

The turn table rotated 360 degrees to determine the position of the maximum emission level. The EUT was set 3 meters away from the receiving antenna which was mounted on an antenna mast. The antenna moved up and down between from 1 meter to 4 meters to find out the maximum emission level.


The radiation measurements are performed in X, Y, Z axis positioning for Transmitting mode, and found the Y axis positioning which it is worse case.

The radiated emission was measured using the Spectrum Analyzer with the resolutions bandwidth set as:

RBW = 300 Hz, VBW = 1 kHz (9 kHz~150 kHz); RBW = 10 kHz, VBW = 30 kHz (150 kHz~30MHz);

RBW = 100 kHz, VBW = 300 kHz ( $30 \text{MHz} \sim 1 \text{GHz}$  for PK)

RBW = 1MHz, VBW = 3MHz (>1GHz for PK);

#### Remark:

- 1. Correct Factor = Antenna Factor + Cable Loss (-Amplifier, is employed);
- 2. Corrected Reading = Original Receiver Reading + Correct Factor;
- 3. Margin = Limit Corrected Reading;
- 4. If the PK Corrected reading is lower than AV limit, the AV test can be elided;
- 5. AV factor =  $20*log(duty\ cycle) = 20*log(1.095/5.955) = -14.71dB$ , AV value = PK value + AV factor.

#### Example:

Assuming Antenna Factor = 30.20dB/m, Cable Loss = 2.00dB, Gain of Preamplifier = 32.00dB, Original Receiver Reading = 10dBuV, Then Correct Factor = 20.20 + 2.00 = 22.00 = 0.20dB/m

Then Correct Factor = 30.20 + 2.00 - 32.00 = 0.20dB/m,

Corrected Reading = 10dBuV + 0.20dB/m = 10.20dBuV/m,

Assuming limit = 54dBuV/m, Corrected Reading = 10.20dBuV/m,

Then Margin = 54 - 10.20 = 43.80dB.




# 4 Assigned bandwidth (20dB bandwidth)

Intentional radiators must be designed to ensure that the 20 dB bandwidth of the emission is contained within the allocated frequency band.



#### 4.3 Test procedure and test setup

The 20dB Bandwidth per FCC § 15.215(c) is measured using the Spectrum Analyzer. Set Span = 2 to 3 times the 20 dB bandwidth, RBW = approximately 1% of the 20 dB bandwidth, VBW>RBW, Sweep = auto, Detector = peak, Trace = max hold. The test was performed at 3 channels (lowest, middle and highest channel).










#### 5.3 Test procedure and test set up

Measured levels of ac power-line conducted emission shall be the emission voltages from the voltage probe, where permitted, or across the 50  $\Omega$  LISN port (to which the EUT is connected), where permitted, terminated into a 50  $\Omega$  measuring instrument. All emission voltage and current measurements shall be made on each current-carrying conductor at the plug end of the EUT power cord by the use of mating plugs and receptacles on the LISN, if used. Equipment shall be tested with power cords that are normally supplied or recommended by the manufacturer and that have electrical and shielding characteristics that are the same as those cords normally supplied or recommended by the manufacturer. For those measurements using a LISN, the 50  $\Omega$  measuring port is terminated by a measuring instrument having 50  $\Omega$  input impedance. All other ports are terminated in 50  $\Omega$  loads.

Tabletop devices shall be placed on a platform of nominal size 1 m by 1.5 m, raised 80 cm above the reference ground plane. The vertical conducting plane or wall of an RF-shielded (screened) room shall be located 40 cm to the rear of the EUT. Floor-standing devices shall be placed either directly on the reference ground-plane or on insulating material as described in ANSI C63.4. All other surfaces of tabletop or floor-standing EUTs shall be at least 80 cm from any other grounded conducting surface, including the case or cases of one or more LISNs.






