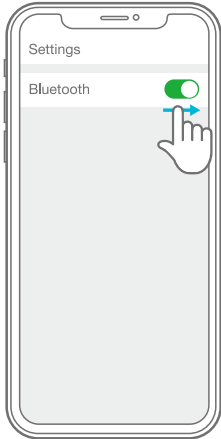


BLUETOOTH PAIRING

1

Turn on Bluetooth in your device settings.

Press and hold button for **8 seconds**. Release. Lights will flash blue/red.



3

Select "JLab Studio Pro" in your device settings to connect.



BUTTON FUNCTIONS

VOLUME UP:
Click once.

TRACK FORWARD:
Click and hold 2+ seconds.

VOLUME DOWN:
Click once.

TRACK BACKWARD:
Click and hold 2+ seconds.

POWER ON/OFF:
Click and hold 2+ seconds.

**PLAY/PAUSE/ANSWER/
HANG UP CALLS:**
Click once.

REJECT INCOMING CALL:
Click and hold 1 second.

**ACTIVATE SIRI (iOS) OR
"OK GOOGLE" (ANDROID):**
Click twice.

Press both buttons simultaneously (Studio Pro will cycle 3 EQ settings)

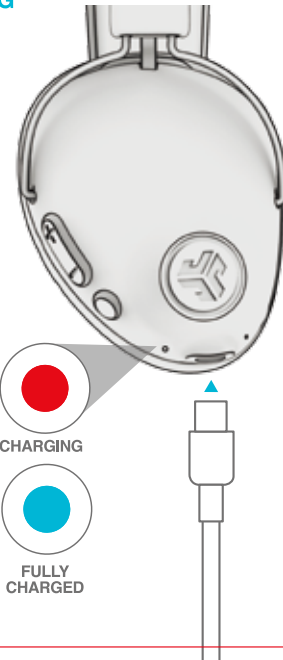
