





FIRST TIME SETUP: BLUETOOTH PAIRING

- Turn on the Bluetooth in your device settings. 
- Press and hold headphone Power Button for **10 seconds**. Release. Light will **blink red and blue** near the foam ear pad to indicate pairing mode. 
- Select "JLab Rewind" in your device settings to connect. Light will **slow blink blue** when Bluetooth is paired.




CHARGING
