4 Test Standards and Limits

According to §1.1310 Radiofrequency radiation exposure limits:

The limit for general population/uncontrolled exposures

For **915MHz** device, the limit of worse case is 0.61mW/cm²

5.1 Maximum transmit power

The Power Data is based on the RF Test Report SHEM160600398301.

5.2 MPE Calculation

According to the formula $S = \frac{PG}{4R^2\pi}$, we can calculate S which is MPE.

Note:

- 1) P (Watts) = Power Input to antenna = $10^{\frac{dBm}{10}} / 1000$
- 2) G (Antenna gain in numeric) = $10^{(Antenna\ gain\ in\ dBi / 10)}$
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm² for FCC

The Max Conducted Peak Output Power is 100mW in highest channel;

The best case gain of the antenna is 5Bi. logarithmic terms convert to numeric result is nearly 3.16

$$\text{So, } S = \frac{PG}{4R^2\pi} = 0.0628\text{mW/cm}^2 < 0.61\text{mW/cm}^2$$
