

Magic II dome



More comfortable to wear and more effectively reduce the whistling sound. Round top dome (Power upgrade)



Effectively reduce the feedback/ whistling sound.

Notice:

The quantity may differ from different configuration.

How to assemble and wear the devices

4. How to assemble



Step 1 Choose a dome.

Note: Please tear off the insulation sticker and start using.

The devices come with pre-assembled domes. You can replace one to fit your special needs.



Step 2 Mount onto the connector firmly.


5. How to wear




Step 1 Hold the device.



Step 2 Insert into ear canal.



Step 3 Gently tug on your ear lobe.




Step 4 Push the device into best fit position.

TIPS: Correct position: Microphone port facing the auricle. Do not touch the microphone port during wearing to prevent howling. Whistling may happen if not placed into place, keep patience and try again.

6. How to charge the devices




Step 1 Please tear off the insulation sticker before charging.




Step 2 Place the devices into charging case



Plug the small end of cable into charging port of charging case.



Plug the big end of cable into adaptor.



Step 5 Connect with power.

The case is being charged. The case is fully charged. The case failure, please clean the charging contact of both devices and charging case.

The devices are being charged.


The devices are fully charged.

- 1) Always put your hearing device into the charging case without a dome attached.
- 2) Always put your hearing device into the charging case when you do not use them.
- 3) We strongly recommend you fully charge the devices when you first time received.
- 4) After the charging cycle, the case will start drying process for 3 hours. The drying process will stop once devices are removed. And drying time will be recalculated when devices are replaced in again.

How to charge the devices

7. Without external power connection



Notice:

The devices will emit 5 beeps every 5 minutes when they are in low battery.

8. ON-OFF switch

To turn on: Just take the devices out of the charging case, they will be automatically turned on. To turn off: Place the devices into corresponding port of the charging case.



Notice:

The devices are equipped with power-on delay function. It needs about 8 seconds to get started. Once properly inserted, the whistling will stop.

How to use the devices

9. Memory Switch and Volume Control

There are totally 4 listening programs and 6 level sound under each program. Follow the guide below to change the program and volume according to your needs.

Program	Program 1	Normal	Long press the touch button for 2-3 seconds.	1 beep sound
	Program 2	Restaurant		2 beeps sound
	Program 3	Traffic		3 beeps sound
	Program 4	Outdoor		4 beeps sound
Volume	From 1 to 6		Short press the touch button	1 beep sound indicator for each change; 3 beeps when reach the highest volume level

10. Troubleshooting

No/ low sound amplification

Low battery	Recharge the device			
Built-up wax in the dome	Clean the dome or replace the old dome			
Excessive ear wax	Consult your physician			
Improper dome insertion	Re-insert the dome			
Hearing device damaged	Contact your provider			
Hearing change	Contact your hearing care professional			
Whistling or feedback				
Dome is wrong size or damaged	Replace with new or better fitting dome			
Improper dome insertion	Re-insert the dome into your ear so that it is flush with the wall of the ear canal

12. Care (You should inspect and clean your hearing devices everyday)

1.Clean the exterior & charging contact

To clean, gently wipe the surface with a soft, dry cloth.

Use the brush to clean the receiver port.

Do keep the charging contact and charging port clean and dry. It is recommended to use dry box or electronic dry box for drying every day to reduce moisture and wax buildup.


2.Clean the dome


Use the brush to clean the dome.

It's recommended that replace with new dome every 2-3 months.



The hearing instruments and charger must be clean and dry in any case.





How to use the App

Step 1: Wear on your device and turn on it.

Step 2: Enable the Bluetooth on your phone.

Step 3: Search the device.

Step 4: Tap to connect your device with your phone.

Step 5: You can adjust the volume, switch listening program

and many customized adjustment through the APP.
