

# XEFO Universal Remote Key User Manual



## Overview:

XEFO Universal Remote Key is suitable for vehicle which contains the Xhorse receiver.

Note: The operating temperature of the product is -20~50°C.

## Button description:



Item	Description
1	Switch button for mechanical key
2	Lock button
3	Trunk button
4	Unlock button
5	Panic button

## Change battery:

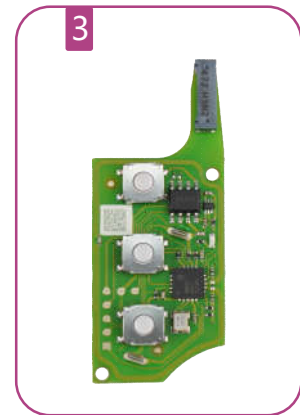
First use or when the battery runs out need to change new battery, following steps:



Break open the back side plastic cover to open the remote



Take the battery out and replace new one



Install the key same as before

Note: The battery type is 2032 with 3V, ensure the positive and negative of battery is correct.

## Pairing method:

Pairing with vehicle: Referring to the corresponding vehicle models to match.
