#### **GENERAL INFORMATION**

#### **Product Description for Equipment under Test (EUT)**

The *PLAY TEK LIMITED*'s product, model number: 0820 (FCC ID: 2AI5408202120160718) or the "EUT" in this report was a *receiver of R/C CAR*, which was measured approximately: 150 mm (L) x 80 mm (W) x 70 mm (H), rated with input voltage: DC 1.5V\*3 AA battery. The highest operating frequency is 49.86 MHz.

Note: For the product, series model 0821, 0822, 0823, 0824, 0825 and 0820 are identical schematics, the difference among them are the model and pattern color, model 0820 was selected for fully testing, the detailed differences between them were explained and stated in the product similarity declaration letter by the applicant.

\* All measurement and test data in this report was gathered from production sample serial number: 20160715. (Assigned by BACL, Shenzhen). The EUT supplied by the applicant was received on 2016-07-15.

#### Objective

This test report is prepared on behalf of *PLAY TEK LIMITED* in accordance with Part 2-Subpart J, Part 15-Subparts A and B of the Federal Communication Commissions rules.

The objective of the manufacturer is to determine the compliance of the EUT with FCC Part 15 B.

#### **Test Facility**

The test site used by Bay Area Compliance Laboratories Corp. (Shenzhen) to collect test data is located on the 6/F, the 3rd Phase of WanLi Industrial Building, ShiHua Road, FuTian Free Trade Zone Shenzhen, Guangdong, China.

Test site at Bay Area Compliance Laboratories Corp. (Shenzhen) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on October 31, 2013. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2014.

The Federal Communications Commission has the reports on file and is listed under FCC Registration No.: 382179. The test site has been approved by the FCC for public use and is listed in the FCC Public Access Link (PAL) database.

#### **Measurement Uncertainty**


All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR 16-4-2:2011, the expended combined standard uncertainty of radiation emissions at Bay Area Compliance Laboratories Corp. (Shenzhen) is 5.81 dB for 30MHz-1GHz and 4.88 dB for above 1GHz, 1.95dB for conducted measurement at antenna port. And the uncertainty will not be taken into consideration for the test data recorded in the report

#### **EUT Setup**

#### **Below 1GHz:**



The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2014. The specification used was the FCC Part 15.109 Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

#### **EMI Test Receiver Setup**

The system was investigated from 30 MHz to 1 GHz.

During the radiated emission test, the EMI test receiver was set with the following configurations:

#### **Test Procedure**

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz.

\* **Statement of Traceability:** Bay Area Compliance Laboratories Corp. (Shenzhen) attests that all calibrations have been performed in accordance to requirements that traceable to National Primary Standards and International System of Units (SI).

#### **Corrected Amplitude & Margin Calculation**

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

The "**Margin**" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7 dB means the emission is 7 dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude

#### **Test Results Summary**

According to the data in the following table, the EUT complied with the <u>FCC 15.109 Class B</u>, the worst margin reading as below:

#### 10.81 dB at 514.843250 MHz in the Vertical polarization mode.

Refer to CISPR16-4-2:2011 and CISPR 16-4-1:2009, the measured level is in compliance with the limit if

$$L_{\rm m} + U_{(L{\rm m})} \leq L_{\rm lim} + U_{\rm cispr}$$

In BACL,  $U_{(Lm)}$  is less than  $U_{cispr}$ , if  $L_m$  is less than  $L_{lim}$ , it implies that the EUT complies with the limit.


