## 3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.10: 2013 and FCC CFR 47 Part 15.207, 15.209, 15.247 and DA00-705.

#### 3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

#### 3.3 GENERAL TEST PROCEDURES

#### **Conducted Emissions**

According to the requirements in Section 13.1.4.1 of ANSI C63.10 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

#### **Radiated Emissions**

The EUT is placed on a turn table, which is 1.5 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.10.

#### 3.5 DESCRIPTION OF TEST MODES

The EUT (model: furbo1) had been tested under operating condition.

After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz and power line conducted emissions below 30MHz, which worst case was in normal link mode only.

The USB slot could be in vertical and horizontal manner. After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz, which worst case was in normal link mode only.

After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz and power line conducted emissions below 30MHz, which worst case was in normal link mode with USB charging cable. The USB port has no data transferring function, therefore no data transferring was done through the USB cable during the charging stage. This is the worst case scenario, therefore USB charging cable is used during all the test.

The field strength of spurious emission was measured in the following position: EUT stand-up position (Z axis), lie-down position (X, Y axis). The worst emission was found in stand-up position (Z axis) and the worst case was recorded.






