
Remote Instructions

Here are the commands that can be used with the flex light remote:



Troubleshooting remote connection

If for some reason the remote does not connect to the strip's controller, please re-pair it following these steps:

- 1. Turn off the power for about 5 seconds by switching to "OFF" on the battery box.
- 2. Check the remote battery if it is installed properly.
- 3. Check the battery box batteries if they are installed properly.
- 4. Switch the battery box toggle to "ON" and check to see if it is working.
