MARES SPA must provide adequate means of software version verification to ensure that no un-authorized software updates can be used by the end user. MARES SPA agrees to indemnify, defend and hold harmless Broadcom and its affiliates from and against any liabilities, actions, losses, judgments, payments made in settlement, costs, suits, proceedings, demands or claims from third parties incurred by Broadcom or any affiliate of Broadcom resulting from Mares Spa failure to comply with any conditions set forth in Exhibit 2 or any applicable laws.

This Letter of Authorization is valid only for the following Broadcom product in countries listed in Exhibit 1.

## **Conditions Applicable to Letter of Authorization**

- A. MARES SPA must ensure that its product (the "MARES SPA Product") is electrically identical to Broadcom's reference designs. MARES SPA acknowledges that any modifications to Broadcom's reference designs may invalidate regulatory approvals in relation to the MARES SPA Product, or may necessitate notifications to the relevant regulatory authorities.
- B. MARES SPA is responsible for obtaining regulatory approvals in the United States and in Canada. Broadcom will cooperate with MARES SPA in any submission by MARES SPA to the FCC pursuant to Section 2.933(a) of the FCC's rules, 47 C.F.R. § 2.933(a), or analogous procedures of Industry Canada.
- C. MARES SPA is responsible for regression testing to accommodate changes to Broadcom's reference designs, new antennas, and portable RF exposure safety testing/approvals.
- D. MARES SPA is responsible for certification updates to include new manufacturers, Taiwan NCC (National Communications Commission) authorization, and approvals in additional countries.
- E. Appropriate labels must be affixed to the MARES SPA Product that comply with applicable regulations in all respects.
- H. A user's manual or instruction manual must be included with the MARES SPA product that contains the text as required by applicable law.
